



Message from the Acting Secretary



The Honor Awards Ceremony provides a chance for all of us at USDA to pause for a moment and look both backward and forward—to reflect on what we have accomplished in the past year and what we hope to achieve in the future. Today, we gather to recognize those who have gone above and beyond the call of duty to provide truly exceptional service. Their efforts have produced impressive results that have benefited our department and the people we serve. I hope you'll join me in thanking and congratulating them for their accomplishments.
