BROWNFIELDS ASSESSMENT, CLEANUP, AND REVOLVING LOANS

Description: Provides funds for assessment and clean up of old industrial and commercial sites for remediation under section 104(k) of CERCLA.

Funding Mechanism: Competitive grants and loans.

Eligible Entities: Local Government Non-Profit Organizations State Government **Responsibility for Implementation:** Federal State

CLEAN WATER ACT PROGRAM - Water Quality Planning

Description: Provides funding to supports water quality planning at the state and local level.

CLEAN WATER STATE REVOLVING FUND

Description: Provides funding for low-interest rate loans to municipalities for wastewater construction projects.

COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) - State and Small Cities Program

Description: Provides continuing community development block grant funding for community and economic development projects, including housing.

DRINKING WATER STATE REVOLVING FUND

Funding Mechanism: Funding distributed through low-interest loans and grants for water utility infrastructure. A portion of the funds are set aside for tribal grants to be administered by the EPA.

FOREST SERVICE WILDLAND FIRE MANAGEMENT - State and Private Forestry

Description: Provides funds for state fire assistance, hazardous fuels projects, volunteer fire assistance, cooperative forest health projects, city forest enhancements and wood-to-energy grants on state and private lands.

LEAKING UNDERGROUND STORAGE TANKS - DNR

Description: Provides funding for clean-up activities related to high risk leaking underground storage tanks. Funds can also be used for assessments, per EPA Reg. 5.

Funding Mechanism: Formula allocation by EPA.

SUPERFUND - Superfund Remedial Program

Description: Provides funding and coordination for cleanup of hazardous waste sites where the responsible party cannot be found or is unable to pay

Funding Mechanism: Funding for projects would be provided through state-federal cooperative agreement.

TRIBAL WATER PROJECTS - Water Intake and Treatment Facilities

Description: Provides funding for Water Intake and Treatment Facilities

USDA NATURAL RESOURCES CONSERVATION SERVICE - Watershed and Flood Prevention

Description: Provides funding for Watershed and Flood Prevention Operations, including expenses to purchase and restore floodplain easements.

Funding Mechanism: Funds allocated through a formula. Purchase of floodplain easements may not exceed \$30 million per state.

USDA NATURAL RESOURCES CONSERVATION SERVICE - Watershed Rehabilitation Program

Description: Provides funding for the Watershed Rehabilitation Program. The program provides cost sharing for rehabilitating watershed dams that were funded under the Watershed Protection and Flood Prevention Program.

Funding Mechanism: USDA allocates funds to states following a national ranking of submitted projects. Priority will be given to projects that are ready to be constructed and those that have the greatest risk of potential loss of life if the dam were to fail.
