The primary goal of this program is to improve student achievement through the use of technology in elementary and secondary schools. Additional goals include helping all students become technologically literate by the end of the eighth grade and, through the integration of technology with both teacher training and curriculum development, establishing research-based instructional methods that can be widely implemented.

Program Title: **State Fiscal Stabilization Fund**

Short Description: Funds must be distributed 81.8% for Education and 18.2% funds for public safety and general government, which may include education.

Appropriation nationwide: \$53,600,000,000

Estimated New Hampshire Funds: \$200,787,230

Granting Agency: US Department of Education

Managing Agency: Governor's Office (Department of Education)

Status: Awaiting federal announcement of application process.

Award Criteria: The amount appropriated to the State is based on:

- 61% on basis of relative population of individuals aged 5 through 24;
- 39% on basis of relative total population;
- State must maintain effort supporting education K-12 and public higher education at SFY06 level.

Use by: Uncommitted funds as of two years following receipt must be returned to the Secretary of Education.

Status: Prior grant awardees seeking competitive grants from the 60% allocated to competitive grants should register/re-register now. Follow NEA web site instructions.

Award Criteria:

- - 40% of funds distributed to state and regional arts agencies in a manner similar to current practice
 - 60% of funds for competitively selected arts projects and activities – restricted to grant awardees in past four years
 - Matching requirements waived

Program Title: Education for the Disadvantaged – Special Education – Infants and Toddlers with disabilities (IDEA Part C – Grants for Infants and Families)

- Award Criteria: NH anticipates that the additional grant amount may include the same restrictions as apply to the annual Part C Grant Award.
- To comply with the likely Maintenance of Effort requirements, BDS would propose that any additional Part C funds be used to fund:
 - Intensive Autism Services to 60 children at an estimated cost of \$1,080,000. This would save \$180,000 in General Funds(GF) requested in the Maintenance budget;
 - Early Intervention services to 169 children in FY 2010 saving \$160,635 in GFs requested in the Maintenance budget;
 - A temporary inflation rate increase of \$343,394. which would save \$183,209 in GFs requested in the FY 2010 Maintenance Budget request;
 - Data collection enhancement with improved IT capacity at an estimated cost of \$200,000.
 - Child find capacity enhancement at an estimated cost of \$50,000;
 - Personnel development at an estimated cost of \$100,000; and
