SUBJECT: Fiscal Year (FY) 2009 Program Guidance and Application Kits - Supplemental

Information

The information provided in this information bulletin is a supplement to Information Bulletin No. 295. The Grant Programs Directorate (GPD) and National Preparedness Directorate (NPD) within the Federal Emergency Management Agency (FEMA) recently announced the availability of the FY 2009 Program Guidance and Application Kits. This bulletin provides a further level of detail on each of the Department's 14 FY 2009 preparedness grant programs. These kits should be available online at http://www.fema.gov/grants later today.

A summary of eligible applicants and deadlines is included in Appendix A. Specific allocations for programs marked with an asterisk (*) are included in Appendix B.

FY 2009 Homeland Security Grant Program (HSGP)*

The HSGP is one tool among a comprehensive set of measures authorized by Congress and implemented by the Administration to help strengthen the Nation against risks associated with potential terrorist attacks.

State Homeland Security Program (SHSP). The SHSP provides \$861,265,000 to build capabilities at the State and local levels and to implement the goals and objectives included in State Homeland Security Strategies and initiatives in the State Preparedness Report.

Urban Areas Security Initiative (UASI). The UASI program dedicates \$798,631,250 to select areas to enhance regional preparedness in major metropolitan areas. The UASI program directly supports the National Priority on expanding regional collaboration in the National Preparedness Guidelines and is intended to assist participating jurisdictions in developing integrated regional systems for prevention, protection, response, and recovery.

Metropolitan Medical Response System (MMRS). The MMRS provides \$39,831,404 to support the integration of emergency management, health, and medical systems into a coordinated response to mass casualty incidents caused by any hazard.

Citizen Corps Program (CCP). The CCP provides \$14,572,500 to bring community and government leaders together to coordinate the involvement of community members and organizations in emergency preparedness, planning, mitigation, response, and recovery.

FY 2009 State Homeland Security Program Tribal (SHSP Tribal)

The FY 2009 SHSP Tribal provides \$1,660,000 to directly eligible tribes to help strengthen the Nation against risks associated with potential terrorist attacks. Pursuant to the 9/11 Act, "a directly eligible tribe applying for a grant under section 2004 [SHSP] shall designate an individual to serve as a tribal liaison with [DHS] and other Federal, State, local, and regional government officials concerning preventing, preparing for, protecting against, and responding to acts of terrorism."

FY 2009 Urban Areas Security Initiative (UASI) Nonprofit Security Grant Program (NSGP)

The FY 2009 UASI NSGP provides \$15,000,000 for target hardening activities to nonprofit organizations that are at high risk of terrorist attack and are located within one of the FY 2009 UASI-eligible Urban Areas.

FY 2009 Operation Stonegarden (OPSG)

The FY 2009 OPSG provides \$60,000,000 to enhance law enforcement preparedness and operational readiness to local units of government at the county level and Federally-recognized tribal governments in the States bordering Canada (including Alaska), southern States bordering Mexico, and States and territories with International water borders.

FY 2009 Transit Security Grant Program (TSGP)*

The TSGP provides \$388,600,000 to the Nation's high-threat urban areas for enhancement of security measures at critical transit infrastructure including bus, ferry and rail systems. From this amount the following components are funded: the **Freight Rail Security Grant Program** (\$15,000,000) and the **Intercity Passenger Rail** (**Amtrak**) (\$25,000,000). Certain ferry systems are eligible to participate in the FY 2009 TSGP and receive funds under the Tier I cooperative agreement process. However, any ferry system electing to participate and receive funds under the FY 2009 TSGP cannot participate in the FY 2009 Port Security Grant Program (PSGP) (and will not be considered for funding under the FY 2009 PSGP). Likewise, any ferry system that participates in PSGP cannot be considered for funding under TSGP.

In FY 2009, the FRSGP will fund security training for frontline employees, the completion of vulnerability assessments, the development of security plans within the freight rail industry and GPS tracking systems for railroad cars transporting toxic inhalation hazardous materials (TIH).

The purpose of the FY 2009 Intercity Passenger Rail (IPR) is to create a sustainable, risk-based effort to protect critical surface transportation infrastructure and the traveling public from acts of terrorism, major disasters, and other emergencies within the Amtrak rail system.

FY 2009 Port Security Grant Program (PSGP)*

The PSGP provides \$388,600,000 for port security grants, including \$5,000,000 to high capacity ferry systems. PSGP funds are primarily intended to assist ports in enhancing maritime domain awareness, enhancing risk management capabilities to prevent, detect, respond to and recover from attacks involving improvised explosive devices (IEDs), weapons of mass destruction (WMD), and other non-conventional weapons, as well as training and exercises and Transportation Worker Identification Credential (TWIC) implementation.

FY 2009 Intercity Bus Security Grant Program (IBSGP)

The IBSGP provides \$11,658,000 to create a sustainable program for the protection of intercity bus systems and the traveling public from terrorism. The program seeks to assist operators of fixed-route intercity and charter bus services in obtaining the resources required to support security measures such as enhanced planning, facility security upgrades, and vehicle and driver protection.

FY 2009 Trucking Security Program (TSP)

The TSP provides \$7,772,000 to eligible applicants to implement security improvement measures and policies deemed valuable by DHS as indicated in the Security Action Items publication of June 26, 2008. These items are primarily focused on the purchase and installation or enhancement of equipment and systems related to tractor and trailer tracking systems. Additionally, the TSP will provide funding to develop a system for DHS to monitor, collect, and analyze tracking information; and develop plans to improve the effectiveness of transportation and distribution of supplies and commodities during catastrophic events.

FY 2009 Buffer Zone Protection Program (BZPP)*

The BZPP provides \$48,575,000 to funding to increase the preparedness capabilities of jurisdictions responsible for the safety and security of communities surrounding high-priority pre-designated Tier 1 and Tier 2 critical infrastructure and key resource (CIKR) assets, including chemical facilities, financial institutions, nuclear power plants, dams, and other high-risk/high-consequence facilities, through allowable planning and equipment acquisition.

FY 2009 Emergency Management Performance Grants (EMPG)*

Emergency management is a vital part of the Department of Homeland Security's preparedness mission and EMPG directly supports the Nation's emergency management community. The FY 2009 EMPG Program provides \$306,022,500 to assist State and local governments in enhancing and sustaining all-hazards emergency management capabilities.

FY 2009 Interoperable Emergency Communications Grant Program (IECGP)*

The FY 2009 IECGP provides \$48,575,000 to improve local, tribal, regional, statewide, and national interoperable emergency communications, including communications in collective response to natural disasters, acts of terrorism, and other man-made disasters. The funding will enable States, Territories, local units of government, and tribal communities to implement their Statewide Communication Interoperability Plans (SCIP) and align to the National Emergency Communications Plan (NECP) to further enhance interoperability.

FY 2009 Regional Catastrophic Preparedness Grant Program (RCPGP)*

The FY 2009 RCPGP provides \$34,002,500 to enhance catastrophic incident preparedness in selected high-risk, high-consequence urban areas. RCPGP is intended to support coordination of regional all-hazard planning for catastrophic events, including the development of integrated planning communities, plans, protocols, and procedures to manage a catastrophic event.
