## **Notes:**

- \* A principal objective of the Antarctic Marine Living Resources Convention Act and implementing regulations is to prevent the unauthorized harvest of Antarctic Marine Living Resources (AMLR), and foreign and interstate commerce in illegally harvested AMLRs. To facilitate this objective, the following sanctions are appropriate in addition to any monetary penalties set forth above:
  - For violations involving AMLRs that likely were harvested unlawfully, forfeiture of all unlawfully harvested AMLRs.
  - For violations involving AMLRs in which it cannot be reasonably determined whether such resources were harvested lawfully, denial of import into the United States of such AMLRs.
