SUBJECT: 2007 Annual Report on Deposits and Savings Accounts by Home and Branch Offices

Branch Office Survey (BOS) Report

This letter provides instruction for the 2007 BOS Report for deposit information as of June 30, 2007. Please ensure that you include escrows with deposits for each reported office/branch. Do not aggregate escrows into one branch. Upon completion of your report, review for accuracy, run the edit checks, and submit the report electronically using the Electronic Filing System (EFS). You can transmit your BOS report any time after you have submitted your June Thrift Financial Report (TFR). The filing deadline for the BOS Report is Monday, August 27, 2007.

- You must install the OTS Electronic Filing System (EFS) Version 6.1 to prepare and transmit your June TFR and BOS reports.
- Trust-Only entities are not required to file a BOS report.
- You must download your 2007 BOS shell report from the OTS system to ensure you have accurate data. If
  you are a new entity, enter 2007 BOS data directly onto the report.
- The 2007 Branch Office Survey allows thrifts to import deposits from external file sources. The OTS strongly encourages institutions with large numbers of branches to take advantage of this feature. - Your Total Branch Office Deposits must equal the total of your TFR Deposits reported on SC710 and Escrows reported on SC712.
- You will <u>not</u> be able to transmit your BOS data with any edit check failures.
- You can transmit amendments to your 2007 BOS data via the EFS filing software through September 30,
