Domestic Volunteerism and Career Development By: Tamara Webb, RVS Program Specialist



PCVs know the sense of personal fulfillment that stems from volunteerism. It is also important to realize the opportunities for careerbuilding through such work. Service can help individuals keep abreast of pressing issues, maintain or develop relevant technical skills, explore organizations and industries, and build networks, to name a few critical job readiness activities.

While both Peace Corps service and domestic volunteer service offer opportunities for career development, there are a few unique differences between the two that merit consideration when exploring these possibly career enabling domestic volunteer opportunities.

Differences between **Peace Corps Service and Domestic Volunteerism**

First, the obvious difference is the *location* of the service. One is abroad and one is not. Basic, yes, but relevant to this discussion - as explained below. Second, Peace Corps, when compared to other types of programs, both domestically and internationally, provides an incredible amount of support for individuals who join. There are health benefits, on-site training teams, experienced project directors, safety and security officers, and federal oversight - a biggie. It is much more difficult for non-governmental, volunteer programs to build such formal and comprehensive support systems. The absence of this support system could very well reduce the quality of the experience. Conversely, the opportunity to develop your own resource and support system might in fact complete the experience.

Next, volunteer placement is a benefit of Peace Corps' structure. Though prospective PCVs are able to state preferences for service sectors and sites. there is a dedicated office to finalize the assignments. The host country is chosen for you, the host/sponsoring organization is vetted, and the volunteer team is created by the Agency. This is not typically the norm for more dispersed, very often smaller, independentlyoperated domestic volunteer programs. As above, what kind of factor that might be needs to be weighed into deciding upon a suitable volunteer assignment.

differences described above are somewhat generalized; however, the proportion of domestic volunteer programs with which the differences hold true is high. What does all of this mean to careerbuilding and development? Just this: understand the differences mentioned above as part of your due diligence in terms of your career aspirations, for it will be you - the individual volunteer rather than a central agency - who must find the most appropriate fit.

Location

Geographic location was the first difference discussed. What are your preferences for where you would like to volunteer? Are you looking for an environment that is urban? Suburban? Rural? Do you want to be a volunteer in a "virtual" environment? That is, do you want to work primarily on-line? The choice is actually yours. Location needs to be one of the first questions you must ask: The essential question being whether the specific location can extend or enable your career. Once you have a clear sense of your ideal volunteer location, you have

practiced a critical first step in the job search and career development.

Support

Deciding on a location is simply one consideration. You must also ask whether and how the program supports your career goals and practical needs. Beyond location, typical questions to address in searching for volunteer work are practically identical to those asked of organizations seeking paid employees. The following questions in the green box above, are merely examples.

These questions can be addressed in a variety of ways. In investigating opportunities, look into annual reports, thoroughly explore the company website, attempt to locate individuals who have been associated with the program or organization, conduct informational interviews with organization representatives, and attend volunteer recruitment events when available. Does the information you gather correlate with your career needs? Additionally, on a practical note, it helps to have practice with these types of screening systems. When the appropriate paid job opportunity arises, your chances of getting

the job offer will increase with your relative degree of comfort and effectiveness with the behind-the-scenes and face-toface interviewing processes.

Placement

You have the qualifications for particular assignments. In turn, the organization and the program meet your career needs. The organization welcomes your support. Now what? Well, now you must play the role of Peace Corps Placement Officer. Some opportunities may simply not be viable options. For example, the start date may be off, the assignment may not embrace your current or desired skill set, or the site might even labor under challenges that could surpass experiential benefits.

When sizing up full-time job offers, people can pay too much attention to money and too little to what the employer is like. In terms of your career needs, volunteer assignments don't really allow that. You must focus on that which matters most to you, outside of financial compensation. Decide what you want, and then follow your informed instinct. As a reminder, just as with paid jobs, be sure to follow-up with

individuals you've interacted with along the way. If you are unable to seize a volunteer opportunity with a good organization, don't shut the door on future discussions. The networks within the organizations that seek volunteers may prove essential to your long-term career ambitions.

Final Comments

Domestic volunteering carries a wealth of opportunities for individual career development. By understanding the volunteer project selection process and through actual work on the related volunteer assignment, you might be well on the way to entering and loving your ultimate career choice.
