## Modified List of EU Products Subject to Additional Duties

Note: This list is an unofficial summary of the action announced by the USTR on January 14, 2009 to modify the July 1999 action taken in connection with the *EC-Beef Hormones* dispute. The only definitive information is the actual modified action as set out in Annex A of the *Federal Register* notice that is posted on USTR's website and that will shortly be published in the *Federal Register*.
