Col. Peter A. Newell assumed command of the 4th Brigade Combat Team, 1st Armored Division at Fort Bliss, Texas on June 24, 2008. His brigade is deploying to Iraq in May 2009 and will operate in the role of an Advisory and Assistance Brigade—a new concept between the U.S. Army, State Department, and other government agencies.

He enlisted as an armor crewman in the 635th Armor Battalion, Kansas Army National Guard in December 1980. He served in a variety of positions within the battalion before being commissioned as an Armor Officer in December 1985. Following the Command and General Staff College in 1996-1997, he was reassigned as the Battalion S3, 1st Battalion, 12th Infantry (Mechanized), 4th Infantry Division, Fort Carson, Colo. In May 1999, he became the S3 for the 3rd Brigade, 4th Infantry Division. In June 2000, he was reassigned to the Office of the Joint Chiefs of Staff, Pentagon, where he served as a Senior Operations Officer in the National Military Command Center.

In June 2003, Col. Newell assumed command of the 2nd Battalion, 2nd Infantry Regiment, 3rd Brigade, 1st Infantry Division in Kosovo. Newell relinquished command of the battalion and was reassigned to Hohenfels, Germany as the Senior Infantry Maneuver Observer Controller and subsequently as the Senior Brigade Observer Controller at the Joint Multi-national Readiness Center (JMRC). He is a graduate of the Joint Advanced Warfighter School in Norfolk, Va.

He was part of the National Military Command Center when they were awarded the Joint Meritorious Unit Citation for their actions during the Global War on Terrorism.
