## FACTS AND FIGURES

### Personnel

- ▶ 94 U.S. Marshals, one for each federal court district
- ▶ 3,324 Deputy Marshals and Criminal Investigators
- ▶ 1,483 administrative employees and detention enforcement officers
- ▶ Total employees: Approximately 4,901
- ▶ 94 districts; 218 sub-offices; three foreign field offices

### Fugitive Apprehension

- ▶ Arrested more than 36,000 federal fugitives, clearing 39,700 felony warrants
- ▶ USMS-led fugitive task forces arrested more than 73,600 state/local fugitives, clearing 90,600 state/local felony warrants
- ▶ Captured 195 *15 Most Wanted* fugitives since 1983
- ▶ Extradited/deported 857 fugitives from 60 countries in FY2008
- ▶ Authorized 10,756 special deputations in FY2008
- ▶ Under the Adam Walsh Child Protection and Safety Act, enacted in FY2006, Marshals apprehended 8,239 sex offenders in FY2008
- ▶ Additionally, 1,293 cases were initiated with 322 warrants issued and 256 arrested for violating the Walsh Act

### Justice Prisoner and Alien Transportation

- ▶ 378,700 federal prisoner movements
- ▶ Over 229,300 movements by air
- ▶ Over 3,650 non-federal prisoner movements

### Judicial Security

- ▶ Provides a 24/7 response capability for intake and review of threats against the judiciary through the Threat Management Center
- ▶ Ensures the safe and secure conduct of judicial proceedings and protects more than 2,000 federal judges and approximately 5,250 other court officials at over 400 court facilities
- ▶ Protects the Director of the Office of National Drug Control Policy in Washington, D.C., and when he travels
- ▶ Protects the Deputy Attorney General in Washington, D.C., and when he travels
- ▶ Protects the Supreme Court Justices when outside Washington, D.C.
- ▶ Coordinates security for judicial conferences throughout the United States
- ▶ Provides protective details for foreign officials during the United Nations General Assembly Sessions

## **Asset Seizure and Forfeiture**

---

- ▶ Currently managing approximately 18,000 assets with a value of more than \$1.98 billion
- ▶ Real property represents nine percent of total value
- ▶ Cash and financial instruments represent 72 percent of total value
- ▶ Vehicles comprise 26 percent of inventory items
- ▶ Approximately \$4.6 billion shared with state/local agencies since FY1985
- ▶ As of February 2009, equitable sharing payments were approximately \$519 million

## **Prisoner Services**

---

- ▶ Prisoners in daily custody: Approximately 58,000
  - ▶ Prisoners received yearly: 217,000
  - ▶ Prisoners produced yearly: 927,000
- Intergovernmental Agreements***
- ▶ Intergovernmental Agreement jails: 1,800

## **Special Operations Group**

---

- ▶ Specially trained tactical unit created in 1971
- ▶ Responds to emergencies anywhere in the United States or its territories
- ▶ Provides tactical support to district offices or as ordered by the U.S. Attorney General
- ▶ Headquartered at Camp Beauregard, a Louisiana National Guard installation

## **Witness Security Program**

---

- ▶ Witnesses: More than 8,200
- ▶ Participants: More than 18,000 (witnesses and family members)

## **Budget**

---

- ▶ FY 2008 salaries and expenses appropriation: \$864,219,000
- ▶ FY 2009 proposed President's budget request: \$933 million
