SUPPORTING STATEMENT NORTHEAST REGION PERMIT FAMILY OF FORMS OMB CONTROL NO.: 0648-0202

INTRODUCTION:

This submission requests Office of Management and Budget (OMB) approval of the information collection requirements contained in Amendment 1 to the Atlantic herring (herring) Fishery Management Plan (FMP) (Amendment 1).

New collections that will increase the annual budget

Amendment 1 contains the following provision that would slightly increase the annual budget for the Northeast Region Permit Family of Forms (OMB Control No.: 0648-0202): herring limited access permit application and related processes.

New collections that will <u>not</u> increase the annual budget

Amendment 1 contains the following provisions that would modify, but not increase, approved collections: (1) A Vessel Monitoring System (VMS) requirement for vessels fishing under limited access permits; (2) reporting requirements for vessels fishing under the limited access permits; (3) a reporting requirement for weir fishermen west of Cutler, ME; and (4) a research set-aside (RSA) program.

- (1) There are currently 111 full-time herring permit holders that are required to have VMS (OMB Control No.: 0648-0404, Northeast Region Vessel Monitoring and Communications, to be merged with OMB Control No.: 0648-0202 as part of this revision). It is estimated that 90 vessels would qualify for a limited access herring permit. Therefore, the requirement for all limited access herring permit holders to have VMS would not increase the collection budget.
- (2) There are currently 111 full-time herring permit holders that have observer and enforcement notification requirements (OMB Control No.: 0648-0521, Northeast Multispecies Framework Adjustment 40-B Permit, to be merged with OMB Control No.: 0648-0202 as part of this revision). It is estimated that 90 vessels would qualify for a limited access herring permit. Therefore, the notification requirement for all limited access herring permit holders would not increase the collection budget.
- (3) Amendment 1 would require weir fishermen west of Cutler, ME to report their catch via Interactive Voice Report (IVR) each time they harvest their net(s). However, since open access incidental catch permit holders must currently report through the IVR system if they land more than 2000 lb and weir harvests are often in excess of 2000 lb, this requirement would not likely affect the collection budget. There are currently less than 10 weir fishermen west of Cutler, ME.
- (4) Amendment 1 would create a herring RSA program under which 0-3% of the annual herring total allowable catch (TAC) would be set aside to fund research that would increase the knowledge of the herring resource. The Northeast Fishery Management Council (Council) would establish research priorities annually, and issue a Request for Proposals (RFP) for herring

research/surveys to be conducted under the TAC set-aside. Researchers could then submit a research proposal in response to the RFP using the existing NOAA Grant application process. The forms included in the NOAA Grant application, Standard Forms 424, 424A, 424B, and SF-LLL are already approved under OMB Control Numbers: 0348-0043, 0348-0044, 0348-0040, and 0348-0046, respectively. The required certification forms, CD-511 and CD-512, are exempt from PRA requirements. The TAC set-aside program proposed in Amendment 2 would not involve a new collection or increase the current information collection budget, for the previously approved collections.

A. JUSTIFICATION

1. Explain the circumstances that make the collection of information necessary.

Under the Magnuson-Stevens Fishery Conservation and Management Act (Magnuson-Stevens Act), the Secretary of Commerce (Secretary) has responsibility for the conservation and management of marine fishery resources off the coast of the United States. The majority of this responsibility has been delegated to the Councils and the National Oceanic and Atmospheric Administration's (NOAA's) NOAA National Marine Fisheries Service (Fisheries).

Amendment 1 to the herring FMP is needed to improve resource conservation, minimize the potential for excess harvesting capacity in the fishery, and provide a platform to promote long-term economic stability for harvesters, processors, and fishing communities. This amendment is designed to meet all the requirements of the Magnuson-Stevens Fishery Conservation and Management Act, as well as other applicable laws.

Limited access justification:

Management of a number of fisheries in the Northeast Region is complicated by excess fishing capacity, which makes it difficult to reduce fishing mortality to levels necessary for stock rebuilding. In order to avoid the problems experienced in these fisheries, we would like to implement a limited access system for the herring fishery to address existing capacity problems in Area 1A and avoid such problems in other areas as the fishery continues to develop.

Although the overall herring TAC is often not harvested, the TAC in the inshore Gulf of Maine (Area 1A) represents at least 60% of the total landings and has triggered a closure of the herring fishery in this area every year. Harvesting capacity in this area may need to be restricted to avoid problems that result from excess fishing capacity.

Consistent with other limited access programs established by the Councils, initial eligibility for a herring limited access permit must be established during the first year after the implementation of Amendment 1. To prove that a vessel is eligible for the limited access program under any landings criteria established through Amendment 1, applicants would have to submit third-party verification of landings history, such as dealer receipts. To qualify for a Limited Access Directed Fishery Permit for Area 1 (allows access to all management areas), a vessel must currently possess a herring permit and have landed at least 500 metric tons (mt) of herring in any one calendar year between January 1, 1988 and September 16, 1999. To qualify for a Limited Access Directed Fishery Permit for Areas 2/3 (allows access to Areas 2 and 3 only), a vessel must currently possess a herring permit and have landed 250 mt of herring in any consecutive twelve

months between January 1, 1988 and December 31, 2003. Vessels that do not qualify for either Limited Access Directed Fishery Permits could qualify for a Limited Access Incidental Catch Permit to fish for herring in any management area if they currently possess a permit to fish for squid, mackerel, butterfish, and/or whiting and have landed at least 15 mt of herring in any calendar year between January 1, 1993 and December 31, 2002.

An appeals procedure will be developed similar to that established for previous limited access programs. An applicant who has been denied a limited access Atlantic herring permit may appeal in writing to the Regional Administrator.

Vessel Replacements and Upgrades

The term vessel replacement, in general, refers to replacing an existing limited access vessel with another vessel. In addition to addressing increases in vessel size and horsepower, the consistency amendment also established a restriction that requires that the same entity must own both the limited access vessel (and fishing history) that is being replaced, and the replacement vessel. In order to maintain consistency with the other regional limited access programs, this provision would be adopted for the Atlantic herring limited access program. A vessel must submit a replacement application to transfer limited access permits from one vessel to another vessel.

This measure would also establish vessel upgrade restrictions for the herring fishery that are consistent with vessel upgrade restrictions in the Multispecies FMP and other limited access fisheries in the Northeast Region. Upgrade restrictions limit the ability of a qualified vessel to increase fishing power Upgrading a vessel requires the submission of an upgrade application.

Permit Renewals and Confirmation of Permit History (CPH)

A vessel owner must maintain the limited access permit status for an eligible vessel by renewing the permits or applying for issuance of a confirmation of permit history (CPH) on an annual basis. A CPH is issued to a person who does not currently own a fishing vessel, but who has legally retained the fishing and permit history of the vessel for the purpose of transferring it to a replacement vessel at a future date. Annual renewal is considered important in establishing participants who have an active interest in maintaining their ability to participate in a limited access fishery, and conversely allowing permits to lapse and be cancelled for those who do not.

A person who does not currently own a fishing vessel, but who has owned a qualifying vessel that has sunk, been destroyed, or transferred to another person, must apply for and receive a CPH if the fishing and permit history of such vessel has been retained lawfully by the applicant. To be eligible to obtain a CPH, the applicant must show that the qualifying vessel meets the eligibility requirements for the limited access herring permit in question. Issuance of a valid CPH preserves the eligibility of the applicant to apply for a limited access permit for a replacement vessel based on the qualifying vessel's fishing and permit history at a subsequent time. A CPH application must be received by the Regional Administrator no later than 30 days prior to the end of the first full fishing year in which a vessel permit cannot be issued. Failure to do so is considered abandonment of the permit.

2. Explain how, by whom, how frequently, and for what purpose the information will be used. If the information collected will be disseminated to the public or used to support information that will be disseminated to the public, then explain how the collection complies with all applicable Information Quality Guidelines.

Vessel permit information is available to the public via the web site for the Northeast Regional Office at www.nero.noaa.gov, and is also available upon request. In most cases, vessel permit information is provided in aggregate form. However, there are cases, such as for law enforcement or mailings, that individual permit information is required. The individual vessel information used for mailings that is derived from the vessel permit application provides NOAA Fisheries with the assurance of reaching all affected constituents with notices of fishery closures, regulatory changes, and other important information. Thus, this information is used frequently; at least once a month.

Vessels applying for a limited access herring permit under the proposed limited access program would be required to complete an application for the limited access permit category for which they are applying and submit proof of landings that meet the criteria for that permit category. This information will be used by NOAA Fisheries to qualify the vessel for the applicable limited access permit category. The initial application for a limited access permit is a one-time occurrence. However, once a vessel is determined to qualify for a limited access permit, it is required to renew that permit annually. Further, the permit category itself will be used by NOAA Fisheries to identify these new limited access vessels, on a case-by-case basis, to ensure compliance with the restrictions associated with possessing a limited access permit.

It is anticipated that the information collected will be disseminated to the public or used to support publicly disseminated information. As explained in the preceding paragraphs, the information gathered has utility. NOAA Fisheries will retain Control over the information and safeguard it from improper access, modification, and destruction, consistent with NOAA standards for confidentiality, privacy, and electronic information. See response #10 of this Supporting Statement for more information on confidentiality and privacy. The information collection is designed to yield data that meet all applicable information quality guidelines. Prior to dissemination, the information will be subjected to quality Control measures and predissemination review pursuant to Section 515 of Public law 106-554.

3. <u>Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological techniques or other forms of information technology.</u>

After initial permit issuance, permit renewal is made as easy as possible for both the public and the issuing office. The information obtained from the vessel's initial permit application is used to prepare a computer generated pre-printed renewal form. This pre-printed form is sent directly the vessel owner each year along with permit renewal instructions. If there are no changes to the information contained on the pre-printed renewal form, renewal only requires the applicant's signature. This feature minimizes the reporting burden on the public and administrative burden on the agency. Furthermore, vessel owners may also request a pre-printed renewal form at any time during the year to make necessary changes to their permit or contact information.

In addition to being available upon request, vessel permit information and all initial permit

applications and forms are available on the Northeast Regional Office's web site at www.nero.noaa.gov/nero/permits/index.html. Posting this information on the web makes it easier for the general public to obtain necessary forms and instructions, and eases the administrative burden on the agency.

4. Describe efforts to identify duplication.

NOAA Fisheries is aware of all related fishery management activities, and these requirements do not duplicate any in existence.

5. <u>If the collection of information involves small businesses or other small entities, describe</u> the methods used to minimize burden.

The proposed collection of information will not have a significant impact on small entities. Only the minimum data to meet the requirements of the above data needs are requested from all participants. Furthermore, detailed instructions are included with all required applications and forms to help facilitate proper completion. Since all of the respondents are small businesses, separate requirements based on the size of the business have not been developed.

6. <u>Describe the consequences to the Federal program or policy activities if the collection is not conducted or is conducted less frequently.</u>

The limited access herring permit application is a one-time application. However, vessels would be required to renew this limited access permit on an annual basis or lose the permit permanently. To require vessels to renew their applications less frequently would result in necessary information not being updated in a timely manner. Furthermore, the information collected on the vessel permit form provides valuable fishery information (fishing power, gears used, etc.) that is used annually to describe the herring fleet and conduct the necessary analysis of impacts of changes in management measures. Because an application is essential to identify the vessel applying for a limited access permit, the program could not occur if the collection is not conducted.

7. Explain any special circumstances that require the collection to be conducted in a manner inconsistent with OMB guidelines.

This collection request is consistent with OMB guidelines.

8. Provide a copy of the PRA Federal Register notice that solicited public comments on the information collection prior to this submission. Summarize the public comments received in response to that notice and describe the actions taken by the agency in response to those comments. Describe the efforts to consult with persons outside the agency to obtain their views on the availability of data, frequency of collection, the clarity of instructions and recordkeeping, disclosure, or reporting format (if any), and on the data elements to be recorded, disclosed, or reported.

The Council has held many meetings that received public comment during the development of Amendment 1 to the FMP. These meetings took place from April, 2003 through the present. The information collections contained in this submission are part of a proposed rule, RIN 0648-

AQ87, scheduled to publish in September 2006.

9. Explain any decisions to provide payments or gifts to respondents, other than remuneration of contractors or grantees.

No payment or gift will be made to respondents.

10. <u>Describe any assurance of confidentiality provided to respondents and the basis for assurance in statute, regulation, or agency policy.</u>

All data will be kept confidential as required by Section 402(b) of the Magnuson-Stevens Act, will be maintained in accordance with NOAA Administrative Order 216-100, Confidentiality of Fisheries Statistics, and will not be released for public use except in aggregate statistical form (and without identifying the source of data, i.e. vessel name, owner, etc.)

11. <u>Provide additional justification for any questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private.</u>

There are no questions of a sensitive nature.

12. Provide an estimate in hours of the burden of the collection of information.

Table 1 summarizes the time burden of this new reporting requirement.

<u>Limited access application</u> process:

It is estimated that there will be 200 applicants for a limited access herring permit with an average processing time of 45 minutes for a total burden of 151 hours. Only 90 are expected to qualify and consequently renew their application each year. The renewal application is estimated to take 30 minutes on average to process for a burden of 45 hours. Up to 10 applicants are expected to appeal the denial of their permit application. The appeals process is estimated to take 2 hours to complete, on average, with a burden of 20 hours.

Replacement / Upgrade / CPH

New limited access herring vessels would be subject to the same replacement, upgrade, and permit history restrictions as other limited access vessels. Completion of a replacement or upgrade application requires an estimated 3 hours per response. It is estimated that no more than 20 of the 90 vessels possessing these limited access permits will request a vessel replacement or upgrade annually. This resultant burden would be up to 20 hours. Completion of a confirmation of permit history (CPH) application requires an estimated 30 minutes per response. It is estimated that no more than 10 of the 90 vessels possessing these limited access permits will request a CPH annually. The resultant burden would be up to 5 hours.

Total annualized responses would be 167, and hours, 165.

The 3 year average total public cost burden for permit applications, appeals and renewals, at an hourly rate of \$15, is \$1,300. At the same rate, the total public cost burden for replacement/upgrade and CPH applications is \$975.

Burden added from 0648-0404: VMS reporting of 150 vessels, 684,000 responses (4,560 responses per vessel), at 5 seconds per transmission, totaling 957.6 hours annually; 10 requests for letters of authorization for VMS exemption, at 2 minutes per request, totally 30 minutes: **Total responses = 684,010; total annualized burden rounded to 958 hours.**

Burdens added from 0648-0521:

- a) Burden transferred from 0648-0525, Haddock Bycatch Notification of Landing, when merged into 0648-0521: landing notifications for 105 vessels x 5 minutes, averaging 6.37 trips per vessel, **totaling 669 responses and 56 hours** (5 minutes per response).
- b) Original 0648-0521 burden:
 - (1) Georges Bank cod research total allowable catch (TAC) Set-Aside (for researchers): 5 respondents x 1annual request x 30 minutes = 3 hours.
 - (2) Request for letter of authorization (LOA) for Western Gulf of Maine (WGOM) closure area rod/reel haddock special access program: 50 respondents x 1 annual request x 5 minutes = 4 hours.
 - (3) WGOM closure area rod/reel haddock special access program VMS polling: 50 respondents x 8,784 responses = 439,200 responses x 0.6 seconds = 439 hours.
 - (4) WGOM closure area rod/reel haddock special access program area and days at sea declaration time: 200 respondents x 1 response x 5 minutes = 17 hours.
 - (5) WGOM closure area rod/reel haddock special access program observer notification: 200 respondents x 1 response x 2 minutes = 7 hours.
 - (6) Herring vessel observer notification: 105 respondents x 12.74 responses on average = 1,337 responses x 2 minutes = 44 hours.
 - (7) Herring vessel observer waiver landings notification: 105 respondents x 6.37 responses = 669 responses and 56 hours.
 - (8) Vessels notifying of standing by entangled whales: 10 vessels x 1 response x 2 hours = 20 hours.
 - (9) Days at sea credit request by vessels standing by entangled whales: 10 vessels x 1 response x 30 minutes = 5 hours.

Total responses = 441,681 and total hours = 593 for original 0648-0521: 593.

Total responses for this request: 1,126,527. Total hours: 1,774.

13. Provide an estimate of the total annual cost burden to the respondents or record-keepers resulting from the collection (excluding the value of the burden hours in #12 above).

With the exception of burden hours, there would be no annual cost burden as a result of this new collection.

Costs added from 0648-0404: messaging costs of \$1,500 per vessel total \$225,000 annually.

Costs added from 0648-0521:

- a) Costs transferred from 0648-0525, Haddock Bycatch Notification of Landing, when merged into 0648-0521: landing notifications 669 transmissions $x \, \$0.50 = \335 .
- b) Original 0648-0521 costs:
 - (1) Georges Bank cod research total allowable catch (TAC) Set-Aside (for researchers): 5 respondents x 1 annual request x \$0.40 = \$2.
 - (3) WGOM closure area rod/reel haddock special access program VMS polling: 50 respondents x \$1,800 annual operations costs = \$90,000.
 - (4) WGOM closure area rod/reel haddock special access program area and days at sea declaration time: 200 respondents x 1 response x \$050 = \$100.
 - (5) Herring vessel observer waiver landings notification: 105 respondents x 6.37 responses = 669 responses x \$0.50 = \$335.
 - (6) Days at sea credit request by vessels standing by entangled whales: 10 vessels x 1 response x 30 minutes x 0.40 = 4.

Total costs: **\$90,441**.

All other burden requirements for 0648-0521 listed in #12 have no public costs.

Total costs from this request: \$315,776.

14. Provide estimates of annualized cost to the Federal government.

A full summary of the cost to the Federal Government associated with this new collection of information can be found in Table 1.

The estimated average cost to the Federal Government to issue a Federal fishery permit is \$33 per permit, including labor, printing, distribution, computer time, and handling. It is estimated that there will be 200 initial permit applications and 90 annual permit renewals, resulting in an average 3 year government cost burden of \$4,180.

The annual estimated cost to the Federal Government is estimated to be \$25 for processing appeals, vessel replacements, vessel upgrades, and confirmations of permit history applications. It is estimated that there will be up to 30 replacement/upgrade/CPH applications processed annually, which will increase the annual government burden total to \$5,180.

Costs from original 0648-0521, using \$25 per hour wage rate = \$7,868. Costs transferred from 0648-0525 when merged into 0648-0521, using \$25 per hour wage rate = \$836.

Costs from 06480-0404, using \$25 per hour wage rate = \$38,960.

Total federal costs from this request: \$52,844.

15. Explain the reasons for any program changes or adjustments reported in Items 13 or 14 of the OMB 83-I.

Respondents have not changed since the last approved action (merger of 0648-0481 into 0648-0202).

A total increase of 1,126,527 responses has been added from the new collection and the merging collections.

An increase of 1) 165 in burden hours is due to Amendment 1. Additional burden hour increases due to merges as part of this request are: 2) 958 from 0648-0404, for VMS operations and maintenance and 3) 649 from 0648-0521 for requests for allocation of Georges Bank cod to facilitate research projects; the Western Gulf of Maine Rod/Reel Haddock Special Access Program; herring vessel observer and law enforcement notifications; request for Days-at-Sea credit from standing by an entangled whale and haddock bycatch notification of landing.

A cost increase of \$225,000 for VMS operations and maintenance has been transferred from 0648-0404 (capital and start-up costs from that collection have expired) and a cost increase of \$90,776 for recordkeeping and reporting has been transferred from 0648-0521.

Supplemental Information for Vessel Replacements and Upgrades

Vessel Baseline Specifications and Allowed Upgrades

For all vessels with limited access permits (except lobster and handgear), the vessel size and engine horsepower may only be increased once, either through upgrade or replacement. A 10% increase in length overall, gross registered tonnage, and net tonnage, and a 20% increase in engine horsepower are allowed. Vessel size and engine horsepower upgrades may be done separately. Any increase in vessel size, including length overall, gross registered tonnage and net tonnage must be done at the same time. Note: If your vessel has only a lobster and/or handgear limited access permit, there are no size restrictions on the replacement vessel; however, if you have either of those permits and another limited access permit, the replacement vessel is subject to the above restrictions.

A limited access permit cannot be "split" from another limited access permit. This means if two or more limited access permits are on one boat they may not be divided and put on two boats. Please call 978-281-9300 for additional explanation if you have any questions about this restriction.

Scallop Trawl Net Authorization (Replacements Only)

Scallop vessels holding a permit authorization to fish for scallops with trawl nets can be replaced, and the scallop trawl net authorization passed to the replacement vessel. However, the replacement vessel must meet the same limitations on fishing for scallops with scallop dredges that the vessel it is replacing met. If the limitations are not met then the replacement vessel may have to relinquish the scallop trawl net authorization. These limitations include NOT having fished for scallops with a scallop dredge after December 31, 1987; NOT having fished for scallops with a scallop dredge on no more than 10 trips from January 1, 1988, through December 31, 1994; and having an engine with no greater than 450 horsepower.

Notwithstanding any other provision of law, no person is required to respond to nor shall a person be subject to penalty for failure to comply with, a collection of information subject to the requirements of the Paperwork Reduction Act, unless that collection of information displays a current valid OMB Control Number.
