# SUPPORTING STATEMENT NORTHEAST REGION VESSEL IDENTIFICATION OMB CONTROL NO.: 0648-0350

### A. JUSTIFICATION

# 1. Explain the circumstances that make the collection of information necessary.

Regulations at 50 CFR § 648.8 and § 697.8 require that vessels over 25 ft in registered length, with Federal permits to fish in the Northeast, display the vessel's name and official number. The success of fisheries management programs depends upon regulatory compliance. The vessel identification requirement, which is required of all Federally permitted fishing vessels in the Northeast region, is essential to facilitate enforcement. The ability to link fishing or other activity to a vessel owner or operator is crucial to the enforcement of regulations issued under the authority of the Magnuson-Stevens Fisheries Conservation and Management Act (Magnuson Act) as amended in 2006. By being able to identify vessels, enforcement personnel can easily identify Federal permit holders that are fishing in restricted areas and/or during restricted times.

2. Explain how, by whom, how frequently, and for what purpose the information will be used. If the information collected will be disseminated to the public or used to support information that will be disseminated to the public, then explain how the collection complies with all applicable Information Quality Guidelines.

No information is directly submitted to National Oceanic and Atmospheric Administration, National Marine Fisheries Service (NOAA Fisheries) as a result of this collection. The vessel name must be affixed to the port and starboard sides of the deckhouse or hull, and on an appropriate weather deck so as to be visible from enforcement vessels and aircraft. This identification allows law enforcement personnel, including U.S. Coast Guard, NOAA Office of Law Enforcement, and state marine patrols, to ascertain whether the vessel's observed activities are in accordance with those authorized for that vessel. Concerned fishermen also use the number to report suspicious activities that they observe. Fishermen ultimately benefit as unauthorized and illegal fishing is deterred, which reduces the need for more restrictive fishing regulations.

3. <u>Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological techniques or other forms of information technology.</u>

This identification requirement facilitates the visual identification of fishing vessels. Although technologies have been developed to electronically identify and monitor vessels, this form of vessel identification is indispensable. The visual collection of the vessel identification characters by law enforcement personnel may involve binoculars or other sight enhancement technology.

### 4. Describe efforts to identify duplication.

There is no duplication of this requirement with other collections by NOAA Fisheries. However, the U.S. Coast Guard and many states require the same identification of vessel name and official

number. These requirements are complementary and do not create additional nor duplicative requirements.

# 5. <u>If the collection of information involves small businesses or other small entities, describe the methods used to minimize burden.</u>

Nearly all the commercial fishing vessels subject to this information collection are categorized as small businesses. It is not anticipated that the information collection will have any significant impact on the operations of small businesses.

# 6. <u>Describe the consequences to the Federal program or policy activities if the collection is not conducted or is conducted less frequently.</u>

If commercial fishing vessels were not identifiable by the National Marine Fisheries Service, U.S. Coast Guard, or any other cooperating enforcement agency the ability to enforce fishery regulations would be significantly impaired. The requirements of this collection are only repeated once the identification markings become illegible.

# 7. Explain any special circumstances that require the collection to be conducted in a manner inconsistent with OMB guidelines.

No special circumstances require the collections to be conducted in a manner inconsistent with the OMB guidelines.

A Federal Register Notice published on October 17, 2007 (72 FR 58812) solicited public comments. No comments were received.

# 9. Explain any decisions to provide payments or gifts to respondents, other than remuneration of contractors or grantees.

No payments or gifts are provided to respondents as part of this collection.

# 10. <u>Describe any assurance of confidentiality provided to respondents and the basis for assurance in statute, regulation, or agency policy.</u>

Vessel identification is not considered confidential information and thus no confidentiality is provided.

# 11. <u>Provide additional justification for any questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private</u>.

No sensitive questions are asked as a part of this collection.

# 12. Provide an estimate in hours of the burden of the collection of information.

The commercial fishing vessel's official number must be displayed at a specified size on the port and starboard sides of the deckhouse or hull and on a weather deck. It is estimated that each vessel will require a total of 45 minutes to paint the number in all three required locations. Each number is expected to need to be touched up or repainted on an annual basis. Table 1 provides a summary of annual burden for vessel identification. This comes to approximately 4,500 hours (45 min x 6,000 vessels).

# 13. Provide an estimate of the total annual cost burden to the respondents or record-keepers resulting from the collection (excluding the value of the burden hours in #12 above).

The cost to the respondents is minimal. Materials needed are paint and paintbrush, and possibly a stencil. The cost of materials each year for painting/repainting can be estimated to be \$10 per respondent, totaling \$60,000. It is anticipated that repainting or repairs would occur annually due to natural weathering of the paint. Table 1 provides a summary of annual costs for vessel identification.

## 14. Provide estimates of annualized cost to the Federal government.

There are no costs attributed to the Federal government resulting from this collection.

# 15. Explain the reasons for any program changes or adjustments reported in Items 13 or 14 of the OMB 83-I.

The number of respondents, federally permitted commercial fishing vessels, has been adjusted upward by 500 respondents due to the number of permitted vessels greater than or equal to 25 feet in overall length, currently listed in the permit database. The total number of respondents and responses is now estimated to be 6,000 per year, with a corresponding increase of 375 hours (from 4,125 to 4,500) and an increase of \$5,000 (from \$50,500 to \$60,000).

This collection will not produce any results that will be published.

PART 648—FISHERIES OF THE NORTHEASTERN UNITED STATES Subpart A—General Provisions

#### § 648.8 Vessel identification.

- (a) Vessel name and official number. Each fishing vessel subject to this part and over 25 ft (7.6 m) in registered length must:
- (1) Affix permanently its name on the port and starboard sides of the bow and, if possible, on its stern.
- (2) Display its official number on the port and starboard sides of the deckhouse or hull, and on an appropriate weather deck so as to be clearly visible from enforcement vessels and aircraft. The official number is the USCG documentation number or the vessel's state registration number for vessels not required to be documented under title 46 U.S.C.
- (b) *Numerals*. Except as provided in paragraph (d) of this section, the official number must be displayed in block arabic numerals in contrasting color at least 18 inches (45.7 cm) in height for fishing vessels over 65 ft (19.8 m) in registered length, and at least 10 inches (25.4 cm) in height for all other vessels over 25 ft (7.6 m) in registered length. The registered length of a vessel, for purposes of this section, is that registered length set forth in USCG or state records.
- (c) Duties of owner. The owner of each vessel subject to this part shall ensure that—
- (1) The vessel's name and official number are kept clearly legible and in good repair.
- (2) No part of the vessel, its rigging, its fishing gear, or any other object obstructs the view of the official number from any enforcement vessel or aircraft.
- (d) Non-permanent marking. Vessels carrying recreational fishing parties on a per capita basis or by charter must use markings that meet the above requirements, except for the requirement that they be affixed permanently to the vessel. The non-permanent markings must be displayed in conformity with the above requirements.
- (e) New Jersey surf clam or ocean quahog vessels. Instead of complying with paragraph (a) of this section, surf clam or ocean quahog vessels licensed under New Jersey law may use the appropriate vessel identification markings established by that state.

#### § 697.8 Vessel identification.

- (2) Have its official number displayed on the port and starboard sides of the deckhouse or hull, and on an appropriate weather deck so as to be clearly visible from enforcement vessels and aircraft. The official number is the USCG documentation number or the vessel's state registration number for vessels not required to be documented under title 46 U.S.C.
- (b) *Numerals*. Except as provided in paragraph (d) of this section, each fishing vessel issued a limited access American lobster permit must display its official number in block Arabic numerals in contrasting color at least 18 inches (45.7 cm) in height for fishing vessels over 65 ft (19.8 m) in registered length, and at least 10 inches (25.4 cm) in height for all other vessels over 25 ft (7.6 m) in registered length. The registered length of a vessel, for purposes of this section, is that registered length set forth in USCG or state records.
- (c) Duties of owner. The owner of each vessel issued a limited access American lobster permit shall ensure that—
- (1) The vessel's name and official number are kept clearly legible and in good repair.
- (2) No part of the vessel, its rigging, its fishing gear, or any other object obstructs the view of the official number from any enforcement vessel or aircraft.
- (d) Non-permanent marking. Vessels over 25 ft (7.6 m) in registered length, fishing in the EEZ and carrying recreational fishing parties on a per capita basis or by charter must use markings that meet the above requirements, except for the requirement that they be affixed permanently to the vessel. The nonpermanent markings must be displayed in conformity with the aforementioned requirements.

U.S. groundfish fisheries of the Exclusive Economic Zone (EEZ) off Washington, Oregon and California under the Pacific Coast Fishery Management Plan. In its consideration of a groundfish trawl rationalization program, the Pacific Fishery Management Council (PFMC) has requested that NMFS collect detailed information for owners of trawl endorsed limited entry permits in order to develop an appropriate policy. The recent reauthorization of the Mangnuson-Stevens Fishery Conservation and Management Act (MSA) placed a deadline on the PFMC to complete its consideration of the trawl rationalization program. Further, the MSA (Section 303A(5)(B)(ii)) requires that the Secretary of Commerce consider procedures to address concerns over excessive geographic and/or other consolidation in harvesting and processing sectors of the fishery. NMFS would request that all trawl endorsed permit owners who are business entities to provide the names of individuals who have an ownership interest in the entity and the percentage of interest held in the entity by such individuals. This information would be requested annually on a voluntary basis.

In addition, NMFS would revise its existing sablefish ownership interest form to request that all business entities who own or hold a sablefish permit to provide the percentage of ownership interest each individual has in the business entity. This information about the percentage of ownership interest by an individual would be requested on a voluntary basis.

**SUPPLEMENTARY INFORMATION:** The mission of NCCOS is to provide coastal managers and other decisionmakers with scientific information and tools needed to balance society's environmental, social, and economic goals in mitigating and adapting to ecosystem stressors such as climate change, extreme natural events,

pollution, invasive species, and resource use. Humans are integral to ecosystems, and the human dimensions of ecosystems are an integral focus of the science needed to achieve this mission. Understanding the impact of humans on the ocean, the impacts of the ocean on humans, and the human aspects of ocean governance provides the scientific basis for ensuring ocean health and quality of life for this and future generations.

Marine science and policy institutions in the United States and worldwide recognize that a deeper understanding of the human dimensions of ecosystems—human causes, consequences, and responses to ecosystem stress—is needed to foster improved support for coastal and ocean decisionmaking. Examples include the Joint Subcommittee on Ocean Science and Technology, Subcommittee on Integrated Management of Ocean Resources, United States Commission on Ocean Policy, Pew Oceans Commission, and NOAA's External Ecosystem Task Team.

The NCCOS Human Dimensions Strategic Plan (FY2009–FY2014) establishes goals and objectives for fostering improved support of coastal and ocean decisionmaking by integrating human dimensions into the NCCOS's science program. It provides the basis for subsequent development of an implementation plan specifying programmatic elements such as strategies, outcomes, partnerships, and fiscal and human resources needs.

Comments and Responses: On February 15, 2007, NCCOS published a notice of availability and solicitation of public comments on a Draft Human Dimensions Strategic Plan (Notice of availability and solicitation of public comments on the National Centers for Coastal Ocean Science Draft Human Dimensions Strategic Plan (FY2008-FY2013), 72 FR 7418-7419 (Feb. 15. 2007)). During the 30-day public comment period, NCCOS received the following comments from the City of Craig, Alaska; Consortium for Oceanographic Research and Education; Island Resources Foundation; New Jersey Marine Science Consortium; NOAA's National Marine Fisheries Service, Office of Science and Technology; NOAA's National Ocean Service, Coastal and Ocean Resource Economics Program; NOAA's Office of Oceanic and Atmospheric Research, Office of Weather and Air Quality and Climate Program Office; NOAA's Research Council; and University of Massachusetts-Amherst Human Dimensions of Marine and Coastal Ecosystems Program. In response to

comments received, NCCOS revised the Draft Human Dimensions Strategic Plan as follows.

#### **General Comments**

Comment 1: Several commenters commended NCCOS on taking this first step toward integrating the human element into coastal management and the required supporting scientific efforts.

Response: NCCOS appreciates this encouragement and advocacy from its coastal science and management partners, and looks forward to working with them to implement human dimensions research priorities.

Comment 2: Several commenters stated that the document is too long and recommended eliminating redundancy.

Response: NCCOS considerably reduced the length of the document and eliminated redundancy. To accommodate diverse levels of interest, NCCOS formatted the plan to describe each strategic objective at four levels of detail: A title, summary statement, concise rationale, and discussion. The discussion sections provide justification and explanation of strategic objectives at a level of detail that NCCOS believes is critical to cultivate a workforce that understands, appreciates, and facilitates the mission value of human dimensions research.

Comment 3: Several commenters stated that the document includes excessive social science jargon.

Response: NCCOS minimized social science jargon. However, NCCOS included and defined key technical terms such as socioeconomic driver, ecosystem service, mitigation, nonmarket value, and resilience. In doing so, NCCOS is responsive to the finding of the Social Science Review Panel to NOAA's Science Advisory Board that developing social science capacity in NOAA is challenged by "a lack of formal understanding of what social science is and what its contributions can be, leading to an organizational culture that is not conducive to social science research." By including and defining key technical terms, NCCOS aims to foster the human dimensions literacy and common language needed to develop an integral human dimensions focus within its science

Comment 5: Several commenters stated that the plan should include programmatic elements such as projects, timelines, fiscal and human resource needs, and deliverables.

Response: As explained in the "Future Directions" section of the "Overview," NCCOS wishes to clarify that this plan provides the basis for a
