SUPPORTING STATEMENT SOUTHEAST REGION ELECTRONIC REPORTING SURVEY

Introduction

This request for OMB review is for the Southeast Fisheries Science Center (SEFSC), National Marine Fisheries Service (NMFS) to conduct a one-time survey of all fishermen and dealers that have been issued a federal permit associated with fishery management plans in the Southeast Region. In accordance with the Government Paperwork Elimination Act (GPEA, P.L. 105-277), Federal agencies are required to provide the opportunity for persons, that are required to submit information to the government, to do so electronically when practicable. The purpose of this survey is to determine how many of the permit holders have (or have access to) a personal computer and whether these individuals and/or businesses would be willing to use the computers to report mandatory data regarding catch and effort data required by the respective fishery management plans in the Southeast Region.

Although the NMFS has submitted its plan to meet the October 23, 2003 deadline for compliance with the GPEA, the SEFSC feels that additional information is required regarding the use of and access to personal computers and the Internet before determining how best to meet the GPEA obligations. There are several methods that can be designed that will allow fishermen and dealers to submit catch and effort data electronically. For example, hardware is currently available that can be installed on a vessel that records the exact location of the vessel based on the global positioning system (GPS) onboard the vessel. This hardware is costly to purchase and install, and may not be necessary for all vessels. Another example is the availability of a secure Web site with an application that allows vessel owners or dealers to enter the required data online, which should eliminate the need for these respondents to prepare paper logbooks or dealer reports.

There are, of course, numerous other examples of potential methods for electronic reporting. The quandary that the SEFSC faces is to determine the most feasible and likely to be accepted (and used) method or methods. Obviously, the SEFSC does not want to waste limited resources to develop and implement a method of electronic reporting, only to have it infrequently used. The purpose of this survey, therefore, is to collect information on the number of fishermen and dealers that have computers and would use them to report electronically.

A. JUSTIFICATION

1. Explain the circumstances that make the collection of information necessary.

The information in this survey will be used to develop a plan for implementation of electronic reporting in the Southeast Region. The Government Paperwork Elimination Act (GPEA, P.L. 105-277) requires Federal agencies to provide the opportunity for persons, that are required to submit information to the government, to do so electronically when practicable. Because of the large diversity in the sizes of commercial harvesting and processing businesses within the

Southeast, it is important to have a good understanding of whether these businesses have access to personal computers and the Internet. The information from this one-time survey will allow the SEFSC to develop more realistic plans for the availability of electronic reporting. Because the cost of electronic reporting can be substantial, both the initial capital (human or fiscal) cost and the ongoing cost of maintaining and upgrading the system(s), the SEFSC wants to be sure that there will be a reasonable return on these costs in terms of increased efficiently to either the fishing community or the Federal government (but hopefully both). However, if little or no use will be made of electronic reporting, either because of lack of hardware or the willingness to use electronic reporting, then the SEFSC cannot justify large funding allocations to such projects.

2. Explain how, by whom, how frequently, and for what purpose the information will be used.

The proposed survey will only be conducted one time, although there will be follow up provisions to encourage recipients that did not respond on the initial mailing to respond. A questionnaire will be sent, via regular mail, to all vessel owners and dealers that have an active or recently expired Federal permit for commercial fishing or seafood production in the Southeast (mailing addresses located in all states from North Carolina through Texas). Because the business practices are different between commercial harvesting (fishermen) and seafood processors (dealers), two separate questionnaires will be used, i.e., one will be sent to vessels owners and one will be sent to dealers. The essence of the questionnaires are the same, but it makes the design of the questions simpler if different questionnaires are used.

As noted above the purpose of this survey is to collect information on whether vessel owners and seafood dealers have access to personal computers and the Internet, and would be willing to use them to submit mandatory fisheries information in lieu of a report on paper.

3. <u>Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological techniques or other forms of information technology.</u>

This survey will not be conducted with electronic reporting.

4. Describe efforts to identify duplication.

To the knowledge of the SEFSC, comprehensive information on the numbers of vessel owners and seafood dealers that have personal computers and have access to the Internet is not currently available. The SEFSC is aware that some dealers are currently using electronic reporting to submit detailed information on the seafood products that they purchase to the respective state agency that regulates them. Because the needed information on electronic reporting is already available from these dealers, they will not be included in the SEFSC's survey.

5. <u>If the collection of information involves small businesses or other small entities, describe</u> the methods used to minimize burden.

Because almost all dealers and fishermen are considered small businesses, separate requirements based on size of business have not been developed. Only the minimum data to meet reporting objectives are required from the respondents. The data requested in these questionnaires is readily available from the recipients without any additional recordkeeping. Thus, the reporting burden on vessel owners and dealers is at a minimum.

6. Describe the consequences to the Federal program or policy activities if the collection is not conducted or is conducted less frequently.

The SEFSC feels that this information is critical in order to develop a cost-effective plan for electronic reporting in the Southeast.

7. Explain any special circumstances that require the collection to be conducted in a manner inconsistent with OMB guidelines.

No special circumstances are requested for this survey.

9. Explain any decisions to provide payments or gifts to respondents, other than remuneration of contractors or grantees.

No payment or other remuneration are provided.

10. Describe any assurance of confidentiality provided to respondents and the basis for assurance in statute, regulation, or agency policy.

The responses to the questions on this survey are not of a sensitive or confidential nature do not fall under either the Magnuson-Stevens Fishery Conservation and Management Act or the Privacy Act.

11. Provide additional justification for any questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private.

No questions of a sensitive nature are asked.

12. Provide an estimate in hours of the burden of the collection of information.

Currently, there are approximately 300 dealers in the Southeast Region with active or recently expired Federal permits. There are approximately 5,800 vessels in the Southeast Region that have active or recently expired permits. In addition, the NMFS issued regulations that are effective September 7, 2002, that require all shrimp vessels fishing in the EEZ in the Gulf of Mexico to have Federal vessel permit. It was estimated in the Paperwork Reduction Act submission for approval to issue these permits that approximately 7,000 permits would be issued to shrimp vessel under these new regulations. Thus, the estimated total vessels and dealers that will have Federal permits for purposes of the electronic reporting survey is 13,100. However, an estimated 100 dealers are already reporting electronically to state fishery agencies and will not be sent the survey questionnaire.

As with most mail survey, a 100% response is highly unlikely. Without any prior knowledge of the expected response rate, we anticipate a 30% response from the fishermen and a 50% response rate from the dealers. Assuming these response rates, it is likely that 3,840 fishermen will respond and 100 dealer for a total number of respondents of 3,940.

An estimated 10 minutes will be necessary to complete the form. Thus, the total reporting burden to the public is 657 hours.

13. <u>Provide an estimate of the total annual cost burden to the respondents or record-keepers resulting from the collection.</u>

There are no anticipated costs to the public other than the time required to complete the questionnaire. The postage costs will be zero because the survey recipients will be provided with addressed, postage-paid envelopes that they will be able to use to return the completed form. They will also be able to fax the form.

14. Provide estimates of annualized cost to the Federal government.

The estimated cost to the Federal government is \$13,000 in postage, which includes the return postage fee. It is estimated that 1 month of time will be required to enter and analyze the data from the survey. The cost will be about \$3,000.

15. Explain the reasons for any program changes or adjustments reported in Items 13 or 14 of the OMB 83-I.

This is a new survey and is a program change.

Results from the data collection using the forms in this family are not planned for publication.



B. COLLECTIONS OF INFORMATION EMPLOYING STATISTICAL METHODS

The survey will be sent to every person and seafood dealer that has an active or recently expired Federal permit. As noted in #12 above, only about 1/3 of the recipients are anticipated to respond. Because we do not plan to use the survey results to estimate personal computer use for the entire population of permit holders, statistical estimation techniques will not be used. We will use the actual responses on the survey questionnaires to determine whether a certain threshold of users has and is willing to use personal computers and Internet access for electronic reporting. Although our thresholds may change, the SEFSC will probably develop methods for electronic reporting if an additional 100 dealers answer positively and at least 500 fishermen answer positively (these are not absolute thresholds, but represent what we think are reasonable targets at this time).

TITLE XVII—GOVERNMENT PAPERWORK ELIMINATION ACT

SEC. 1701. SHORT TITLE.

This title may be cited as the "Government Paperwork Elimination Act".

SEC. 1702. AUTHORITY OF OMB TO PROVIDE FOR ACQUISI-TION AND USE OF ALTERNATIVE INFORMA-TION TECHNOLOGIES BY EXECUTIVE AGEN-CIES.

Section 3504(a)(1)(B)(vi) of title 44, United States Code, is amended to read as follows:

"(vi) the acquisition and use of information technology, including alternative information technologies that provide for electronic submission, maintenance, or disclosure of information as a substitute for paper and for the use and acceptance of electronic signatures.".

SEC. 1703. PROCEDURES FOR USE AND ACCEPTANCE OF ELECTRONIC SIGNATURES BY EXECUTIVE AGENCIES.

(a) In General.—In order to fulfill the responsibility to administer the functions assigned under chapter 35 of title 44, United States Code, the provisions of the Clinger-Cohen Act of 1996 (divisions D and E of Public Law 104–106) and the amendments made by that Act, and the provisions of this title, the Director of the Office of Management and Budget shall, in consultation with the National Telecommunications and Information Administration and not later than 18 months after the date of enactment of this Act, develop procedures for the use and acceptance of electronic signatures by Executive agencies.

- (b) Requirements for Procedures.—(1) The procedures developed under subsection (a)—
- (A) shall be compatible with standards and technology for electronic signatures that are generally used in commerce and industry and by State governments;
- (B) may not inappropriately favor one industry or technology;
- (C) shall ensure that electronic signatures are as reliable as is appropriate for the purpose in question and keep intact the information submitted:
- (D) shall provide for the electronic acknowledgment of electronic forms that are successfully submitted; and
- (E) shall, to the extent feasible and appropriate, require an Executive agency that anticipates receipt by electronic means of 50,000 or more submittals of a particular form to take all steps necessary to ensure that multiple methods of electronic signatures are available for the submittal of such form.
- (2) The Director shall ensure the compatibility of the procedures under paragraph (1)(A) in consultation with appropriate private bodies and State government entities that set standards for the use and acceptance of electronic signatures.

SEC. 1704. DEADLINE FOR IMPLEMENTATION BY EXECUTIVE AGENCIES OF PROCEDURES FOR USE AND ACCEPTANCE OF ELECTRONIC SIGNATURES.

In order to fulfill the responsibility to administer the functions assigned under chapter 35 of title 44, United States Code, the provisions of the Clinger-Cohen Act of 1996 (divisions D and E of Public Law 104–106) and the amendments made by that Act, and the provisions of this title, the Director of the Office of Management and Budget shall ensure that, commencing not later than five years after the date of enactment of this Act, Executive agencies provide—

- (1) for the option of the electronic maintenance, submission, or disclosure of information, when practicable as a substitute for paper; and
 - (2) for the use and acceptance of electronic signatures, when practicable.

SEC. 1705. ELECTRONIC STORAGE AND FILING OF EMPLOY-MENT FORMS.

In order to fulfill the responsibility to administer the functions assigned under chapter 35 of title 44, United States Code, the provisions of the Clinger-Cohen Act of 1996 (divisions D and E of Public Law 104–106) and the amendments made by that Act, and the provisions of this title, the Director of the Office of Management and Budget

shall, not later than 18 months after the date of enactment of this Act, develop procedures to permit private employers to store and file electronically with Executive agencies forms containing information pertaining to the employees of such employers.

SEC. 1706. STUDY ON USE OF ELECTRONIC SIGNATURES.

- (a) Ongoing Study Required.—In order to fulfill the responsibility to administer the functions assigned under chapter 35 of title 44, United States Code, the provisions of the Clinger-Cohen Act of 1996 (divisions D and E of Public Law 104–106) and the amendments made by that Act, and the provisions of this title, the Director of the Office of Management and Budget shall, in cooperation with the National Telecommunications and Information Administration, conduct an ongoing study of the use of electronic signatures under this title on—
 - (1) paperwork reduction and electronic commerce;
 - (2) individual privacy; and
 - (3) the security and authenticity of transactions.
- (b) Reports.—The Director shall submit to Congress on a periodic basis a report describing the results of the study carried out under subsection (a).

SEC. 1707. ENFORCEABILITY AND LEGAL EFFECT OF ELEC-TRONIC RECORDS.

Electronic records submitted or maintained in accordance with procedures developed under this title, or electronic signatures or other forms of electronic authentication used in accordance with such procedures, shall not be denied legal effect, validity, or enforceability because such records are in electronic form.

SEC. 1708. DISCLOSURE OF INFORMATION.

Except as provided by law, information collected in the provision of electronic signature services for communications with an executive agency, as provided by this title, shall only be used or disclosed by persons who obtain, collect, or maintain such information as a business or government practice, for the purpose of facilitating such communications, or with the prior affirmative consent of the person about whom the information pertains.

SEC. 1709. APPLICATION WITH INTERNAL REVENUE LAWS.

No provision of this title shall apply to the Department of the Treasury or the Internal Revenue Service to the extent that such provision—

- (1) involves the administration of the internal revenue laws: or
- (2) conflicts with any provision of the Internal Revenue Service Restructuring and Reform Act of 1998 or the Internal Revenue Code of 1986.

SEC. 1710. DEFINITIONS.

For purposes of this title:

- (1) Electronic signature" means a method of signing an electronic message that—
 - (A) identifies and authenticates a particular person as the source of the electronic message; and
 - (B) indicates such person's approval of the information contained in the electronic message.
- (2) Executive Agency.—The term "Executive agency" has the meaning given that term in section 105 of title 5, United States Code.
