# SUPPORTING STATEMENT GULF OF MEXICO RED SNAPPER INDIVIDUAL FISHING QUOTA REFERENDUM DATA COLLECTION

### A. JUSTIFICATION

## 1. Explain the circumstances that make the collection of information necessary.

The legislative authority to collect data from the various sectors of the economy that harvest marine resources in the exclusive economic zone is the Magnuson-Stevens Fishery Conservation and Management Act (Act). Under this authority the Secretary of Commerce needs to properly implement the referendum procedures specified in Section 407(c) of the Act (U.S.C. 1801 et seg.). The Act provides that on or after October 1, 2000, the Gulf of Mexico Fishery Management Council (Council) may prepare and submit a fishery management plan, plan amendment, or regulation for the Gulf of Mexico commercial red snapper fishery that creates an individual fishing quota (IFQ) program or that authorizes the consolidation of licenses, permits, or endorsements that result in different trip limits for vessels in the same class. These actions can only take place if the preparation of such plan, amendment, or regulation is approved in a referendum, and only if the submission to the Secretary of such plan, amendment, or regulation is approved in a subsequent referendum. Only a person who held an annual vessel permit with a red snapper endorsement for such permit on September 1, 1996 (or any person to whom such permit with such endorsement was transferred after such date) and vessel captains who harvested red snapper in a commercial fishery using such endorsement in each red snapper fishing season occurring between January 1, 1993, and such date (i.e., September 1, 1996) may vote in the referendums.

2. Explain how, by whom, how frequently, and for what purpose the information will be used. If the information collected will be disseminated to the public or used to support information that will be disseminated to the public, then explain how the collection complies with all applicable Information Quality Guidelines.

The Secretary will use the data as needed to properly conduct these referendums. The Secretary has sufficient data, collected under OMB approval 0648-0205, needed to contact persons who held an annual vessel permit with a red snapper endorsement for such permit on September 1, 1996 (or any person to whom such permit with such endorsement was transferred after such date). However, the Secretary does not have such data on the vessel captains who harvested red snapper in a commercial fishery using such endorsement in each specified fishing season. Therefore, the Secretary will use several communication methods to attempt to identify such captains and make them aware of the referendum procedures. One possible communication method that involves data collection would be a request for detailed information from persons with a vessel permit with a red snapper endorsement, regarding vessel captains who harvested red snapper using such endorsement in each specified fishing season.

Prior to each referendum, the Secretary, in consultation with the Council, will (a) identify and notify all such persons holding permits with red snapper endorsements and all such vessel captains; and (b) make available to all such persons and vessel captains information about the schedule, procedures, and eligibility requirements for the referendum and the proposed IFQ program.

The exact details of the schedule, procedures, and eligibility requirements are unknown at this time, but will be determined via the Council process prior to the second referendum. The IFQ program is expected to utilize percentage shares of the annual commercial quota, which equate to an IFQ based on each participant's share. Submission of the paper questionnaires is voluntary.

It is anticipated that the information collected will be disseminated to the public or used to support publicly disseminated information. As explained in the preceding paragraphs, the information gathered has utility. NOAA Fisheries will retain control over the information and safeguard it from improper access, modification, and destruction, consistent with NOAA standards for confidentiality, privacy, and electronic information. See response #10 of this Supporting Statement for more information on confidentiality and privacy. The information collection is designed to yield data that meet all applicable information quality guidelines. Prior to dissemination, the information will be subjected to quality control measures and a pre-dissemination review pursuant to Section 515 of Public Law 106-554.

# 3. <u>Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological techniques or other forms of information technology.</u>

The Southeast Region currently has no resource or technological capability for electronic (i.e., Web site) collection of this data. This capability cannot be accomplished in the Southeast Region without significant changes to data collection processes, which are impracticable in the short time frame needed to properly conduct the referendum as requested by the Council.

### 4. Describe efforts to identify duplication.

NOAA Fisheries is confident that it is aware of similar collections if they exist. The information proposed to be collected is not being collected elsewhere; therefore, this data collection would not cause duplication.

# 5. <u>If the collection of information involves small businesses or other small entities, describe the methods used to minimize burden.</u>

Because all respondents are considered small businesses, separate requirements based on size of business have not been developed. Only the minimum data to meet the current and future needs of NOAA Fisheries' fisheries management are requested under this collection.

# 6. Describe the consequences to the Federal program or policy activities if the collection is not conducted or is conducted less frequently.

If the collection is not conducted or is conducted less frequently, the Secretary cannot properly implement the referendum procedures specified in Section 407(c) of the Act. This would, in turn, prevent proper management of the red snapper fishery as intended by the Council.

# 7. Explain any special circumstances that require the collection to be conducted in a manner inconsistent with OMB guidelines.

There are no special circumstances that require the collection to be conducted in a manner inconsistent with OMB guidelines.

8. Provide a copy of the PRA Federal Register notice that solicited public comments on the information collection prior to this submission. Summarize the public comments received in response to that notice and describe the actions taken by the agency in response to those comments. Describe the efforts to consult with persons outside the agency to obtain their views on the availability of data, frequency of collection, the clarity of instructions and recordkeeping, disclosure, or reporting format (if any), and on the data elements to be recorded, disclosed, or reported.

A Federal Register Notice (copy attached) solicited public comment on this data collection. No comments were received.

All aspects of this data collection program were considered by the Council. Furthermore, comments and suggestions from fishermen are routinely submitted, reviewed, and considered as part of the Council process. Experience with this process, provides a continual feedback mechanism to NOAA Fisheries on issues and concerns to the respondents. The IFQ concept did not raise an unusual amount of controversy during the Council development process. There are no major problems that have not been resolved.

# 9. Explain any decisions to provide payments or gifts to respondents, other than remuneration of contractors or grantees.

There are no payments or other remunerations to respondents.

# 10. Describe any assurance of confidentiality provided to respondents and the basis for assurance in statute, regulation, or agency policy.

All data that are submitted are treated as confidential in accordance with NOAA Administrative Order 216-100.

# 11. <u>Provide additional justification for any questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private.</u>

No questions of a sensitive nature are asked.

### 12. Provide an estimate in hours of the burden of the collection of information.

The estimated number of respondents is 200. The number of responses is 200 for the initial referendum on preparation; 200 for the subsequent referendum; and 12 for an information request regarding vessel captains. The estimated time per response is 10 minutes for a response to an initial referendum on preparation; 20 minutes for a response to a subsequent referendum; and 10 minutes per response for any information request regarding vessel captains. The estimated total annual burden hours, therefore, is 102.

# 13. Provide an estimate of the total annual cost burden to the respondents or record-keepers resulting from the collection.

No fee is charged for each response submitted. However, the public pays mailing costs for the various responses. Those mailing costs are estimated at \$.37 average per each of the 412 responses. Therefore, the estimated total annual cost to the public is \$152.

# 14. Provide estimates of annualized cost to the Federal government.

The administrative costs for the data collection are paid by the fishermen. As a result, there is no cost to the Federal government.

# 15. Explain the reasons for any program changes or adjustments reported in Items 13 or 14 of the OMB 83-I.

The changes in burden hours and costs are program changes resulting from the referendum procedures.

# 16. For collections whose results will be published, outline the plans for tabulation and publication.

The results from this collection are not planned for statistical publication.

### -STATUTE-

- (a) Independent peer review
- (1) Within 30 days of October 11, 1996, the Secretary shall initiate an independent peer review to evaluate -
  - (A) the accuracy and adequacy of fishery statistics used by the Secretary for the red snapper fishery in the Gulf of Mexico to account for all commercial, recreational, and charter fishing harvests and fishing effort on the stock;
  - (B) the appropriateness of the scientific methods, information, and models used by the Secretary to assess the status and trends of the Gulf of Mexico red snapper stock and as the basis for the fishery management plan for the Gulf of Mexico red snapper

# fishery;

- (C) the appropriateness and adequacy of the management measures in the fishery management plan for red snapper in the Gulf of Mexico for conserving and managing the red snapper fishery under this chapter; and
- (D) the costs and benefits of all reasonable alternatives to an individual fishing quota program for the red snapper fishery in the Gulf of Mexico.
- (2) The Secretary shall ensure that commercial, recreational, and charter fishermen in the red snapper fishery in the Gulf of Mexico are provided an opportunity to -
  - (A) participate in the peer review under this subsection; and
  - (B) provide information to the Secretary concerning the review of fishery statistics under this subsection without being subject to penalty under this chapter or other applicable law for any past violation of a requirement to report such information to the Secretary.
- (3) The Secretary shall submit a detailed written report on the findings of the peer review conducted under this subsection to the Gulf Council no later than one year after October 11, 1996.

## (b) Prohibition

In addition to the restrictions under section 1853(d)(1)(A) of this title, the Gulf Council may not, prior to October 1, 2002, undertake or continue the preparation of any fishery management

plan, plan amendment or regulation under this chapter for the Gulf of Mexico commercial red snapper fishery that creates an individual fishing quota program or that authorizes the consolidation of licenses, permits, or endorsements that result in different trip limits for vessels in the same class.

# (c) Referendum

- (1) On or after October 1, 2002, the Gulf Council may prepare and submit a fishery management plan, plan amendment, or regulation for the Gulf of Mexico commercial red snapper fishery that creates an individual fishing quota program or that authorizes the consolidation of licenses, permits, or endorsements that result in different trip limits for vessels in the same class, only if the preparation of such plan, amendment, or regulation is approved in a referendum conducted under paragraph (2) and only if the submission to the Secretary of such plan, amendment, or regulation is approved in a subsequent referendum conducted under paragraph (2).
- (2) The Secretary, at the request of the Gulf Council, shall conduct referendums under this subsection. Only a person who held an annual vessel permit with a red snapper endorsement for such permit on September 1, 1996 (or any person to whom such permit with such endorsement was transferred after such date) and vessel captains who harvested red snapper in a commercial fishery using such endorsement in each red snapper fishing season occurring between January 1, 1993, and such date may vote in a referendum under this subsection. The referendum shall be decided by a

majority of the votes cast. The Secretary shall develop a formula to weigh votes based on the proportional harvest under each such permit and endorsement and by each such captain in the fishery between January 1, 1993, and September 1, 1996. Prior to each referendum, the Secretary, in consultation with the Council, shall

- (A) identify and notify all such persons holding permits with red snapper endorsements and all such vessel captains; and
- (B) make available to all such persons and vessel captains information about the schedule, procedures, and eligibility requirements for the referendum and the proposed individual fishing quota program.

# (d) Catch limits

Any fishery management plan, plan amendment, or regulation submitted by the Gulf Council for the red snapper fishery after October 11, 1996, shall contain conservation and management measures that -

- (1) establish separate quotas for recreational fishing (which, for the purposes of this subsection shall include charter fishing) and commercial fishing that, when reached, result in a prohibition on the retention of fish caught during recreational fishing and commercial fishing, respectively, for the remainder of the fishing year; and
  - (2) ensure that such quotas reflect allocations among such

sectors and do not reflect any harvests in excess of such allocations.

NOAA proposes to collect censuslevel information on fishing vessel and gear characteristics in the Gulf of Mexico shrimp fishery (Exclusive Economic Zone only) to conduct economic analyses that will improve fishery management decision-making in that fishery; satisfy NOAA's legal mandates under Executive Order 12866, the Magnuson-Stevens Fishery Conservation and Management Act (U.S.C. 1801 et seq.), the Regulatory Flexibility Act, the Endangered Species Act, and the National Environmental Policy Act; and quantify achievement of the performance measures in the National Marine Fisheries Service Strategic Operating Plans. Used in conjunction with landings and price data already being collected in this fishery as part of the dealer reporting program, and economic data to be collected under a voluntary program (implementation of which is expected later this year), this data will be used to properly describe the fishery and its operations. The collected information will also help to assess how fishermen will be impacted by and respond to any regulation likely to be considered by fishery managers. In addition, this data will be used to determine how fishing communities will be impacted by proposed fishing regulations.

The vessel and gear characterization form will be mailed to all vessel owners who either currently have or who apply for Gulf of Mexico federal shrimp permits. Vessel owners will be asked for information about the nature and extent of their operations in the Gulf shrimp fishery, as well the types of electronic equipment and gear they use to conduct this fishery. Submission of a completed

vessel and gear characterization form would be mandatory.

This data collection is needed for the Secretary of Commerce (Secretary) to properly implement the referendum procedures specified in Section 407(c) of the Magnuson-Stevens Fishery Conservation and Management Act (U.S.C. 1801 et seq.). The Act provides that on or after October 1, 2000, the Gulf of Mexico Fishery Management Council (Council) may prepare and submit a fishery management plan, plan amendment, or regulation for the Gulf of Mexico commercial red snapper fishery that creates an individual fishing quota (IFQ) program or that authorizes the consolidation of licenses, permits, or endorsements that result in different trip limits for vessels in the same class. These actions can only take place if the preparation of such plan, amendment, or regulation is approved in a referendum, and only if the submission to the Secretary of such plan, amendment, or regulation is approved in a subsequent referendum.

Only a person who held an annual vessel permit with a red snapper endorsement for such permit on September 1, 1996 (or any person to whom such permit with such endorsement was transferred after such date) and vessel captains who harvested red snapper in a commercial fishery using such endorsement in each red snapper fishing season occurring between January 1, 1993, and such date (i.e., September 1, 1996) may vote in the referendums.

#### **II. Method of Collection**

The Secretary, at the request of the Council, will conduct these referendums. The Secretary has sufficient data, collected under OMB approval 0648-0205, needed to contact persons who held an annual vessel permit with a red snapper endorsement for such permit on September 1, 1996 (or any person to whom such permit with such endorsement was transferred after such date). However, the Secretary does not have such data on the vessel captains who harvested red snapper in a commercial fishery using such endorsement in each specified fishing season. Therefore, the Secretary will use several communication methods to attempt to identify such captains and make them aware of the referendum procedures. One possible communication method that involves data collection would be a request for detailed information from persons with a vessel permit with a red snapper endorsement, regarding vessel captains who harvested red snapper using such endorsement in each specified fishing

Prior to each referendum, the Secretary, in consultation with the Council, shall (a) identify and notify all such persons holding permits with red snapper endorsements and all such vessel captains; and (b) make available to all such persons and vessel captains information about the schedule, procedures, and eligibility requirements for the referendum and the proposed individual fishing quota program. Submission of the paper questionnaires would be voluntary.
