
FEDERAL HOUSING FINANCE BOARD

RESOLVED, That the action of the board of directors of the Federal Home Loan Bank of New York, at a meeting on October 19, 1989 in electing Brian D. Dittenhafer as President, is hereby approved; and

RESOLVED, That the President's salary for calendar year 1990 is approved in the amount of \$220,000; and

BE IT FURTHER RESOLVED, That in keeping with the policy to maintain the Bank presidents' salaries at the 1989 level, any proposal by a bank's board of directors to award incentive compensation payment for 1990 to a Bank president is subject to prior approval by the Federal Housing Finance Board.
