Memphis, Tennessee


WHEREAS, the Federal Housing Finance Board ("Finance Board") has considered a recommendation from the Federal Home Loan Bank of Cincinnati to approve the membership application submitted by National Bank of Commerce, Memphis, Tennessee; and

WHEREAS, the Finance Board concurs with the recommendation and agrees that National Bank of Commerce meets the eligibility criteria for membership in the Federal Home Loan Bank;

FURTHER RESOLVED, that National Bank of Commerce, Memphis, Tennessee is thereby granted the full rights and privileges of a member in the Federal Home Loan Bank System.
