The hearing shall include oral testimony and cross-examination in the discretion of the Presiding Officer only upon proper showing that there are genuine issues of material fact that cannot be resolved on the basis of sworn statements, affidavits, deposit ons, or other documents or that the nature of the matter in issue is such that an oral hearing and cross-examination are necessary for the development of an adequate record. Fursuant to the further terms of 48 CFR 502.61, the initial decision of the Presiding Officer in this proceeding shall be issued by August 9. 1993, and the final decision of the Commission shall be issued by December 7, 1993.
