1994 Appointment of the President -
Federal Home Loan Bank of Boston

WHEREAS, pursuant to 12 U.S.C. Section 1432 (Supp. I, 1989) the Federal Housing Finance Board (Finance Board) shall approve the compensation for Federal Home Loan Bank (FHLBank) Presidents; and

WHEREAS, the Finance Board has considered the action of the board of directors of the FHLBank of Boston, to appoint Michael A. Jessee as its President for the period commencing January 1, 1994 and ending December 31, 1994; and

WHEREAS, having reviewed the recommendation of the board of directors of the FHLBank of Boston regarding the President's salary for 1994, and following full deliberation of the facts;

'NOW THEREFORE, RESOLVED, that the appointment of Michael A. Jessee as the President of the FHLBank of Boston for the period indicated is approved; and

FURTHER RESOLVED, that the President's salary in the amount of \$240,000 for the same period is approved; and

FURTHER RESOLVED, that any compensation for the President, beyond that approved herein, whether direct or indirect, or whether payable during the current period or in future periods, is subject to prior written approval by the Finance Board.
