What is e-Services?

- Suite of products designed for tax professionals and taxpayers to do business with IRS electronically
- Includes:
 - Registration
 - *e-file* Application
 - Preparer Tax Identification Number (PTIN) Application
 - Tax Identification Number (TIN) Matching Application
 - *e-filing* “Incentive” Products
- Accessed through a secure environment known as the “**Registered User Portal (RUP)**”

Why do I have to register?

- Doing business as an individual representing yourself or your corporation
- IRS needs to authenticate you
- Authentication achieved by:
 - Providing “shared secrets” to corroborate your identity (combination of name, Social Security Number, Date of Birth and Adjusted Gross Income from current or one previous tax year)
 - Further authentication by mailing a registration confirmation number to your official IRS address of record (from your latest return filed)

- Click on the “e-Services” link under “the Tax Professionals” box
- Click the “Not yet registered?” link

Your Electronic Alternatives to Filing Paper Returns

IRS e-file Options For:

Individual Taxpayers	File your 2008 Individual Income Tax Return electronically (available through October 15, 2009). You can file online for free through the Free File program.
Business and Self-Employed Taxpayers	Electronic filing and payment options for businesses including employment taxes, information returns, partnerships, corporations, and estates & trusts.
Large Corporations	Information for Modernized e-File (MeF) program for partnership returns, Forms 1065/1065-B. Large corporations are required to electronically file their Forms 1120 and 1120-S, while small businesses are required to file their Forms 1120 and 1120-S electronically. Information for corporations who prepare and transmit their returns through the services of third-party tax professionals.
Tax Professionals	IRS e-file information for tax professionals. Several online e-services products are available including the electronic IRS e-file application. Includes information on the new Modernized e-File (MeF) program for filing partnership returns electronically.
Charities and Non-Profits	Electronic filing options for tax-exempt organizations. New requirements mean large tax-exempt organizations are now required to e-file their returns.
Excise Tax Filers	Legislation now requires filers of certain Excise Forms to file their returns electronically.
e-file Software Developers and Transmitters	For individual and business e-file programs. Includes XML schemas - downloadable zipped files and other useful information for e-file software developers and transmitters.

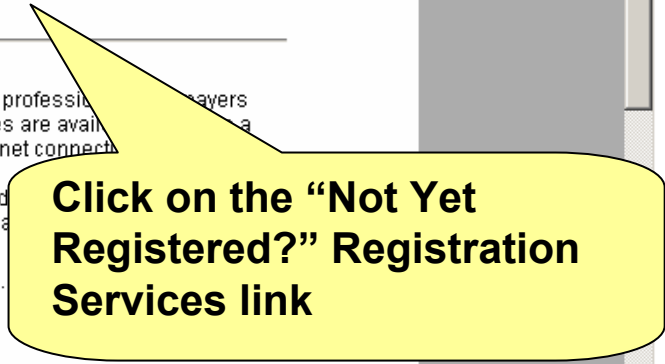

Here you can register to become a user of the e-services web site. Our registration process involves collecting personal and taxpayer data for the sole purpose of authenticating your identity. The IRS will compare the information you provide with the information received from the Social Security Administration (SSA) and with the tax return information you previously filed. We will issue a registration confirmation code to you via the U.S. Postal Service, if the information you provide matches our data. You must log back into the e-services web site within 28 days of your registration submission and enter this confirmation code to complete the registration process.

We ask you to provide the following information to become a registered user:

- Legal name (verified with IRS & SSA records)
- Social Security Number (verified with SSA records)
- Date of birth (verified with SSA records)
- Telephone number
- E-mail address
- Adjusted Gross Income (AGI) from either your current year or prior year filed tax return (verified from IRS records)
- Username. Select your preferred username. Please read the rules for selecting your username

We may give the information to the Department of Justice and to other Federal agencies, as provided by law. We may also give it to cities, states, the District of Columbia and U. S. commonwealths or possessions to carry out their tax laws. We may give it to foreign governments because of tax treaties they have with the United States. Your participation in the e-services program is voluntary. As such, your responses to any of the registration questions are entirely voluntary. However, if you do not provide all or part of the information required to create your account and authenticate your identity, you will not be eligible for access to e-services.

Paperwork Reduction Act Notice:

The collection of information contained in e-services has been reviewed and approved by the Office of Management and Budget in accordance with the Paperwork Reduction Act (44 U.S.C. 3507) under control number 1545-1823. Your Registration Obligations:

As an e-services user, you agree to provide true, accurate, current and complete information about yourself as prompted by the registration process and that you will maintain and promptly update this data to keep it true, accurate, current and complete. If you provide any information that is untrue, inaccurate, obsolete or incomplete, or there are reasonable grounds to suspect that such information is untrue, inaccurate, obsolete or incomplete, the IRS has the right to suspend or terminate your account and refuse any and all current or future use of e-services.

Member Account, Password and Security:

As part of the registration process, you selected a username, password and PIN. You are responsible for maintaining the confidentiality of this information. While it may be necessary to disclose your username or PIN to an IRS employee or other individual, you agree not to disclose your password to anyone. You are fully responsible for all activities that occur under your password. IRS personnel do not have access to your password and should never ask you for it. You agree to immediately notify the IRS at 1-866-255-0654 (international callers use 512-416-7750) of any unauthorized use of your password or account, or any other breach of security and ensure that you exit from your account at the end of each session.

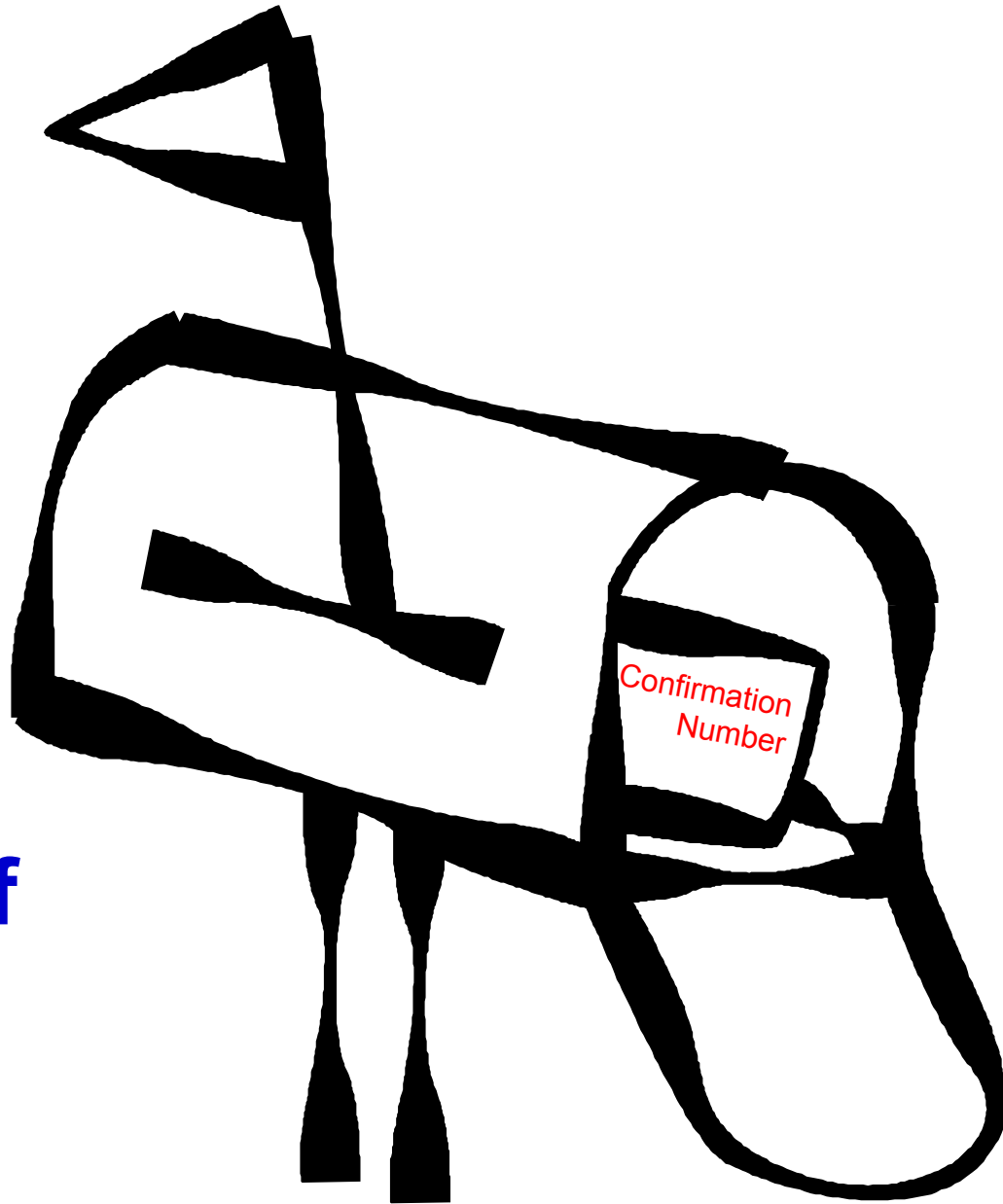

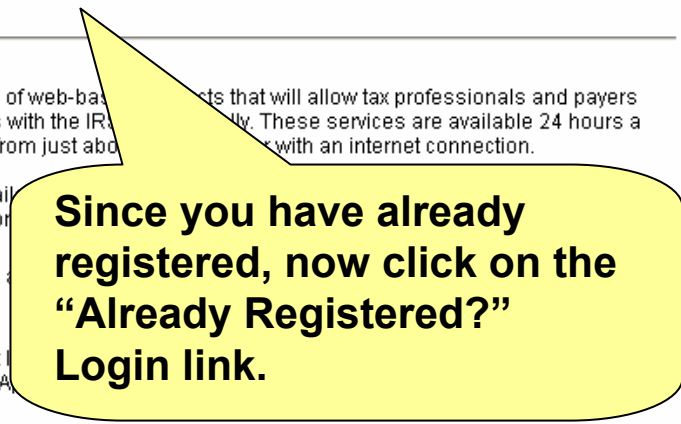

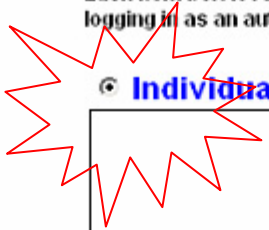

Welcome to Registration Services

Registration

Here you can register to become a user of e-services. The registration process involves collecting personal information and authenticating your identity. The IRS will compare the information received from the Social Security Administration with the information you provide to verify your identity. We will issue a registration confirmation code if the information you provide matches our data. You must log back into e-services after your registration submission and enter this code.

We ask you to provide the following information:

- Legal name (verified with IRS & SSA records)
- Social Security Number (verified with SSA records)
- Date of birth (verified with SSA records)
- Telephone number
- E-mail address
- Adjusted Gross Income (AGI) from the previous year (verified from IRS records)
- Username. Select your preferred username.
- Password and PIN. Select your preferred password and PIN. It must be secure, unique password and PIN.
- Reminder question to recover a forgotten password or PIN.
- Home mailing address (verified from IRS records). If you have moved since you last filed with the IRS, please update your information.

Please have this information available before you register.

Confirm Registration

Select this option to enter the confirmation code you received from the IRS. You should only have to complete this process once within 28 days of registering (if you ever forget your password or PIN, you will need to repeat this process).

Revise Registration

Selecting this option will allow you to revise the following information in your Registration record:

Selecting this option will allow you to revise the following information in your Registration record:

- Telephone number
- Address
- E-mail address

Change Password/PIN

Use this option to change your password, PIN, or both.

Forgotten Password or PIN

If you have lost your password or PIN you will need to repeat a portion of the initial registration process and will be issued a new confirmation code via the U.S. Postal Service. You must then log back into e-services within 28 days and confirm your registration using this new confirmation code.

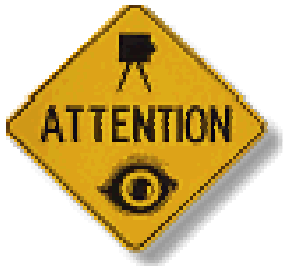
Enter the 12-character confirmation number (combination of letters and numbers) you received in the mail from IRS.

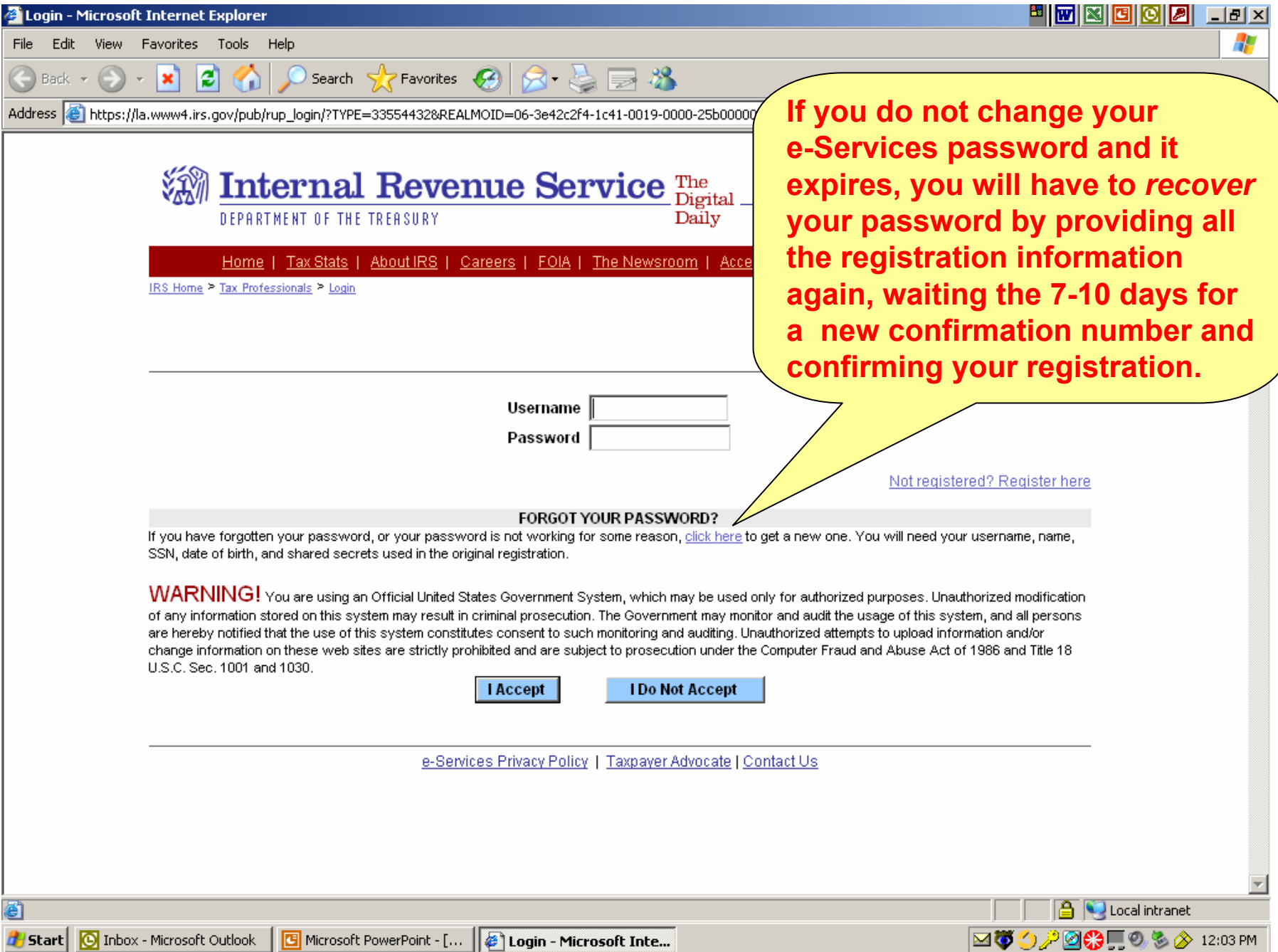
For security reasons, e-Services passwords expire every 180 days.



15 days prior to expiration of your e-Services password, the system will advise you when you log in.

10 days prior to expiration of your e-Services password, IRS will send you an e-mail advising that your e-Services' password will expire in 10 days.

Set your own reminder to log in to e-Services and change your password if you did not provide an e-mail address during registration.



If you do not change your e-Services password and it expires, you will have to *recover* your password by providing all the registration information again, waiting the 7-10 days for a new confirmation number and confirming your registration.

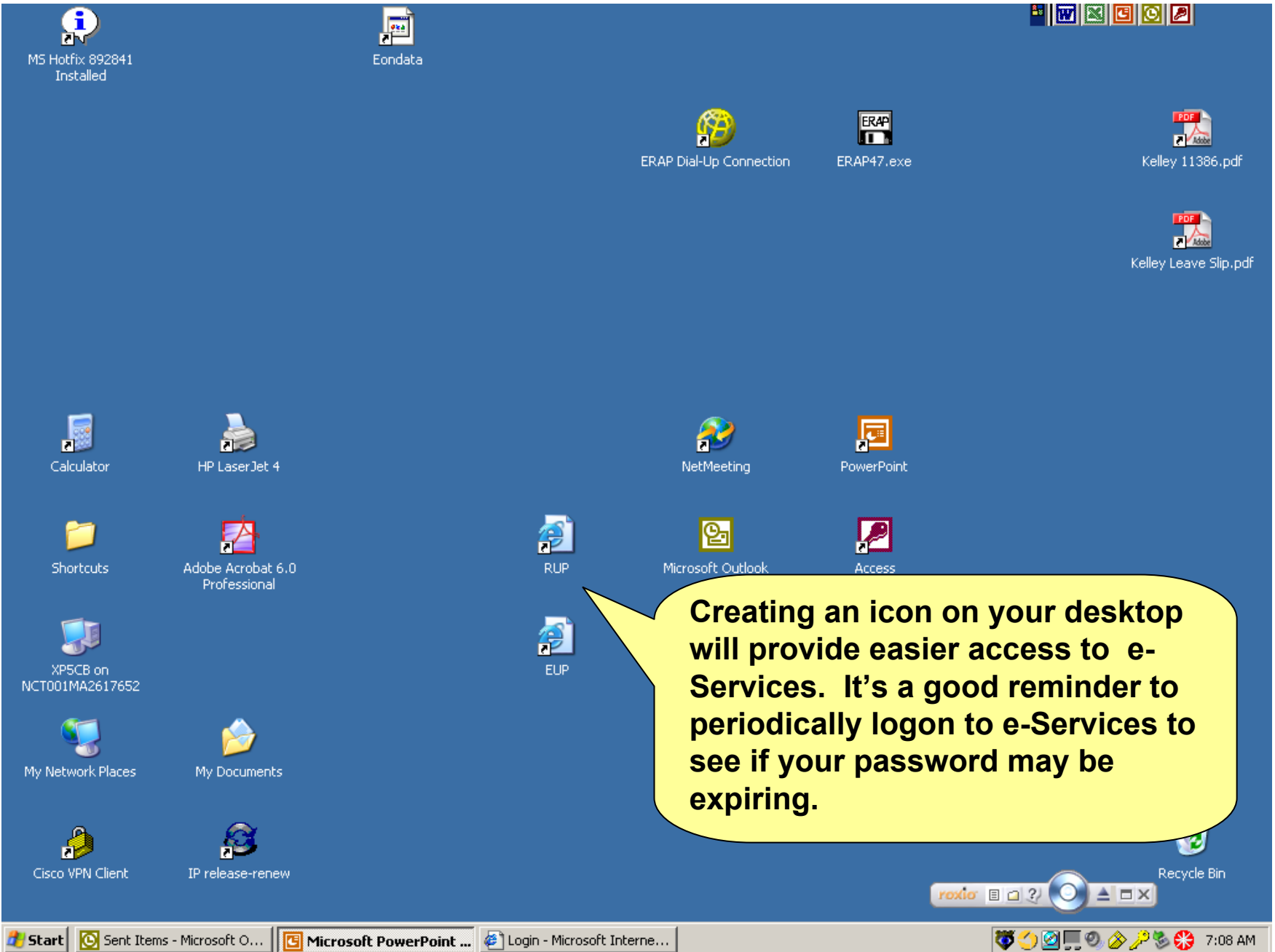

Registration Summary

- Registration is a one-time authentication of you as an individual that allows you to do business with IRS electronically
- Confirm your registration within 28 days of the initial registration
- Reset your password when prompted by the system when you log in or by an e-Services e-mail (or set a reminder if you don't have e-mail)
- Keep your Username, Password, Recovery Question and PIN in a secure location and do not share this information.
