### **Drivers for LAPPs**

- Section 303 A of the MSRA authorized expanded use of LAPPs
- National Standard 8
- Market-based fishery management programs supported by the U.S. Commission on Ocean Policy
- Administration Goal to double the number of such programs, from 8 to 16, by 2011



### Value of LAPP-Managed Fisheries

- The estimated value of fisheries utilizing marketbased programs in 2006 was \$689.3M.
  - —This value will increase by \$18.0M in 2007
  - —With the addition of another estimated \$143.5M in 2011, a total of \$850.8M, or over one-fifth of the current ex-vessel value of U.S. fisheries, will be managed under LAPP programs
- Fishermen in LAPP managed fisheries have enjoyed higher profits, lower costs, longer fishing seasons, and a safer more stable industry.



# **LAPP Implementation Goal/ Funding Status**

NMFS is on track to meet the goal of doubling the number of LAPPs (from 8 to 16), provided that the \$6.0 million requested in the FY09 and subsequent budgets are funded.

At the end of FY2008, 12 LAPP programs were implemented.

Note: Because only \$1.2M was provided in FY08 for LAPPs, the original target of 16 LAPPs by 2010 was delayed by one year.
