

Day Ahead/Real Time Guidance

REPORTING DAY AHEAD vs. REAL TIME SALES ON THE EQR

- List energy sold in the DAM as energy sales at the day-ahead price.
- List energy reported on the hourly settlement statement as balancing or RTM transactions as energy at the real time price.

Example 1:

Company A sells 100 MWh of energy into the PJM day ahead market during Hour 14 of July 23rd. The price is \$50 per MWh. When that hour arrives, Company A supplies 110 MWh (for a net change from the DAM commitment of +10 MWh). The price in the Real Time Market for the hour is \$60 per MWh.

Company A would report:

Example 2:

Company B sells 100 MWh of energy into the PJM day ahead market during Hour 14 of July 23rd. The price is \$50 per MWh. When that hour arrives, Company B supplies 90 MWh (for a net change from the DAM commitment of -10 MWh). The price in the Real Time Market for the hour is \$60 per MWh.

Company B would report:

Example 3:

Company C sells 100 MWh of energy into the PJM day ahead market as a sale during Hour 14 of July 23rd. The price is \$50 per MWh. When that hour arrives, the price in the Real Time Market for the hour is \$60 per MWh. Company C would report:
