BULK PURCHASE AGREEMENT FORM - 2004

QUALIFYING CRITERIA

To become a Registered Bulk Purchaser, an applicant must:

- 1. have worked as a reputable, full-time coin dealer for at least five years,
- 2. possess a current business license and/or state resale number, and
- 3. have completed and signed both a "Bulk Purchase Agreement Form 2004" and a "Bulk Purchase Registration Form 2004" which have been forwarded to and accepted by the United States Mint.

TERMS AND CONDITIONS

- 1. Orders will qualify for a 5% discount for qualifying products only after the United States Mint has accepted the Applicant's "Bulk Purchase Agreement Form 2004" and "Bulk Purchase Registration Form 2004." No order will qualify retroactively.
- 2. Any order for less than \$5,000 retail price will not qualify for the discount. The discount will be applied only to available products listed on the United States Mint's "Bulk Purchase Order Form" as of the time the order is placed. An order may combine any assortment of available products listed on the current "Bulk Purchase Order Form" to meet the \$5,000 minimum purchase requirement.
- 3. To cover shipping and handling charges, Registered Bulk Purchasers will be assessed the following percentages of the retail value of their order: 1% for domestic orders and 2% for international orders.
- 4. Orders placed through this program will be shipped only to a single location and only to the location listed on the "Bulk Purchase Registration Form 2004."
- 5. Registered Bulk Purchasers are required to use the same assigned customer account number for all orders. Orders may only be sent to the United States Mint Bulk Purchase Program's special mail, fax or e-mail address as set forth on the order form. Orders not sent to the United States Mint's Bulk Purchase Program's addresses listed on the order form will not qualify for the discount.
- 6. A Registered Bulk Purchaser may display United States Mint point-of-purchase signage provided by the United States Mint. Such signage shall not be reproduced, altered or modified in any way.
- 7. This program does not limit the United States Mint's authority to offer other discounts or to exempt certain products from the Bulk Purchase Program in the future.
- 8. As a condition of participating in this program, a Registered Bulk Purchaser agrees that products purchased through this program may not be advertised for retail sale at prices less than the United States Mint's current retail price for the same product.
- 9. A Registered Bulk Purchaser may not advertise any relationship or connection with the United States Mint. Participation in this program does not make or imply any "distributorship" or "authorized purchaser" status, or any other status or relationship with the United States Mint. Failure to follow this provision may cause the United States Mint, in its sole discretion, to cancel any company's participation in this program without notice.

- 10. Ordering terms: Bulk Purchase orders are not valid until accepted by the United States Mint. You may cancel your order at any time prior to United States Mint processing. If for any reason, within 30 days of receiving your product, you are dissatisfied with your purchase, return the entire product for refund or replacement. The United States Mint reserves the right to limit quantities and may discontinue accepting orders for any product at any time. The United States Mint reserves the right to accept or reject orders in any combination or option(s) it determines to be in its best interest. In the event a particular product is sold out, the United States Mint reserves the right to either process partial orders and make refunds, or return orders in their entirety.
- 11. This agreement and any dispute thereunder shall be governed by and construed only under Federal Law. The United States Mint reserves the right to alter, modify and/or change this agreement or the terms thereof at any time provided notice of the change or modification is provided to the then current Registered Bulk Purchasers prior to the effective date of such modification. The effective date of such change or modification will be 15 days after receipt of any notice of change or alteration of the program's terms and conditions, unless the Registered Bulk Purchaser has sent the United States Mint Bulk Purchase Program written notice of their with drawal from the United States Mint's "Bulk Purchase Agreement."
- 12. The United States Mint has the right to terminate the Bulk Purchase Program or change program criteria at its discretion, at any time and without advance notice. The United States Mint has the right to terminate this Agreement for good cause at any time, without advance notice.
