On February 25, 2009, the House Budget Committee adjusted the 302(a) allocation for the House Appropriations Committee pursuant to Sec. 301(c) of S. Con. Res 70, increasing the allocation by \$968 million in budget authority and \$892 million in outlays, for a total of \$1,012,686 million in budget authority and \$1,107,004 in outlays. The Appropriations Committee has not yet revised their 302(b) allocation.
