Amendment Number Three (3)

1. EDUCAUSE shall not institute any deletion of inactive registrations during a technical transition of the .edu registry functions or during critical school administrative time periods, including, but not limited to, student registration.
2. EDUCAUSE shall certify to the Grants Officer thirty (30) days prior to the removal of any inactive registration from the .edu registry that it has taken all reasonable steps to notify each .edu registrant institution of its efforts to improve the accuracy of the .edu WHOIS database, including the possibility of removal of all inactive registrations, pursuant to EDUCAUSE's proposal. This certification shall include a list of all names scheduled to be deleted as well as detailed information regarding efforts to notify each affected institution on a per name basis, including but not limited to data, name and method of contact.
3. Approval of this proposal is limited to a one-time implementation to be completed during calendar year 2003.
