## RESPIRATOR USER'S NOTICE

**Subject: Revocation of NIOSH Certificate of Approvals for Various Sellstrom Manufacturing Company Respirators**

The National Institute for Occupational Safety and Health (NIOSH or the Institute) wishes to inform respirator users that the NIOSH certificates of approval for the following Sellstrom Manufacturing Company's particulate filtering respirators listed in Table 1 have been revoked effective August 1, 2005.

The Institute has revoked these certificates of approval because of the respirator’s failure to meet the performance requirements of Title 42, *Code of Federal Regulations*, Part 84 (42 CFR 84). On January 16, 2004, during product audit testing conducted at the Institute, Sellstrom Manufacturing Company’s model 2080X (TC-84A-1789) particulate filtering respirator using part number 20030 P100 filter failed the Dioctyl Phthalate (DOP) P100 test. The P100 filter is a component of all the respirators that have had NIOSH approval revoked.

Revocation of approval means that the Sellstrom Manufacturing Company’s Model 2080X particulate filtering respirator identified above will no longer be listed as NIOSH-approved respirators. Revocation also means that respirators bearing these approval numbers may no longer be manufactured, assembled, sold, or distributed.

Table 2 represents those respirators manufactured by Sellstrom Manufacturing where NIOSH approvals are obsolete. Obsolete respirators may continue to be used while they are in operating order. However, the obsolete classification informs users that the product is no longer supported by the manufacturer and replacement parts may not be available.
