






Impact of U.S. Petroleum Imports

Impact of U.S. Petroleum Imports






Trade Percentage of U.S. Economy

U.S. Goods Exports by Market





U.S. Goods Imports by Market










Top Sectors in Merchandise Trade





Percent of U.S. Exports, 2006


