Seasonally adjusted estimates for 56pt are obtained indirectly by summing the seasonally adjusted estimates for 5613, 5615, and 562 and the not seasonally adjusted estimate for 561pt \*. Direct seasonal adjustment factors are provided for 56 pt in this table and may be used to approximate the published seasonally adjusted estimates at this level.
