# **2008 Annual Building Permits**

### **New Residential Construction**

During 2008, local building permit offices in the 20,000-place universe authorized the construction of 905,359 new privately-owned housing units with a total valuation of \$141.6 billion. This was 1.4 percent above the preliminary annual estimate of 892,771 housing units, and is the lowest number of authorizations since Census began the survey in 1959.

In 2008, multi-family units (5 units or more) accounted for over half of the total number of housing units authorized in the following states:
