HOWEVER, THE PURPORTED 4000-TON ANNUAL PRODUCTION LISTED IS FULLY 1000 TONS MORE THAN THE MINING COMPANIES CLAIM TO HAVE PRODUCED IN 2001.

PRESSING THE GON FOR ASSURANCES NOW

2. (S/NF) AMBASSADOR MET WITH FORMIN MINDAOUDOU ON FEBRUARY 18 AND -- WITHOUT ANY REFERENCE TO REF A -- ASKED FOR AN UNEQUIVOCAL ASSURANCE THAT NIGER HAS STUCK TO THE COMMITMENT THEN PRESIDENT-ELECT TANDJA MADE TO U/S

PICKERING IN DECEMBER 1999 NOT TO SELL URANIUM TO ROGUE STATES (REF B). AMBASSADOR LINKED HER QUESTION TO HEIGHTENED USG SECURITY CONCERNS AND TO A COMMENT BY PRIME MINISTER HAMA AMADOU LAST FALL (REF C). FORMIN PROMISED TO SEEK THE ASSURANCES THE AMBASSADOR REQUIRED AND TO RAISE THE ISSUE THE SAME DAY WITH PRESIDENT TANDJA. ON SEPTEMBER 10, 2001 THE PM TOLD US THAT THERE WERE BUYERS LIKE IRAQ WHO WOULD PAY MORE FOR NIGER'S URANIUM THAN FRANCE. HAMA AMADOU QUICKLY ADDED THE COMMENT "OF COURSE NIGER CANNOT SELL TO THEM." THAT DID NOT DEFLECT OUR IMMEDIATE, STRONGLY WORDED WARNING THAT ANY SUCH SALE WOULD BE WRONG AND DISASTROUS FOR NIGER'S RELATIONS WITH THE USG AND OTHERS.

3. (S/NF) IN MEETINGS ON OTHER ISSUES TODAY, FEBRUARY 19
(SEPTEL), FIRST WITH THE FORMIN ALONE AND THEN WITH THE

RAISE THE URANIUM ISSUE, NOR PROVIDE THE ASSURANCES

SHOULD SOMETHING LIKE THIS BE ONGOING OR CONTEMPLATED, WE NEED TO SQUASH IT RIGHT AWAY.
