Introduction

The National Renewable Energy Laboratory (NREL) routinely subcontracts for minor construction work to support research activities and to incorporate health and safety improvement for the NREL facilities. The general requirements for these projects are described below. The specific work requirements shall be fully described in an individual task order. A Construction Task Ordering Agreement (TOA) will enable NREL to obtain the resources and materials required to complete specific tasks in a timely and effective manner.

Objective

NREL is seeking firms to provide complete construction services to accomplish a variety of tasks at NREL including:

- Equipment relocations,
- Building alterations,
- System alterations,
- Repairs,
- Minor construction tasks.

Work is to be performed accordance with applicable codes and standards in force at the time of work.

The work to be performed comprises the construction described in the individual task orders and documents, and shall include all labor, materials, transportation, equipment, and supplies necessary to complete the project.
