Introduction

Integral to the Department of Homeland Security (DHS) performance management are the program evaluations that occur in collaboration with the Office of Management and Budget (<u>OMB</u>) using the Program Assessment Rating Tool (<u>PART</u>). The PART process evaluates programs across a set of performance-related criteria, including:

- Purpose and Design;
- Strategic Planning;
- Program Management; and,
- Results and Accountability.

Programs are assessed and assigned numeric scores, which correspond to qualitative ratings of *Effective, Moderately Effective, Adequate, Ineffective, and Results Not Demonstrated.* PART scores and findings are used to inform the budget process and drive program improvements.

There are currently 61 DHS programs that have been reviewed by OMB using the PART process. The figure below shows the overall results for DHS for the past three years. Since FY 2006, DHS has reduced the number of *Results not Demonstrated* ratings from 27 to 13, a 52 percent improvement.




Figure 1. DHS PART Rating Trend
