King Salmon

The Lake & Peninsula Business Development Center of King Salmon, AK provides business development and technical assistance services to the Lake and Peninsula Borough, which is 80% Alaska Native. The Awardee has been granted a technical assistance grant through the 2005 Native American CDFI Assistance (NACA) Program in the amount of \$70,000 to facilitate the awardee's development of a revolving loan fund to finance Native entrepreneurs and small business owners. Lake & Peninsula BDC will use the grant to: (1) acquire consulting services to develop loan policies and procedures, a product feasibility analysis, and a capitalization plan; (2) purchase computer hardware and software; (3) acquire training for staff and board members related to CDFI development and management; and (4) support operations.

The awardee will use a \$140,000 technical assistance grant through the 2005 Native American CDFI Assistance (NACA) Program to purchase consulting services to develop implementation plans for CDFI operations and capitalization; to acquire training for staff and board members; and to support operations.

SOAR will use a \$36,000 technical assistance grant through the 2005 Native American CDFI Assistance (NACA) Program to: (1) purchase consulting services to develop marketing and capitalization plans, policies and procedures, and product development; (2) acquire computer technology; and (3) support operations.

Tuba City

Four Corners Enterprise Community, Inc.

The Four Corners Enterprise Community will use the 2005 Native American CDFI Assistance (NACA) technical assistance grant of \$100,000 to (1) hire consultants to conduct a market analysis, develop policies and procedures, develop a capitalization plan and develop a strategic business plan; (2) purchase computer technology; (3) acquire training on CDFI operations and oversight for staff and board members; and (4) support operations.

The California Indian Manpower Consortium (CIMC) of Sacramento, CA, was established in 1978 to provide employment, training and supportive services to American Indian communities in 37 of California's 58 counties. CIMC is the sponsoring entity for an emerging Native CDFI that will eventually be called the California Entrepreneurs Opportunity Fund. The proposed Native CDFI will offer financial education and financial literacy development services in conjunction with its existing entrepreneur training. Additionally, the proposed Native CDFI aims to provide small loans to Native entrepreneurs and homeowners throughout California. CIMC will use the 2005 Native American CDFI Assistance (NACA) technical assistance grant of \$80,000 to (1) hire a consultant to conduct a market analysis; (2) purchase a computer workstation and financial management software; (3) cover the costs for members of the Awardee's staff / board to attend training on CDFI management and operations; and (4) support its operating costs.

Four Directions Development Corporation of Orono, Maine is a certified community development financial institution serving the four Tribes of Maine. Four Directions' mission is to improve the social and economic conditions of tribal members of the four tribes by investing in affordable housing, tribal business ventures, and small and medium-sized businesses owned by tribal members. Four Directions will use \$425,000 of its \$525,000 award under the 2005 Native American CDFI Assistance (NACA) Program for loan capital (FA award) and the remaining \$100,000 is a technical assistance grant to support operations.

Bay Mills Indian Community will use the Native American CDFI Assistance (NACA) technical assistance grant of \$80,000 to help it establish the Native CDFI by: (1) obtaining consulting services to design its small business and housing loan products; (2) purchasing computers and loan management software; (3) paying for training related to establishing a CDFI; and (4) supporting its general operating expenses associated with the CDFI.

The Awardee will use the remaining \$70,000 technical assistance grant to obtain (1) consulting services to update strategic and capitalization plans and policies and procedures; and (2) support for operations.

The Sequoyah Fund (formerly the Eastern Bank of Cherokee Indians Community Development Corporation) is a non-profit corporation created in 1998 to promote the social welfare of the Eastern Band of Cherokee Indians on the Cherokee Indian Reservation and surrounding Appalachian counties in North Carolina. The Sequoyah Fund's mission is to provide training and resources to support entrepreneurship, small business expansion, affordable housing, and community development on the Cherokee Indian Reservation and among Cherokee Tribal members. The Sequoyah Fund will use a 2005 Native American CDFI Assistance (NACA) Program technical assistance grant of \$140,000 to (1) purchase accounting and loan management software; (2) obtain consulting services to update their loan policies and procedures and develop a capitalization plan; (3) support operations; and (4) attend training in CDFI operations.

The Lumbee Revitalization and Community Development Corporation (LRDCD) is an emerging Native CDFI established in 2002. LRCDC provides housing rehabilitation, down payment and business loans to Lumbee Tribal Members and other Native Americans residing in Robeson County, North Carolina. LRCDC also provides development services consisting of instruction in financial literacy, homeowners counseling and a small business development course. LRCDC will use a 2005 Native American CDFI Assistance (NACA) Program technical assistance grant of \$132,000 to: (1) hire consultants to review, update and write policies and procedures, develop a loan and policy manual, create a development services workbook and develop a five-year strategic plan; (2) purchase and install accounting and loan management hardware and software; (3) obtain training for staff and board members regarding loan underwriting, portfolio management and policy development; and (4) support operations.

TMHA will use a \$150,000 technical assistance award through the 2005 Native American CDFI Assistance (NACA) Program to (1) purchase consulting services to develop: a market analysis, capitalization and strategic plans, policies and procedures, and a staff training program; (2) acquire technology and training, and (3) support operations.

The Citizen Potawatomi Community Development Corporation (CPCDC) of Shawnee, OK, is a tribally chartered non-profit corporation, incorporated in May 2003 and certified as a CDFI in September 2004. It was chartered by the Citizen Potawatomi Nation, headquartered in central Oklahoma, to provide capital and technical assistance to the 26,000 Potawatomi members throughout the United States as well as all Native Americans in Oklahoma. The organization currently offers three programs: micro-business loans, commercial lending and business development. CPCDC will use the 2005 Native American CDFI Assistance (NACA) award of \$650,000 (FA award of \$500,000 and the TA grant of \$150,000) to expand its physical presence to Kansas, increase its loan capital as well as expand their loan products to include construction finance, lines and credit and community facilities loans to support the local construction boom. CPCDC will also use its technical assistance grant to (1) purchase consulting services to conduct a market analysis and product feasibility analysis, develop policies and procedures, and develop a strategic plan; (2) purchase hardware and software to improve operational efficiency; (3) acquire underwriting training; and (4) support operations.

The Cherokee Nation Economic Development Trust Authority of Tahlequah, OK, is a certified CDFI established in 1999. The Cherokee Nation Economic Development Trust Authority administers six revolving loan programs that provide consumer and commercial loans. The Trust Authority also provides technical assistance credit counseling, loan packaging and workshops on topics such as: financing, marketing, record keeping, accounting, contracting, taxes, franchising, and insurance, along with a 12-week in-depth and individualized entrepreneur training program. Both the lending and development services are provided through the Cherokee Nation Small Business Assistance Center and target tribal members within the fourteen county jurisdictional territories of the Cherokee Nation in northeastern Oklahoma. The Cherokee Nation Economic Development Trust Authority will use the 2005 Native American CDFI Assistance (NACA) technical assistance grant of \$40,880 to (1) pay for staff training in commercial lending, real estate documentation, financial analysis and collections; (2) to cover staff salary to conduct a market needs assessment; (3) purchase computer hardware and business management and marketing software technology; and (4) to support its operating costs.

The Sicangu Fund will use a \$100,000 technical assistance grant through the 2005 Native American CDFI Assistance (NACA) Program to help Sicangu Fund obtain certification as a community development financial institution. The grant will be used to: (1) purchase consulting services to develop strategic and capitalization plans, a webpage, and to conduct an audit; (2) acquire technology; (3) obtain training for staff and board members on business lending and CDFI oversight; and (4) support operations.

The grant will be used to: (1) purchase consulting services to develop a capitalization plan and policies and procedures; (2) acquire technology; (3) obtain training for staff and board members in the housing lending, CDFI operations and oversight; and (4) support staff salaries to assist in the development of the capitalization plan, a marketing plan, and the policies and procedures.

The applicant will use the 2005 Native American CDFI Assistance (NACA) technical assistance grant of \$130,000 to (1) engage consultants to conduct a market analysis, develop policies and procedures, develop a capitalization plan, develop a strategic business plan and develop its lending products; (2) purchase basic office equipment and computer hardware and software; (3) send its staff and board to training on community development finance; (4) to receive peer training on CDFI operations from an established Native CDFI; and (5) to support its ongoing operating costs.

This Native CDFI will provide seed money in the form of equity while bringing real understanding of tribal-owned company best practice using the prototype developed with the Northwestern Band of the Shoshone Nation in Utah. The technical assistance grant will be used to (1) acquire consulting services to develop policies and procedures and technical assistance documents; (2) purchase hardware and software; (3) obtain training for staff and board members on community development venture capital investing; and (4) support operations in the form of a contract with Northwestern Band of the Shoshone Nation Economic Development Corporation to provide staffing and related assistance in the development of the CDFI.

FACC's affiliate, the American Indian Chamber of Commerce of Wisconsin (AICCW) is a prior CDFI Fund awardee that utilized a technical assistance grant to create FACC. FACC's mission is to operate a statewide revolving loan fund providing gap financing for the development and expansion of enterprises owned by qualifying American Indian business people. FACC will use is 2005 Native American CDFI Assistance (NACA) award of \$420,000 (\$300,000 financial assistance and \$120,000 technical assistance grant) to increase its loan volume, increase its average loan size and allow the provision of direct start-up loans. The Awardee will use the technical assistance portion of its NACA grant to (1) hire consultants to create and strengthen its policies and procedures; (2) purchase computer hardware and loan portfolio software modules; and (3) support operations.
