

It was April 19th, 1985, 3 and John was here, and I'm not sure 4 MR. SCHINDLER: Bob Raft (ph.), 5 6 and Debbie Johnson. MR. POWERS: Yeah. Two other 7 people were here, and it was to seek information about what we 8 should write about in the E.I.S., and so now we have prepared a 9 draft environmental impact statement. We're holding hearings in 10 11 five places. This is the UNIDENTIFIED SPEAKER: Come on 12 in. 13 MR. POWERS: third hearing. 14 We've held hearings in Barrow, and -- excuse me -- Point Hope, and 15 we'll hold a hearing in Wainwright tomorrow, and then one in 16 Anchorage next week. And after we get comments on the draft en-17 vironmental impact statement, then we will prepare a final environ-18 mental impact statement. That final environmental impact statement 19 will be used by the Secretary of Interior when he makes decisions 20 regarding O.C.S. Lease Sale 109. 21 The sale, if it's held, is scheduled for 1988. The area 22 that we're talking about leasing is shown on the map on your right 23 that's on the wall, and let me stand up and just point it out to 24 We're talking about this whole area through here, and Point 25 you.

Tn-1 cluded in the proposal are what we call alternatives, and there are 2 three principal alternatives that we're studying at the same time. 3 And one alternative is to lease all of the area except this that is 4 In other words, we would delete this from the 5 colored in purple. Another would be to delete this area from the Lease Lease Sale. 6 And a third alternative that we're considering is deleting Sale. 7 all of this from the purple line to the shore. All of this would 8 be deleted. 9

Now, there's never been any oil and gas leasing in the 10 Chukchi Sea, and there hasn't been any drilling in the Chukchi Sea. 11 So, nobody knows for sure if there's even oil and gas out there. 12 Our estimates are pretty rough, since there hasn't been any drill-13 ing, but we think the chances of finding commercial quantities of 14 oil are only about one out of five, about 20 percent. If oil is 15 present, we think that it could be as little as a billion barrels, 16 which is actually a pretty good size oil field, and as much as 17 five-and-a-half or six billion barrels that could be produced. By 18 comparison, Prudhoe Bay will probably produce about 10 billion 19 barrels. We don't envision anything as large as Prudhoe Bay by a 20 long shot. 21

If drilling occurs, and discoveries are made, we think that it will be probably about ten years before production could actually start, and if production -- and if there is production, production could last for maybe 30 years.

One of the major concerns that has been expressed about off-1 2 shore oil and gas activity in Chukchi and Arctic waters has been And, possible effects on whaling, and other subsistence activities. 3 that's an important concern for us, too. We can exercise, and do 4 exercise a lot of control over drilling, and we'll expect oil 5 companies to be careful about the effects that they might have on 6 We would expect that the 7 subsistence activities, including whaling. oil companies and the villagers and the whalers would work together 8 when they -- if they had problems. That seems to work best when the 9 people who are interested in the ocean actually work together.

If there are onshore construction activities, such as support bases, that will be controlled by the State and the North Slope Borough. We don't have jurisdiction over that.

Now, what we -- what we would like to do today is to get comments on the draft environmental impact statement so that we can proceed and prepare a final environmental impact statement. If you want to testify, we would need your name on the record, and would like for you to sign up with Laura Yoesting, the lady on my right, and -- and then you can sit here, and everything will be recorded so that we will have a complete record.

Now, I guess if you don't want to testify, and want to -if the village, for example, would like to present written testimony
at a later date, we can accept written testimony up until May 5th.

Willie Tukrook, and I'd like to see this lease sale postponed or 13 cancelled due to the fact that not enough noise pollution study has 14 been done on the belugas, or -- we have no idea how the noise will 15 effect them. It might change their migratory routes, or -- like in 16 Kotz -- it might be too much activity around if the lease sale goes 17 through, and it might chase the belugas away. Like I've seen the 18 same thing happening in Kotzebue. The belugas hardly go into 19 Kotzebue Sound anymore, where they used to be numerous. It might 20 be due to activity or noise pollution. But, I think some kind of 21 a study should be made, and included in the draft environmental 22 statement before this lease sale takes place.
