Trust accounts are for the purpose of recording transactions in connection with funds received by the U.S. Government in the capacity of trustee in accordance with terms of statutes or formal agreements. The responsibility of the U.S. Government is fixed by the terms of the trust in each case. These funds, having both receipt and appropriation or expenditure accounts, are processed as special funds. The last four digits of the symbols fall within the range of 8000 to 8999.

In many cases, these monies must be used soon after receipt so that time does not permit the delay occasioned by the appropriating process. In such case, the accounts are designated as immediately available by the suffix (Available Receipts). The receipts are then recorded on the collection documents under the receipt symbols followed by the appropriation symbols in parentheses. The funds are then available for expenditure without further action. The actual appropriating procedure is carried through at the end of the fiscal year by the Department of Treasury instead of monthly as is done with receipts which are not immediately available.
