Certain materials in Yellowstone's museum collections and archives may be protected by the U.S. Copyright Law (Title 17, U.S.C.), or restricted by NPS gift or purchase agreements, donor restrictions, privacy and publicity rights, licensing and trademarks. Please refer to the Copyright and Privacy Restrictions form for all terms and agreements regarding the use of copyrighted materials.

Historic photograph and film footage requests are dealt with on a first come first serve basis. Please allow 2 to 4 weeks for delivery. If order exceeds 25 images, delivery time will increase to 6 to 8 weeks. Orders exceeding 75 images will be completed based on staff availability. *No rush orders accepted*.

Digital images are available in JPEG file format burned onto a CD-R or can be reproduced on premium photo paper. Reproduction prints are on premium photo paper available in 3½x5, 5x7, or 8½ X11. Due to the high volume of requests for images, the Museum Collections and Archives limit the number of paper based prints to 10.

Orders are shipped by U.S. Mail unless a special delivery service, such as FedEx, is requested and prepaid.
