

Re: Former Aleut Bunkhouse, Northeast Point

The former Aleut bunkhouse is located on a small knoll near the Webster House, and served as a temporary residence for those involved in seal harvesting at Northeast Point. The building has collapsed, leaving a heap of wood and some metal debris within a shallow concrete foundation.



NOAA has been approached to remove the debris at the site. However, some community members have stated to NOAA that the site represents some historical value and should remain as it is. NOAA is willing to remove the debris but the concrete foundation would remain in place.



The ultimate decision for the removal of the bunkhouse lies with the landowner, Tanadgusix Corporation (TDX). However, NOAA and TDX are interested in the opinions of the various St. Paul RAB members and the community to assist in making the most appropriate decision.
