1.0 Introduction:

The 2008 Peter Pan Fleet Co-Op was allocated 12,489.16 mt of the Inshore component of the BSAI 2008 pollock TAC

The individual catcher vessels belonging to the PP Fleet CoOp were given individual percentages of the Co-Op's allocation based on (confirmed by NMFS) historical catch brought to the PP Fleet CoOp. This is showed in Table 1-A.
