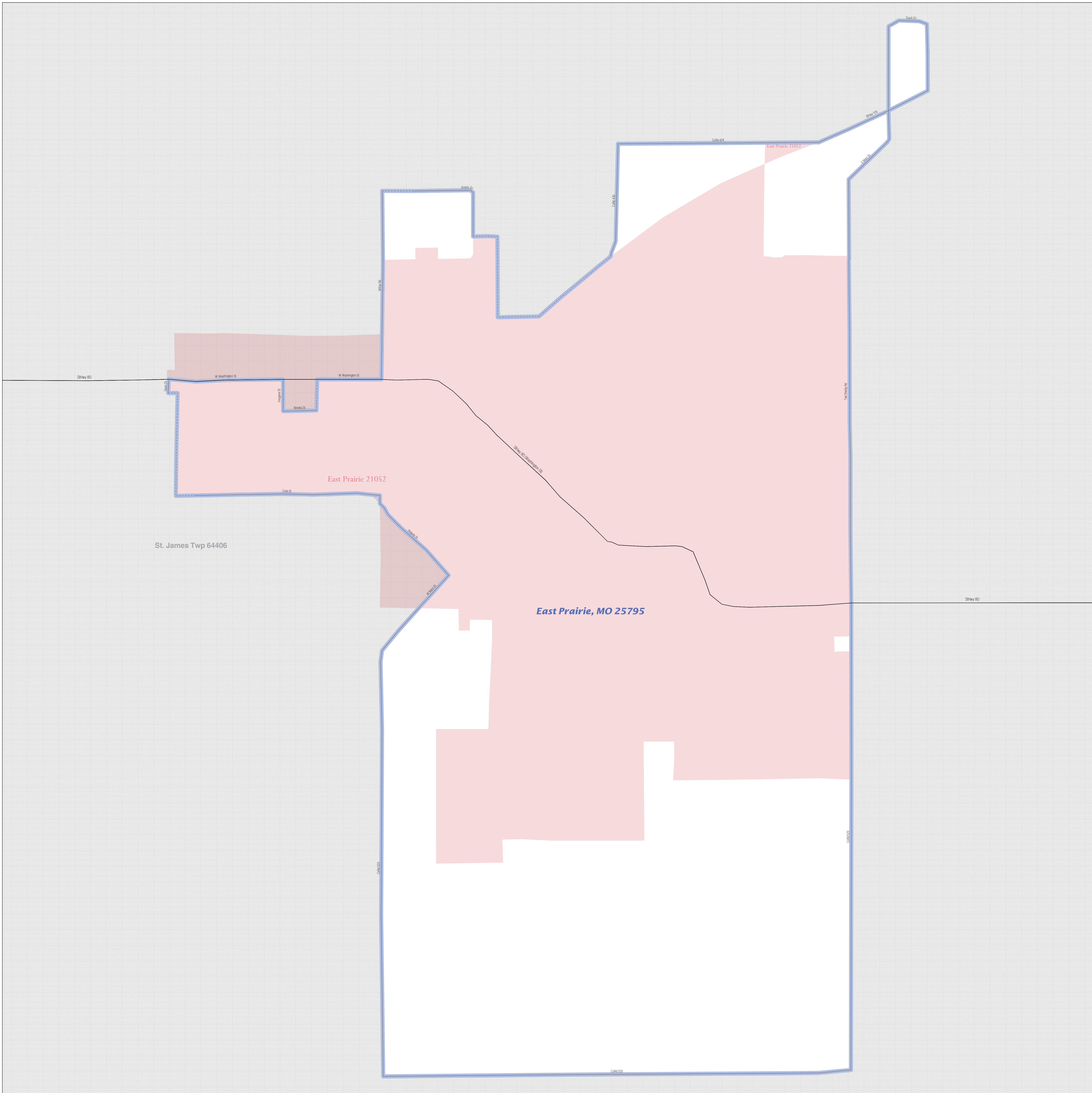


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) East Prairie, MO
