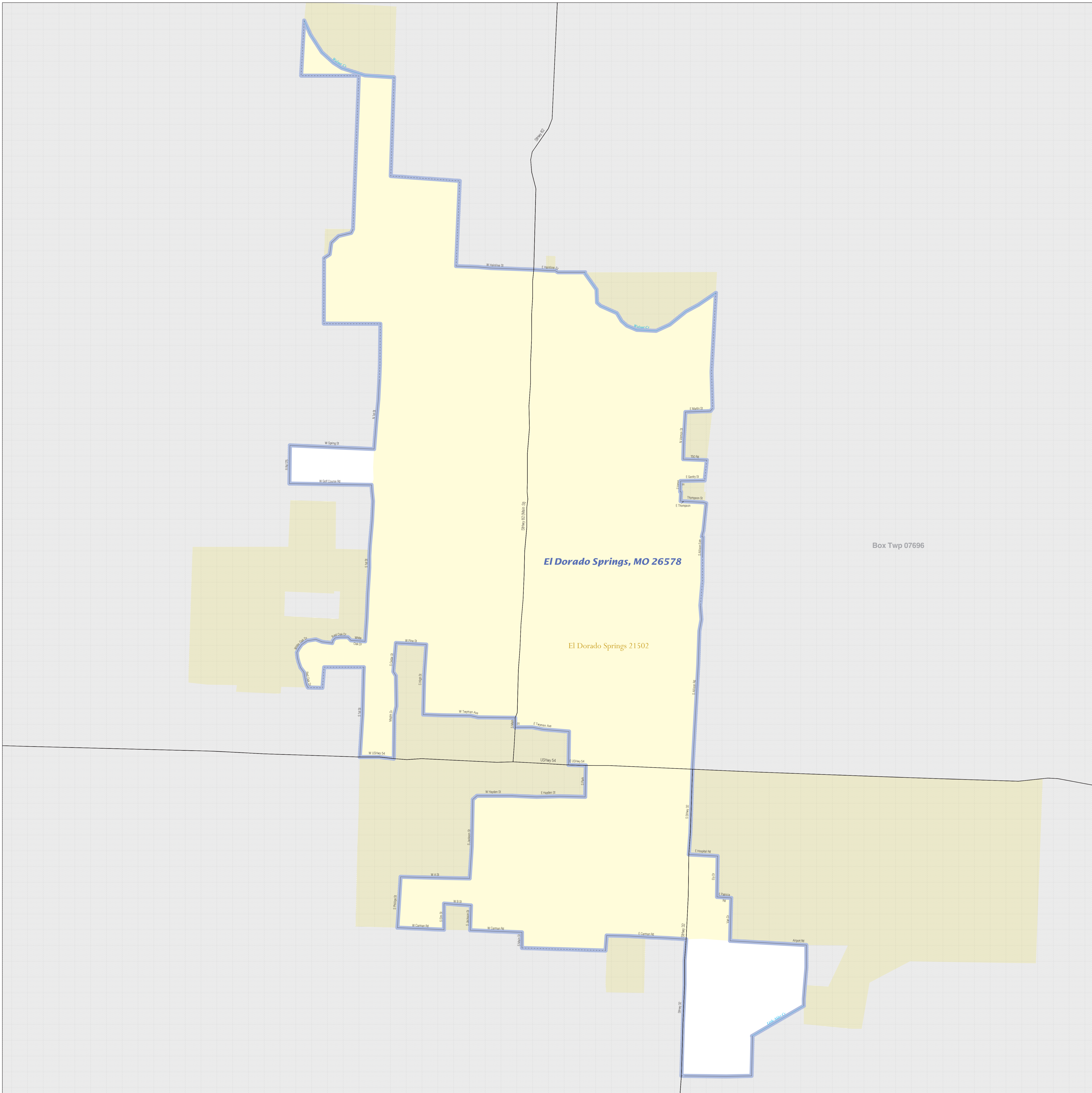


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) El Dorado Springs, MO
