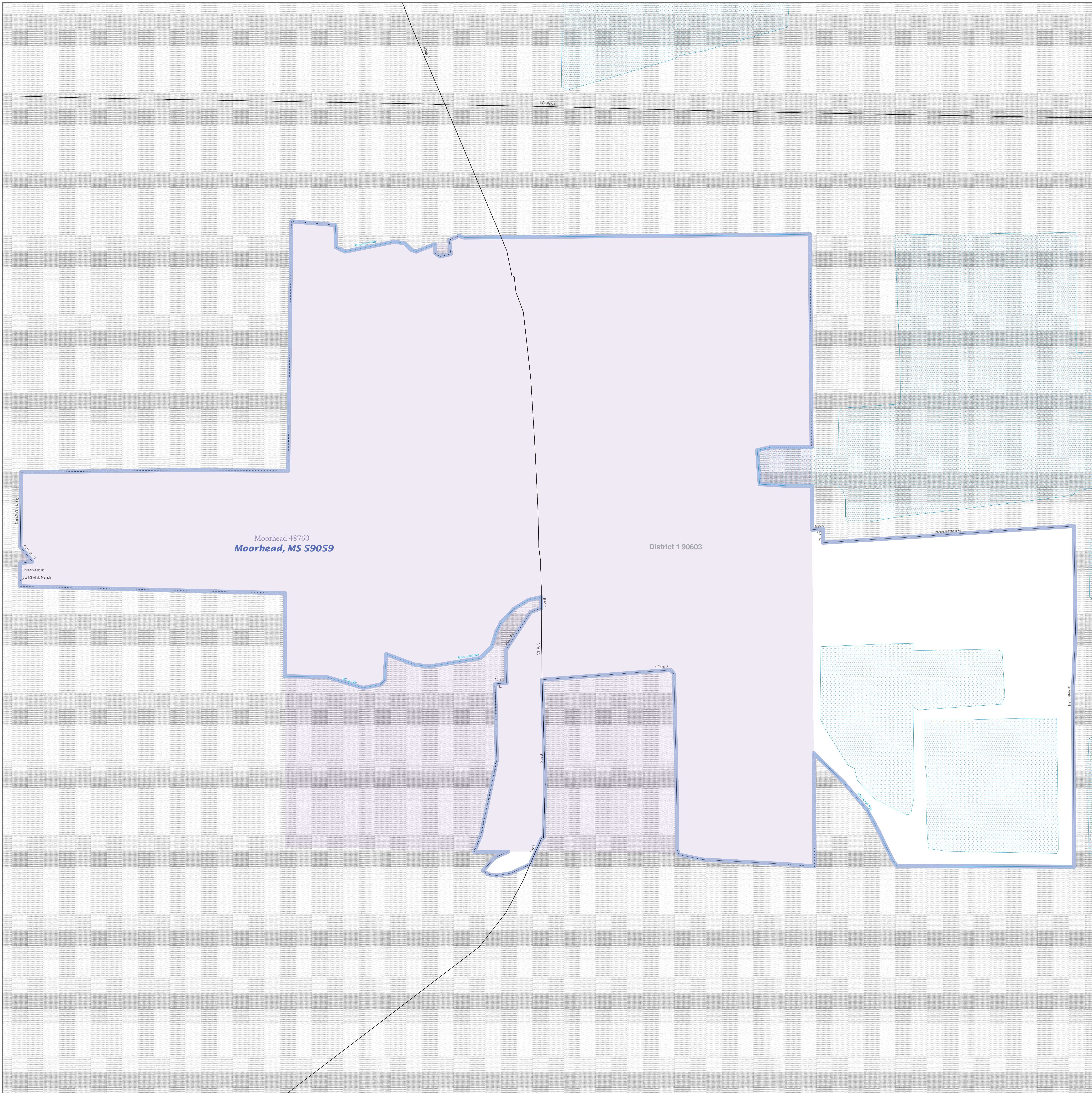


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) Moorhead, MS
