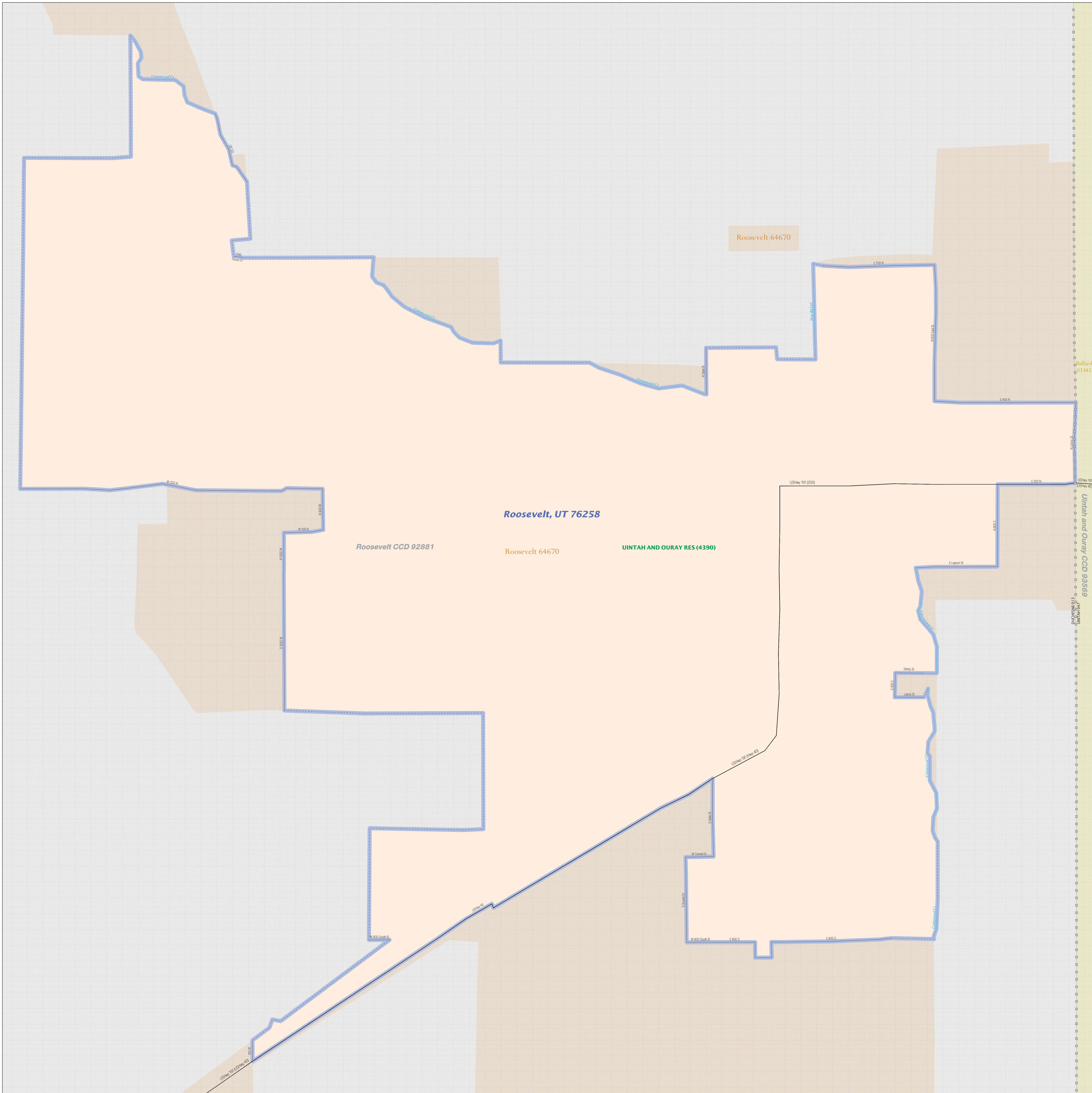


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) Roosevelt, UT
