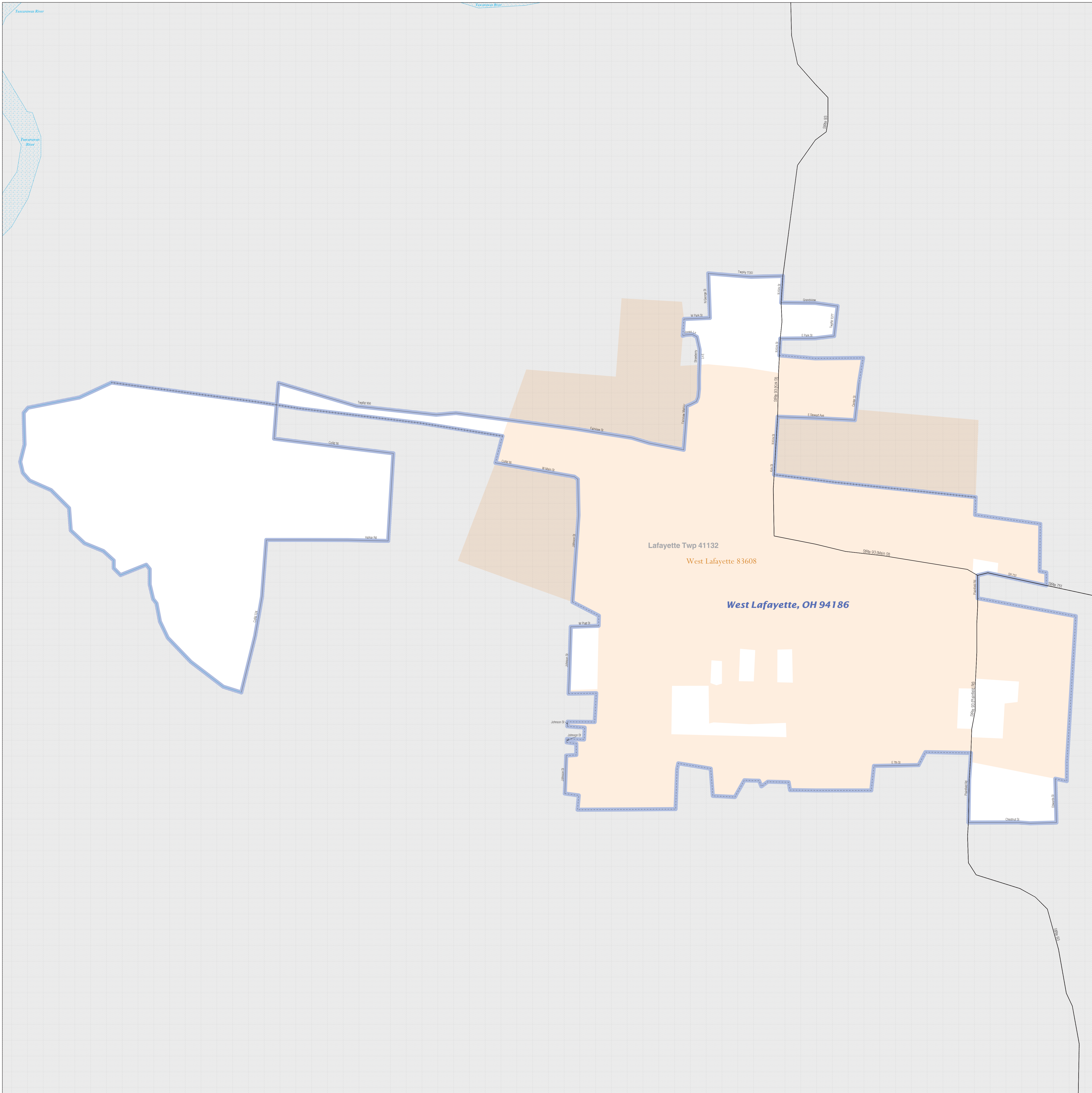


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) West Lafayette, OH
