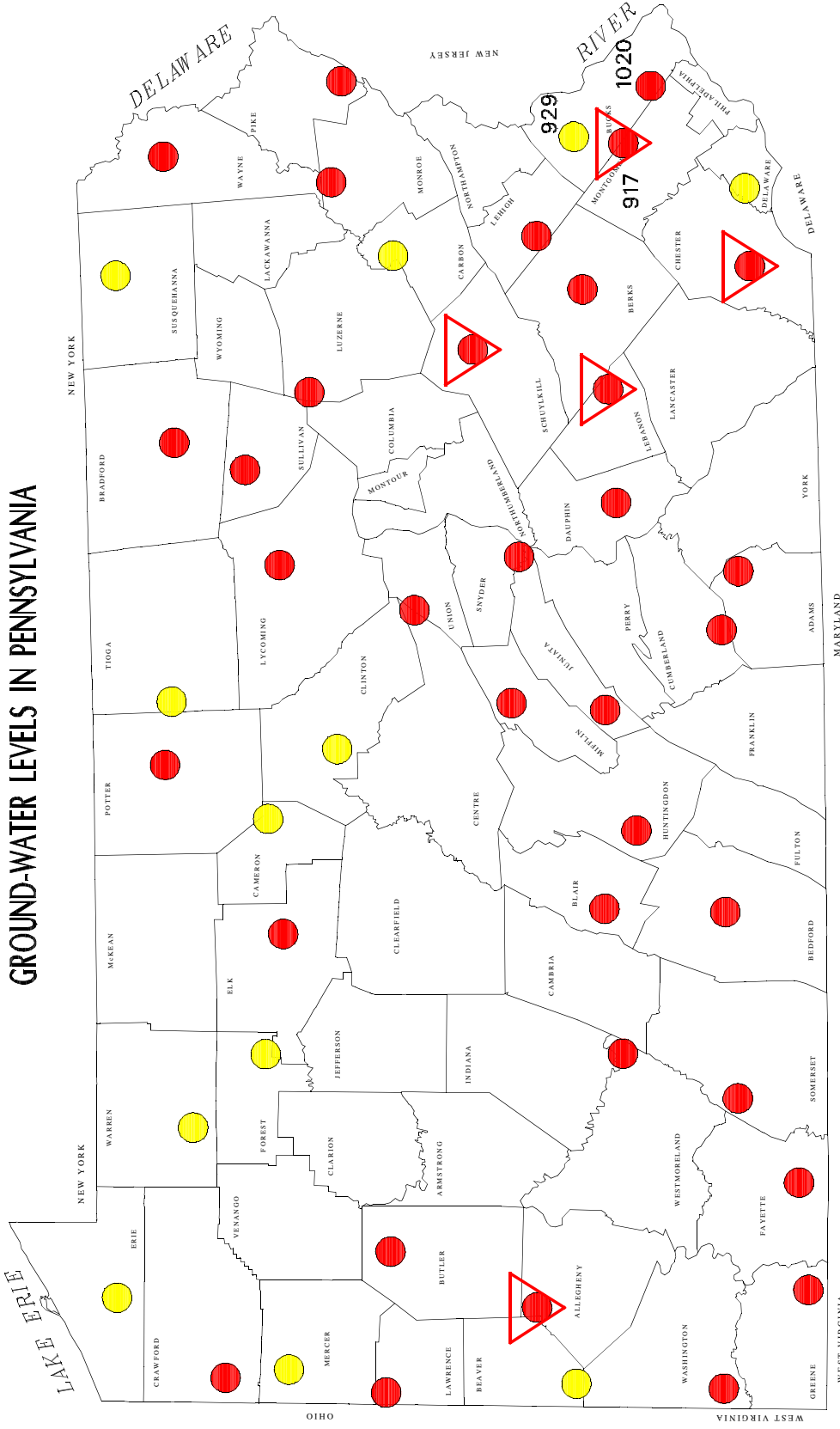
NOTE:
