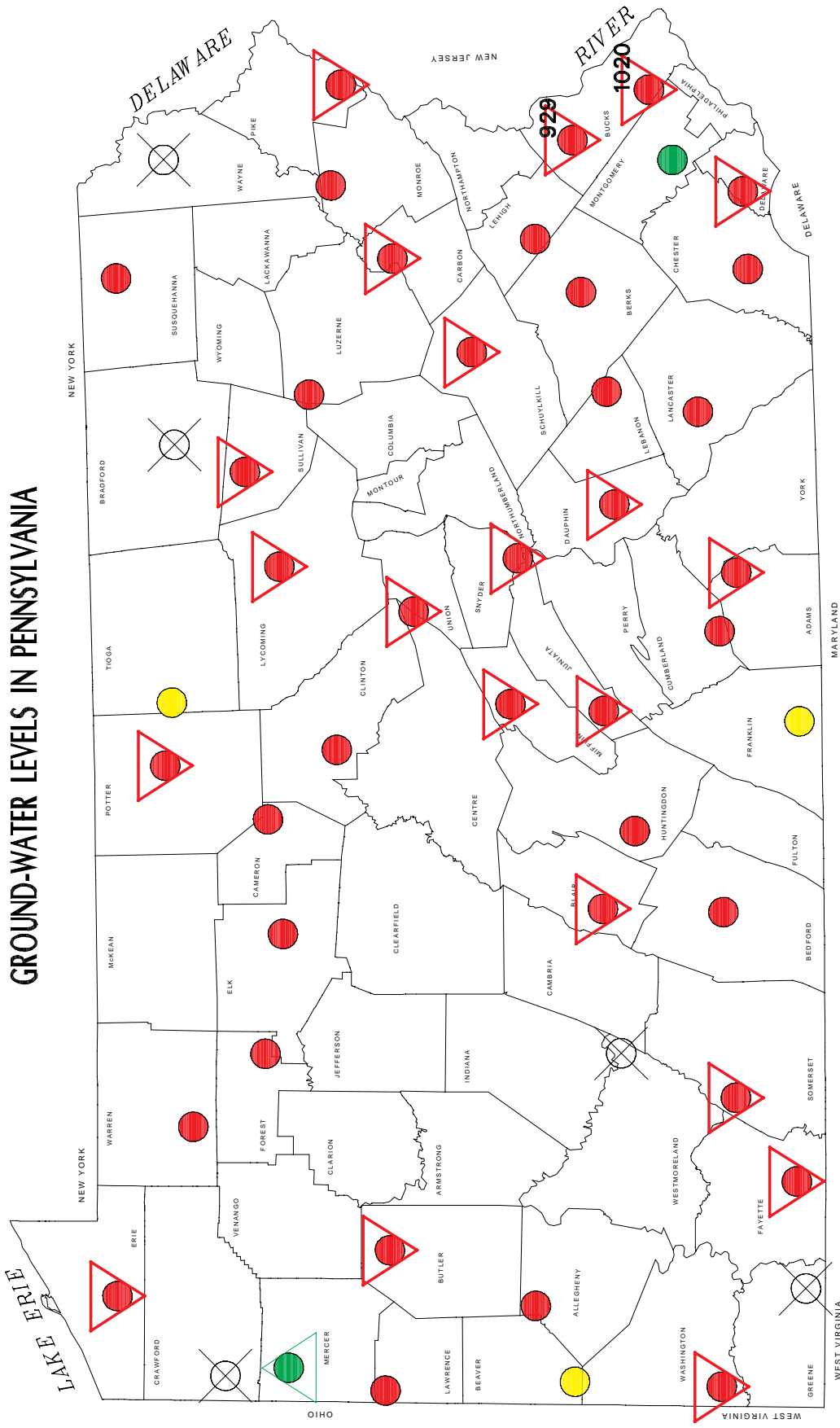

GROUND-WATER LEVELS IN PENNSYLVANIA






