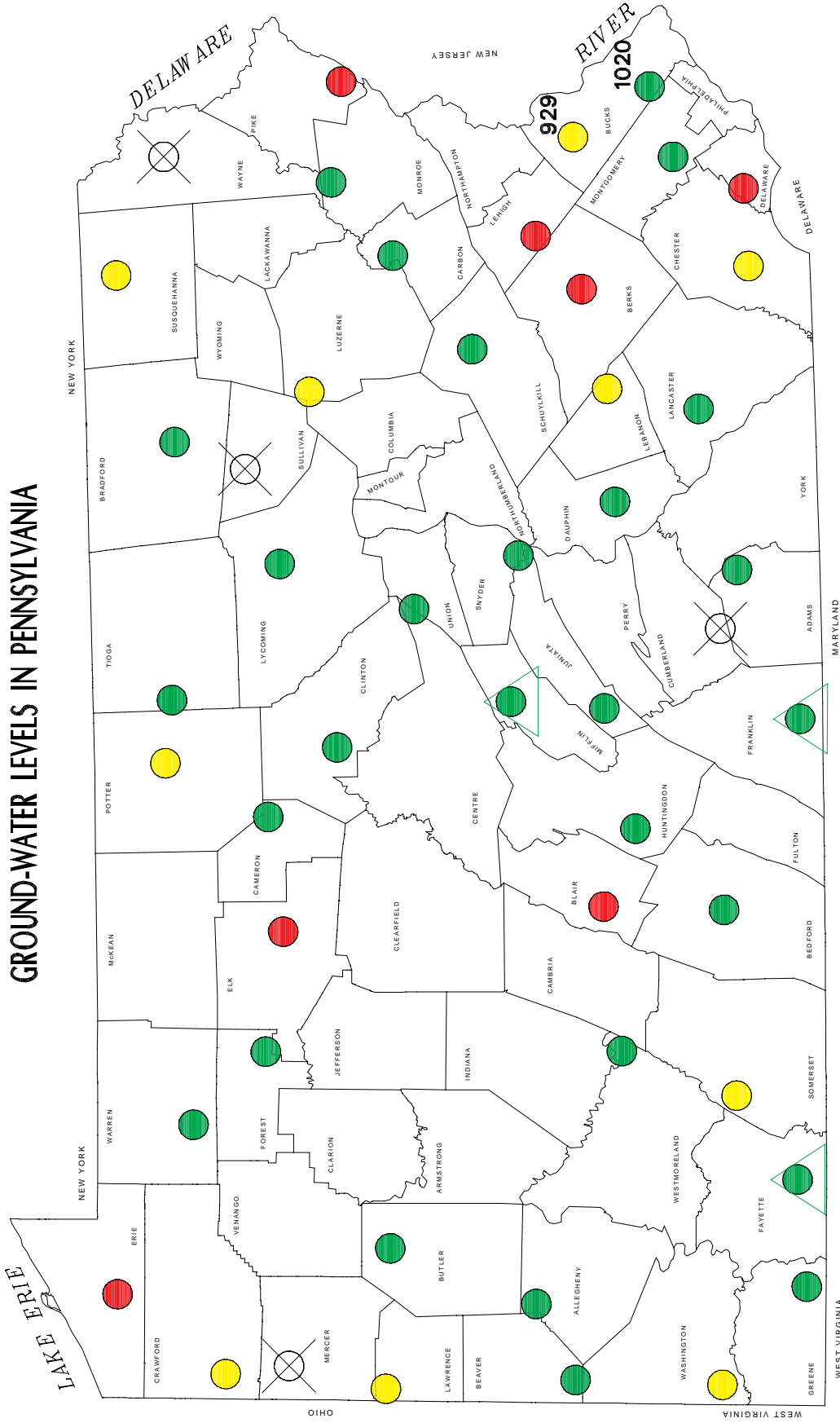

MEAN WATER LEVELS IN OBSERVATION WELLS

Normal is defined as a water level between the 25th percentile and 75th percentile of monthly mean water levels for all previous years of record for this month.
