13. ABSTRACT (Maximum 200 words) Sounds associated with oversnow vehicles, such as snowmobiles and snowcoaches, are an important management concern at Yellowstone and Grand Teton National Parks. The John A. Volpe National Transportation Systems Center's Environmental Measurement and Modeling Division is supporting the National Park Service with its on-going Winter Use Planning program. As part of this support, acoustic measurements of ten snowcoaches and six snowmobiles were made at the south entrance to Yellowstone National Park from the 26th through the 28th of February 2008. Measurement methodologies were guided by SAE J1161 and SAE J192. There were two primary objectives: 1) to determine which snowcoaches had the Best Available Technology (BAT) with respect to noise emissions, and 2) to determine if there was a significant difference between snowmobile sound levels when tested using two revisions of SAE J192. Based on analysis of the data, it appears that among the snowcoaches, the Yellowstone Expeditions' modified Dodge B530 snowcoach would be an excellent candidate for BAT classification. It was also found that measurements guided by the two revisions of SAE J192 had very similar results.

Executive Summary

Sounds associated with Oversnow Vehicles (OSVs), such as snowmobiles and snowcoaches, are an important management concern at Yellowstone and Grand Teton National Parks. The John A. Volpe National Transportation Systems Center's Environmental Measurement and Modeling Division (Volpe Center) is supporting the National Park Service (NPS) with implementation of the Winter Use Planning program (Ref. 1, 2, 3, 4) and supporting National Environmental Policy Act (NEPA) documents, including the 2007 Winter Use Planning / Environmental Impact Statement. As part of this support, the Volpe Center, in cooperation with the NPS, performed acoustic measurements of ten snowcoaches and six snowmobiles at the southern entrance of Yellowstone National Park from the 26th through the 28th of February 2008. The measurement site location is indicated in Figure 2.

These measurements were made with three primary objectives in mind:

- 1) Help determine what sound testing protocols should be used to determine if *snowcoaches* meet the Best Available Technology (BAT) with respect to noise emissions.
- 2) Determine which *snowcoaches* meet BAT standards with respect to noise emissions.
- 3) Determine if there was a significant difference between *snowmobile* sound levels when tested using two different methodologies.

The measurement site was an open section of snow packed road at the south entrance of Yellowstone National Park, at the same location as was used in October 2002 for snowcoach measurements. There was a 2 to 3 foot buildup of snow in the measurement area adjacent to the road which was not ideal, however, analysis of the data indicated that this snow berm did not substantially influence the measurements.

Three microphones were setup along a line perpendicular to the road. Two were set 50 feet from the center of the over-snow vehicle travel path, one 4 feet above the snow and a second 15 feet above the snow. One microphone was set 200 feet from the center of the travel path, 4 feet above the snow. Sound levels were measured as the over-snow vehicle traveled along the roadway.

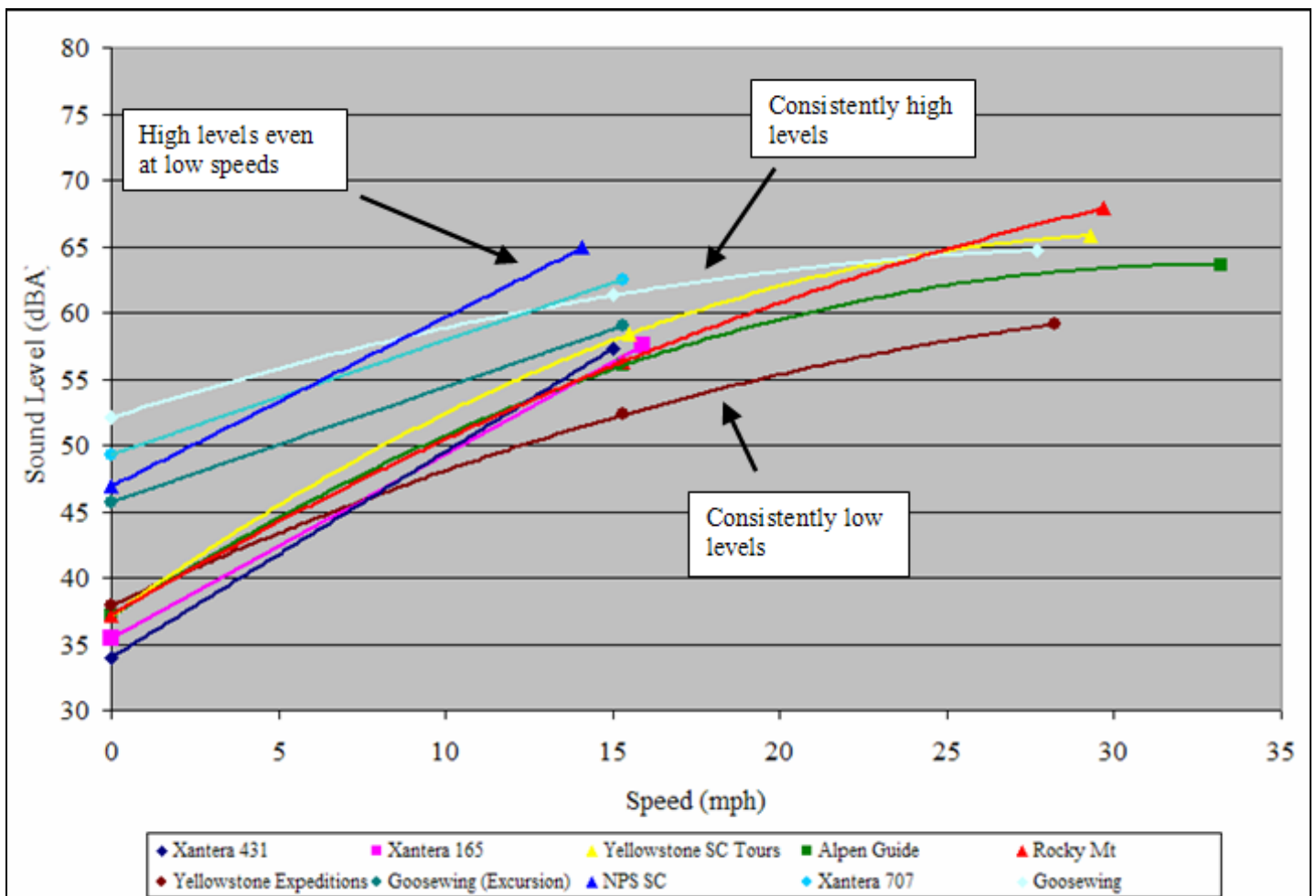


Figure 1: Sound Level vs. Speed

The snowcoaches tested are indicated in Table 1. Testing of the snowcoaches was guided by specifications given in SAE J1161 (Ref. 11). On the first day of testing, vehicles were measured at idle, 15 mph and 30 mph, however, due to degraded road conditions, only idle and 15 mph measurements were made on the second day. Results from these measurements are shown in Figure 1.

* Track types for the snowcoaches are as follows: Skis / Tracks – the rear wheels have been replaced with tracks while the front wheels have been replaced with skis; Mattracks – both the front and rear wheels have been replaced with triangular tracks manufactured by Mattracks; Snowbuster – are a specific manufacturer of Skis / Tracks, and Grip Trax – another specific type of triangular tracks to replace the front and rear wheels.

Snowmobiles tested are shown in Table 2. These vehicles were evaluated in order to determine if two different revisions of SAE J192 (Ref. 12) would produce different sound level results. The 1985 revision required snowmobiles to start from rest and then travel along the road at full throttle while measuring the sound level using a fast time response. The 2003 revision required snowmobiles to approach the measurement zone at 15 mph and then travel along the road at full throttle while measuring the sound level using a slow time response. On average, the 1985 revision produced results about 2 dB greater than the 2003 revision.

* Track types for the snowmobiles are as follows: Standard – indicates a standard width belt track with skis in the front for steering; Wide – indicates a wide belt track with skis in the front for steering.

Based on experiences during this study, the following recommendations are suggested for future measurement of snowcoach sound levels for the purpose of testing BAT conformance. The measurements should adhere to SAE J1161 with the following modifications and considerations:

- Because of the altitude, barometric pressure specifications should be expanded to include typical pressures in the parks during the winter season. The sound level variation due to the lower barometric pressure could be corrected in a manner similar to the methods described in References 5 and 6.
- If a snow berm is present, all practical efforts to remove it should be implemented.
- If a snow berm greater than 3 feet tall cannot be removed, another site should be sought.
- Testing should be conducted for three conditions
 - Idle
 - 15 mph
 - A high speed to be determined by the park based on local speed limits, e.g., 30 mph, road speed limit, or a typical cruising speed.
- A road groomer should be kept on hand in order to ensure that the road conditions do not deteriorate over the course of the testing.
- If vehicles fail to meet BAT requirements at the high speed, consideration should be given to restrictions which would still allow the snowcoach to operate in the parks, but at a reduced speed.

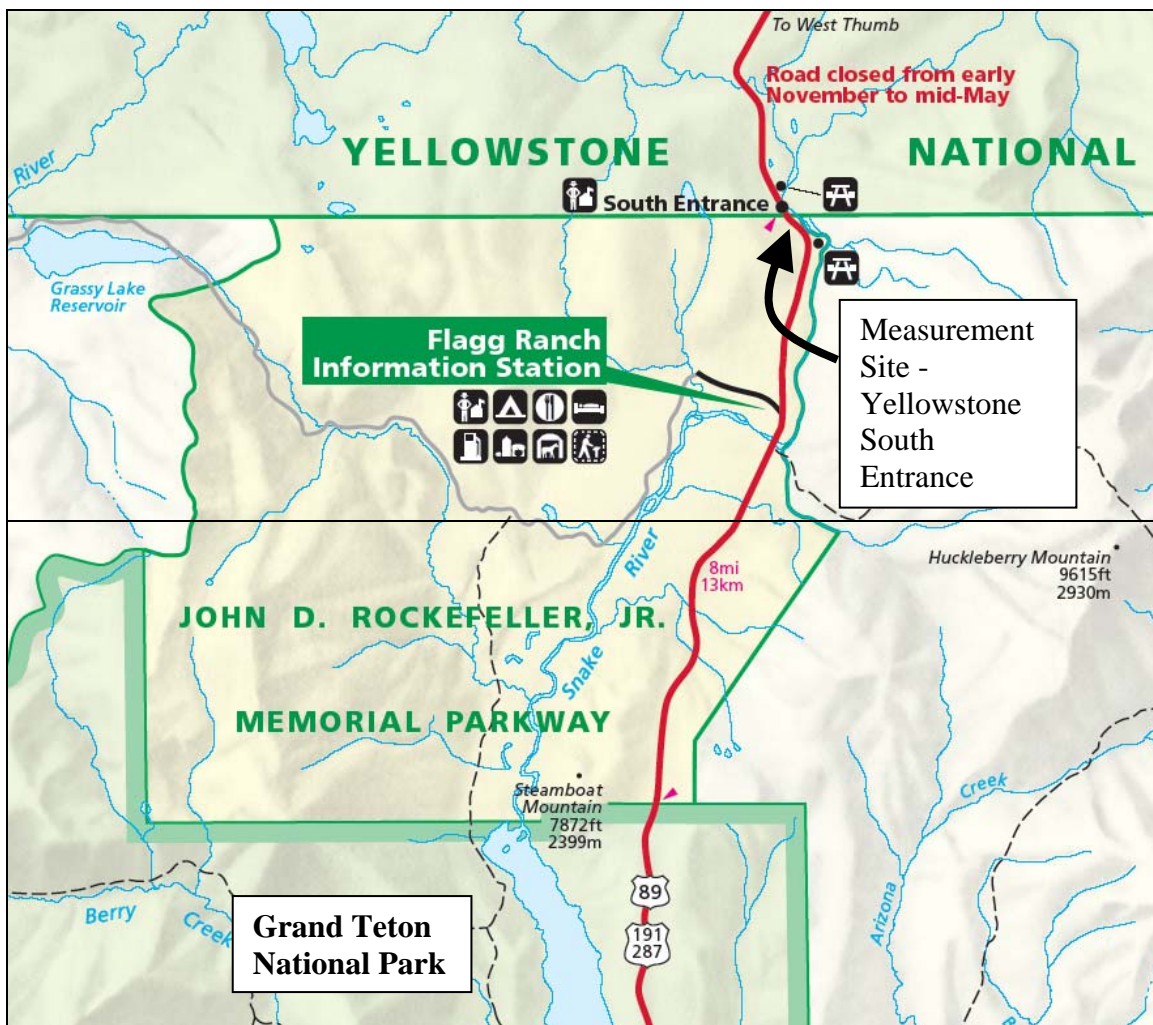


Figure 2. Location of Measurements in the John D. Rockefeller Jr. Memorial Parkway



These measurements were made with three primary objectives: 1) Help determine what sound testing protocols should be used to determine if *snowcoaches* meet the Best Available Technology (BAT) with respect to noise emissions, 2) Determine which *snowcoaches* currently operating in the parks met BAT standards with respect to noise emissions, and 3) Determine if there was a significant difference between *snowmobile* sound levels when tested using two different methodologies.

The use of BAT OSVs is one management approach to reducing the sound levels in the parks due to OSVs. The NPS wishes to determine the procedures to evaluate compliance with the snowcoach BAT requirements*. The winter use regulations (Federal Register, Vol. 72, No. 239, December 13, 2007, pages 70781-70804) states that, "Beginning in the 2011-2012 season, all snowcoaches must meet a sound emission requirement of no greater than 73 dBA. The Superintendent will establish procedures for determining compliance." (36 CFR 7.131(4)(v)). In order to determine which snowcoaches are BAT compliant, idle measurements and passby measurements at constant speeds of 15 and 30 mph were made for ten snowcoaches. The procedure used was based largely on the Society of Automotive Engineers J1161 standard (SAE J1161) (Ref. 11).

The NPS is also interested in evaluating the difference in snowmobile sound level when tested according to two different methodologies. The basic testing approach is provided in the Society of Automotive Engineers J192 standard (SAE J192) (Ref. 12). This standard is used for measuring the maximum exterior sound level from snowmobile passby events. Two versions of this standard specify different starting speeds for the passby event as well as different time responses. Specifically, the 1985 revision requires that snowmobiles start from rest (0 mph) and the use of a fast time response for the sound level meter while the 2003 revision requires that snowmobiles start with an initial speed of 15 mph and the use of a slow time response for the sound level meter.

In addition to the NPS's three primary objectives, the agency wanted to obtain additional data that could be used for the modeling of OSVs in the Parks using a purpose-built version of the FAA's Integrated Noise Model (INM) (Ref. 13). This requires that the measurements be comparable with previous and potential future measurements. Previous measurements also involved significant conformance to SAE J192 and SAE J1161 (Ref. 7, 8). Conformance to these standards would allow the data collected in the current study to be included in the purpose-built version of INM. Specifically, NPS desires to obtain additional OSV noise-speed-distance and spectral data in the current study.

Section 2 provides a description of the measurement site, the vehicles measured, and cover details of the measurement setup. Section 3 covers the measurement methodology, including a description of the SAE J1161 and J192 standards. Section 4 presents data analysis and discussion. A summary with conclusions and proposed next steps is included in Section 5.

* BAT classification also includes considerations for reduced / cleaner exhaust emissions.



2. Measurement Setup and Data Collection

This section presents information on the layout and conditions of the measurement site, the vehicles measured, and the measurement equipment used.

2.1. Measurement Site Layout

The site chosen by the NPS is at the southern boundary of Yellowstone National Park. An aerial photo of the site is shown in Figure 3. The ground during the measurements was covered by at least four feet of snow. The river, shown in Figure 3, was in a ravine with a depth of approximately 25 feet. Flowing water could be faintly heard during the quietest times, however, it could not be heard during measurements. To the east of the road, there was a pull-off where tourists would stop to take photographs. The western pull-off was not present during the measurements due to snow cover. To the north there were several park buildings which did not interfere with the measurements.

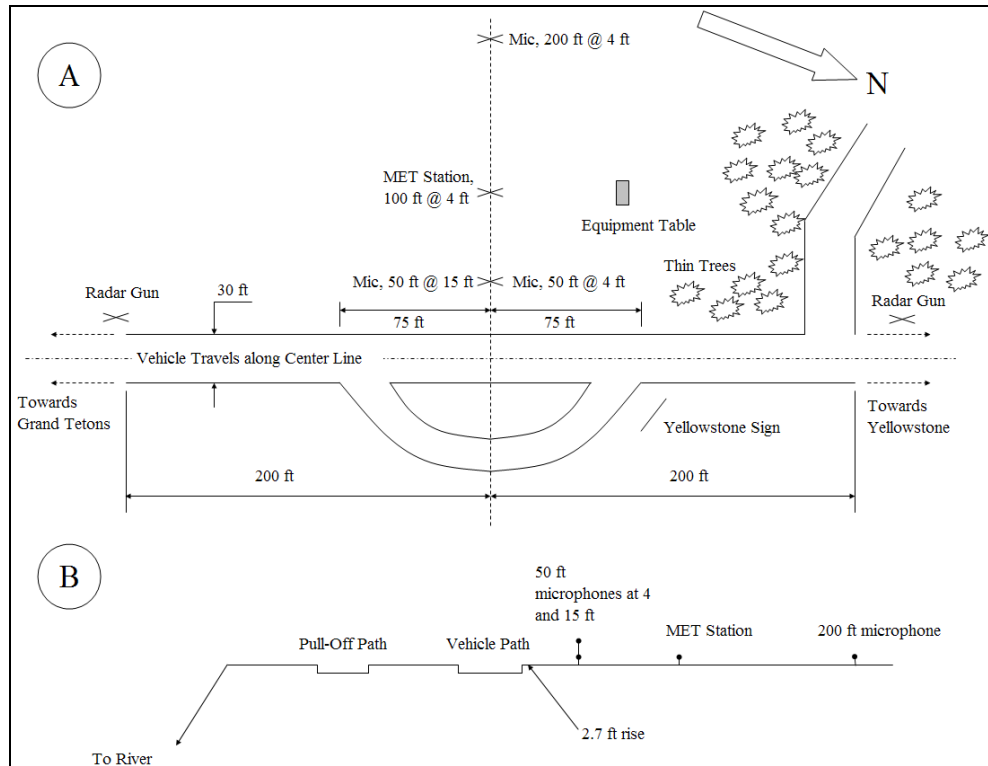


Figure 4. Measurement Site Sketch – (A) Aerial View, (B) Profile

Microphones were setup to the west of the road in the region free of trees. A sketch of the site showing the aerial view and profile is provided in Figure 4. Two microphones were located 50 feet from the center of the travel lane, one at 4 feet above the snow cover and one at 15 feet above the snow cover. One microphone was located 200 feet from the center of the travel lane, 4 feet above the snow cover. A meteorological system was set up 100 feet from the center of the travel lane in line with the microphones, 4 feet above the snow cover. A single measurement table was positioned 65 feet off to the side of the microphone line and all data recording equipment was setup at this location. The location of equipment is indicated in Figure 4A.

Aside from the difference in snow height between the road and the microphone locations, the only other obstructions were the presence of some evergreen trees on the north end of the measurement area. These trees were lightly distributed and when listening to passby events, they were not observed to affect the levels at the 50 foot microphone. It is possible that they did affect portions of the data measured at the 200 foot microphone location. For this reason, only maximum levels, which were not affected by the trees, are examined for the 200 foot microphone.

2.2. Measurement Conditions

The road was not closed during the measurements so extraneous road traffic did occur, primarily during a two-hour morning interval and a two-hour afternoon interval. Extraneous traffic predominantly consisted of guided tour groups, either on snowmobile or in snowcoaches that entered Yellowstone in the morning and departed in the afternoon. In most cases, the tours stopped at the pull-off east of the measurements to take photographs. This necessitated a pause during the measurements whenever a group came through. Temperatures during the measurements ranged from 16 to 38 degrees Fahrenheit. Relative humidity ranged from 51 to 89 percent. Wind speeds ranged from 0.0 to 13.4 mph, although acoustic measurements made during wind speeds greater than 12 mph were discarded.



2.3. Vehicle Description

Over the course of the three-day study, the team measured ten snowcoaches at two speeds* and at idle for both sides of each vehicle. In addition, the team measured six snowmobiles at full throttle for two different starting conditions for both sides of each vehicle and three snowmobiles were measured at two constant (cruise) speeds for both sides of each vehicle. A summary of the vehicles' manufacturer / model type, track type, and engine characteristics is provided in Table 3 for snowcoaches and in Table 4 for snowmobiles. These tables also indicate which test types were conducted for each vehicle. Snowmobiles were from the NPS administrative fleet, with the exception of the TZ1, which was a prototype on loan to the park. Photos of the vehicles are shown in Figure 6 through Figure 15.

In general, increasing the load of an OSV will increase its sound level. Two loading factors affected the test conditions, 1) the number of passengers and 2) snow conditions on the road. The snowcoaches tested had carrying capacities which ranged from eight to twenty passengers. It was not practical to test all snowcoaches at full capacity. For consistency, no passengers were used for the measurement runs. Thus, the sound levels measured represent the lowest levels that these vehicles would produce with respect to passenger load. Although the absolute sound levels during loaded operations will be higher, unloaded comparisons are reasonable to use to evaluate best available technology since they do allow for valid relative comparisons between vehicles.

Softer packed snow provides less traction and more drag, requiring OSVs to operate at higher engine speeds to obtain the same vehicle speed. It was originally planned to have a road groomer available to groom the road at least every night if not more periodically, however, it was not possible to get the groomer to maintain the road as required. Therefore, the snow pack got progressively softer with each successive day. With increasing use, the softer packed snow also developed dips and ruts which made operation of the OSVs at high speeds unsafe. Thus some snowcoaches were not tested at high speed (as represented by N/A on Table 7).

2.4. Equipment Description (Acoustics, Meteorology, and Speed)

Three acoustic systems, one meteorological system, and two radar guns were used to collect the requisite data.

2.4.1. Acoustic System

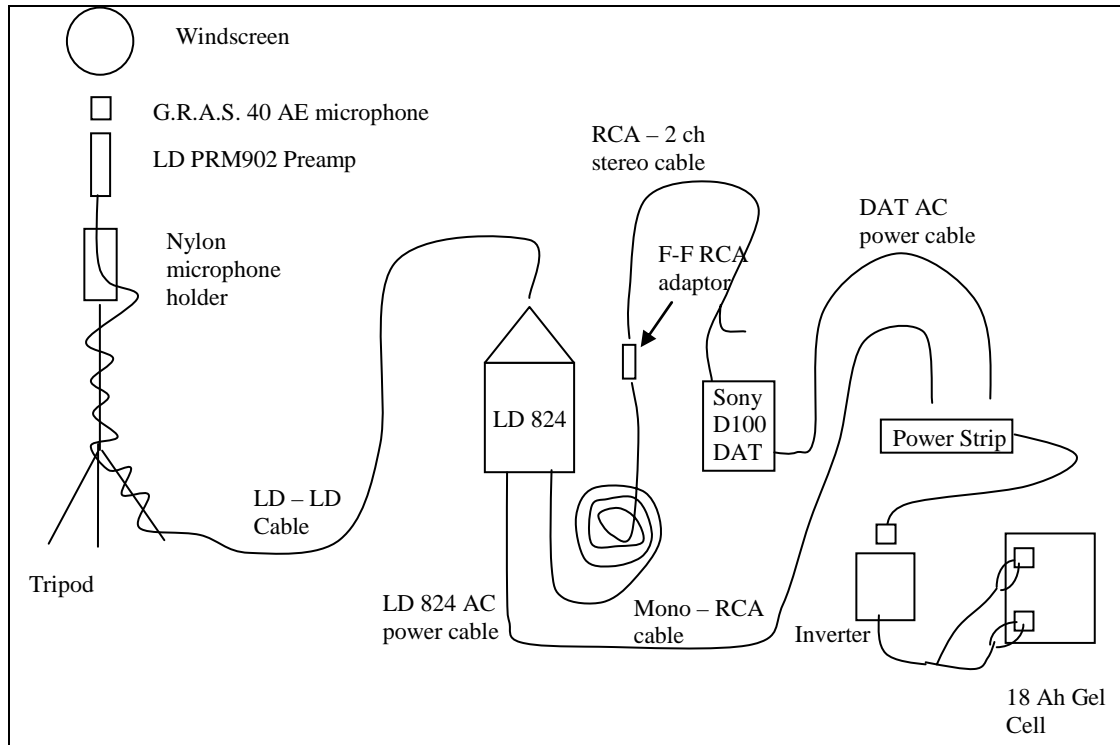


Figure 16. Acoustic System Setup

Each acoustic system consisted of a Larson Davis Model 824 Real Time Analyzer (LD824) a G.R.A.S. 40AE microphone and a Sony D100 DAT recorder as backup to the LD824. Figure 16 shows a block diagram of the acoustic system. The LD-LD cables were used to connect the microphone / preamp to the LD824 positioned at the measurement table, so that all acoustic systems could be monitored at a single location. Care was taken to insure that no connections were exposed to moisture. This involved using plastic bags to cover connections and, wherever possible, keeping cables off the snow.

One-half second samples were used for the 50 foot microphone at a height of 4 feet above the snow cover while 1 second samples were used for the remaining microphones*. At all microphone locations the overall L_{Aeq} and L_{ASmx} were stored in the LD824s. One-third octave band levels were also stored for each sample. Additional information on the LD824 and the Sony D100 DAT is provided in Appendix A and Appendix B.

2.4.2. Meteorological Equipment

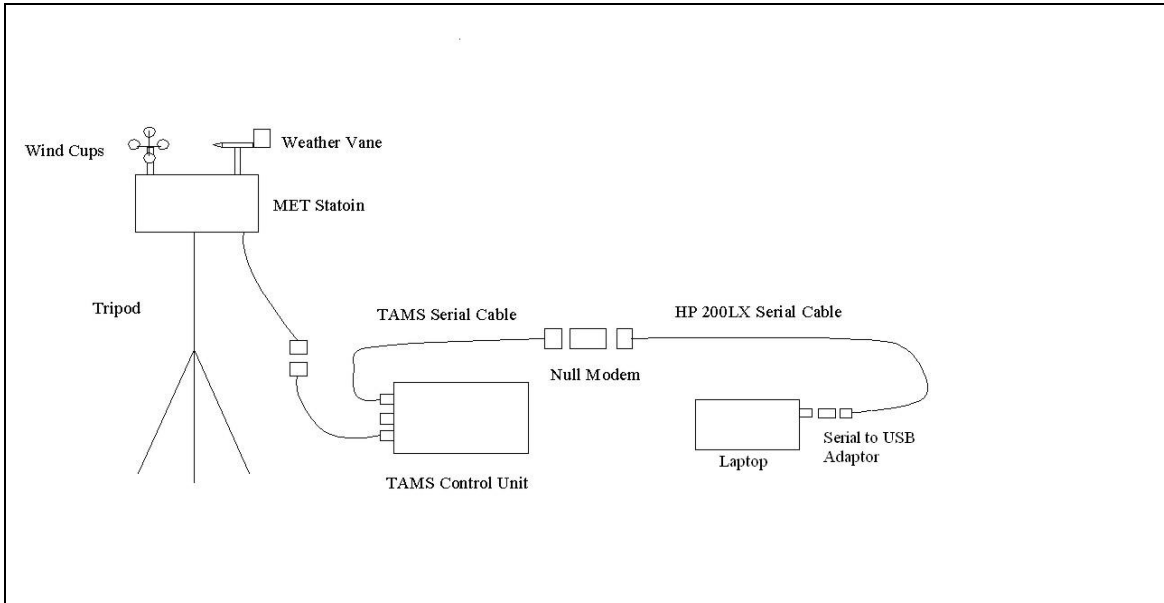


Figure 17. TAMS Setup

A Qualimetrics Transportable Automated Meteorological Station (TAMS) was used to measure wind speed, wind direction, relative humidity, and air temperature at one-second intervals. A complete TAMS system consists of a sensor unit and a control / display unit that displays real time meteorological data. These battery-powered stations are portable and well suited for remote sampling. Table 5 shows the metrics collected and the operating accuracy and Figure 17 shows a block diagram of the system. The unit's sensors were placed on a tripod at a height of 4 feet above the snow cover. Data from the control unit is automatically displayed and saved onto a laptop using TAMS Analysis software which can be viewed in real-time. Additional information on the TAMS unit is provided in Appendix C.

* A 1 second sample was used for the 50 foot microphone at a height of 4 feet above the snow cover on the first day. For the second and third day the sample period was changed to 1/2 second.

2.4.3. Vehicle Speed Collection (Doppler-Radar Gun)

Two Doppler-radar detectors were used to measure vehicle speed. One was situated at each end of the 400-foot span along the travel path centered at the microphone line. Their locations are indicated in Figure 4. Each radar detector was used to measure the speed of vehicles approaching the given radar detector location.



3. Measurement Methodology

This section details the measurement methodologies with specific references to SAE J1161 and J192. The measurements were conducted jointly by the NPS and Volpe. The NPS provided the vehicles, the measurement site, tools to help OSV drivers control their speed during the measurements, and staff to assist. Volpe provided acoustic, meteorological, and speed measurement equipment (see Section 2) and staff to conduct the measurements. Details of the measurement protocol and a sample log sheet are given in Appendix D.

3.1. Methodology in Accordance with SAE International Standard J1161

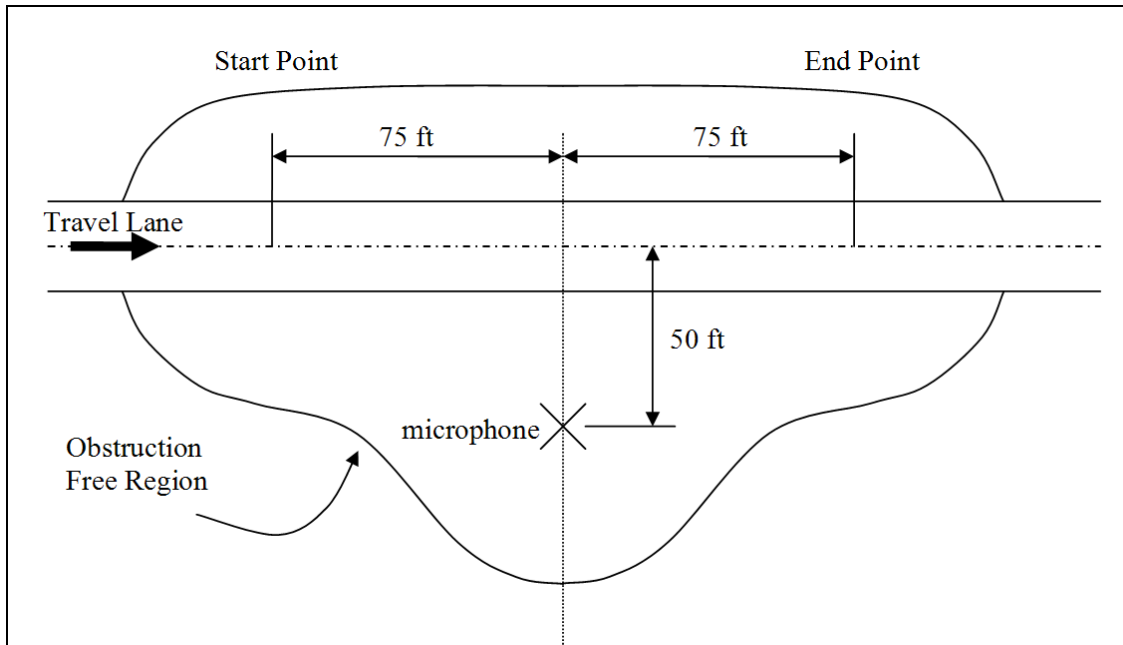


Figure 18. SAE J1161 / SAE J192 Measurement Area Layout

SAE J1161 specifies a methodology for the measurement of operational sound levels for OSVs. The measurement area is required to be an open region of packed snow at least 2 inches deep* which is free of reflecting surfaces. The snow pack is required to be sufficient to support the OSV without penetration with no more than 3 inches of loose snow on top of the packed snow. An illustration of the measurement area is provided in Figure 18.

The OSV approaches the measurement area at a speed of 15 mph and maintains this speed throughout the area. The microphone / sound level meter is required to be positioned 50 feet from the center of the travel lane and 4 feet above the snow cover (see Figure 18). The sound level meter should be set to measure the maximum A-weighted sound pressure level with slow time weighting (L_{ASmx}) as the vehicle passes at a constant speed of 15 mph. Measurements are repeated until three L_{ASmx} values are within 2 dB. These L_{ASmx} values are then arithmetically averaged and rounded to the nearest integer. The measurements are conducted for the vehicle traveling in both directions and the side of the vehicle with the highest average is reported as the sound level for the OSV. When drivers are traveling towards Grand Teton, the microphones are on their right hand side, this is documented as the “right side” of the vehicle. When drivers are traveling towards Yellowstone, the microphones are on their left hand side, this is documented as the “left side” of the vehicle. An example of the sound level calculation is given in Table 6.

During the measurements, the standard specifies that atmospheric temperature, pressure, relative humidity, wind speed and direction be measured at recorded intervals of not less than 1 hour. Further details are given in Reference 11.

3.2. Methodology in Accordance with SAE International Standard J192

SAE J192 specifies a methodology for the measurement of maximum exterior sound levels for snowmobiles. This standard is the same as SAE J1161 with the exception that it is specified for snowmobiles only (not OSVs in general), that vehicles are intended to be measured at full throttle rather than at continuous speed, and, for the 1985 revision, a fast time response is specified.

Two revisions of SAE J192, 1985 and 2003, were used during the study. The 1985 revision specifies that the snowmobile start with zero initial speed at the start point (see Figure 18) and then maintain full throttle as it travels through the measurement area. The 2003 revision specifies that the snowmobile approach the start point with an initial speed of 15 mph and then maintain full throttle as it travels through the measurement area. Further details of this methodology are provided in Reference 12.

3.3. Additional Measurements

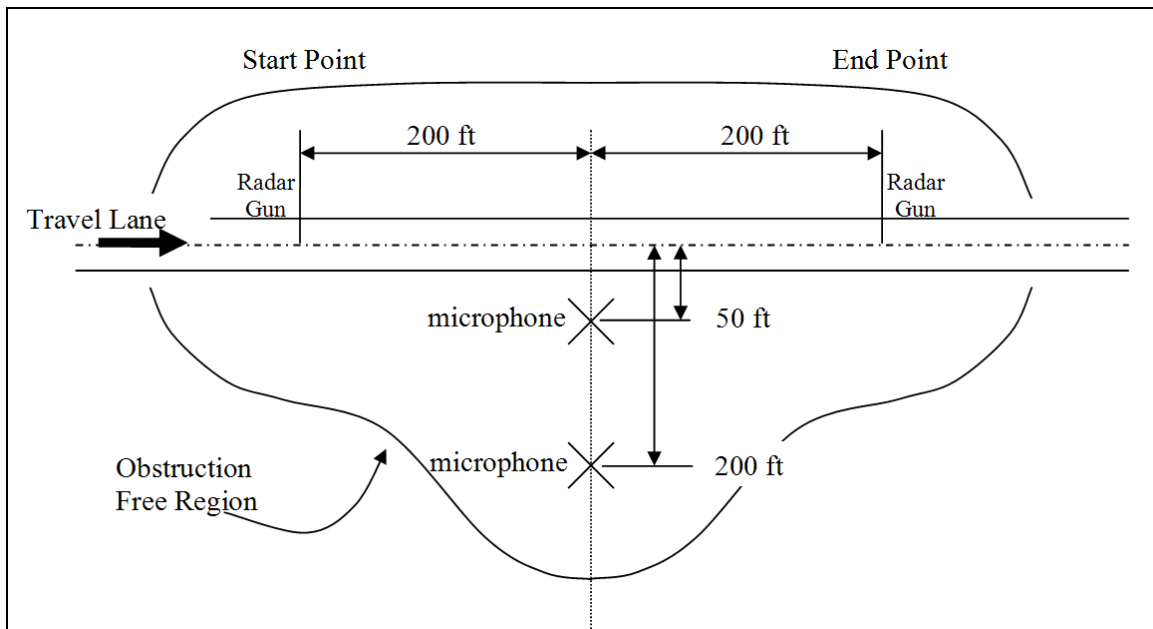


Figure 19. Extended Measurement Area Layout

In order to maximize the data obtained during the study, vehicles were operated under additional operating conditions, additional microphones were utilized, and the measurements were made over an extended measurement area. The measurement area was extended to cover a region from 200 feet on either side of the microphone line

instead of the 75 feet on either side*. See Figure 19. The extension to 200 feet on either side provided sufficient distance to assure a 10 dB drop from the maximum level, so that Sound Exposure Levels (SELs) could also be readily computed.

In addition to the microphone required by SAE J1161 and SAE J192, two additional microphones were used in the study. One microphone was positioned at the 50 foot location but with a height of 15 feet above the snow cover. This microphone was intended to provide a measurement that was less influenced by the ground cover. A second microphone was set at 200 feet from the travel lane at a height of 4 feet above the snow cover. This microphone was intended to provide a second measurement near the ground so that comparisons can be made with the 50 foot microphone in order to evaluate the ground attenuation over distance at the site.

Additional operating conditions were also measured for the snow coaches and included measurements at idle and at high constant speed. Idle measurements consisted of one minute of L_{Aeq} measurements made for each side of the vehicle. High constant speed tests were vehicle dependent, that is, the vehicles were operated at the highest speed that could be maintained over the course, typically about 30 mph.

3.4. Meteorological Measurements

Meteorological measurements were made throughout the measurement period and recorded at 1 second intervals. This is a higher temporal resolution than required by the SAE J1161 and J192 standards, but allows for increased quality control of the measurements, especially with respect to wind speed. Temperature, relative humidity,

* For the SAE J192 type measurements the 150 ft measurement area was maintained because increasing the area would effect the speed reached at the microphone line and beyond.



wind speed, and wind direction were measured by using a TAMS system located 100 feet from the center of the road, inline with the microphones. These data were displayed and recorded on a laptop computer which was located at the measurement table, as discussed in Section 2.4.1. The wind speed was monitored in order to avoid making measurement runs when the wind speed was above 12 mph.



4. Results and Analysis

Processed results and analysis are presented in this section. Analysis focuses on two of the primary objectives: 1) to determine which snowcoaches had the Best Available Technology (BAT) with respect to noise emissions, and 2) to determine if there was a significant difference between snowmobile sound levels when tested using two different methodologies. Additional analysis examines the attenuation due to the snow bank and the ground attenuation over the distance between the 50 and 200 foot microphones.

4.1. Ambient and Meteorological Conditions

A summary of the meteorological data is provided in Table 7. The primary concern during the measurements was wind speed. Although wind speeds exceeded 12 mph on both the 26th and the 28th, care was taken to avoid making measurements during such periods. High wind speeds were not observed on the 27th.

During measurements, the primary sound sources which contributed to the ambient level included OSVs operated at other locations in the parks, birds, running water, and wind / vegetation sound. Ambient levels ranged from 34 to 37 dB(A) on the 26th, 19 to 27 dB(A) on the 27th, and 34 to 39 dB(A) on the 28th. The lower ambient levels observed on the 27th, for example 19 dB(A), are likely influenced by the instrumentation noise floor, thus the true ambient level may be even lower. The higher ambient levels included more human generated sound and higher wind speeds. For the purposes of this study, these estimates of the ambient level provide a conservative limit for comparison with vehicle noise measurements.

4.2. Best Available Technology (BAT) for Snowcoach Noise Emissions

Ten snowcoaches were measured following guidelines in SAE J1161. These data have been processed to provide information that can be used to evaluate BAT qualification. Note, because there was partial Line-of-Sight (LOS) blockage due to the difference in height between the road and the snow cover adjacent to the road where the measurements were made, relative comparisons can be made between the ten snowcoaches measured as part of this project, but comparisons to snowcoaches measured at other times or locations may not be appropriate (but see Section 5).



4.2.1. Sound Level Time History

Although the primary noise metric for SAE J1161 and SAE J192 is the maximum A-weighted sound pressure level with slow exponential time weighted averaging, L_{ASmx} , an additional useful metric for examining time histories is the equivalent continuous sound pressure level, $L_{Aeq\Delta t}$, where Δt is the duration of the measurement. (L_{Aeqs} are needed for the computation of the Sound Exposure Level (SEL) as will be discussed in Section 4.2.4.)

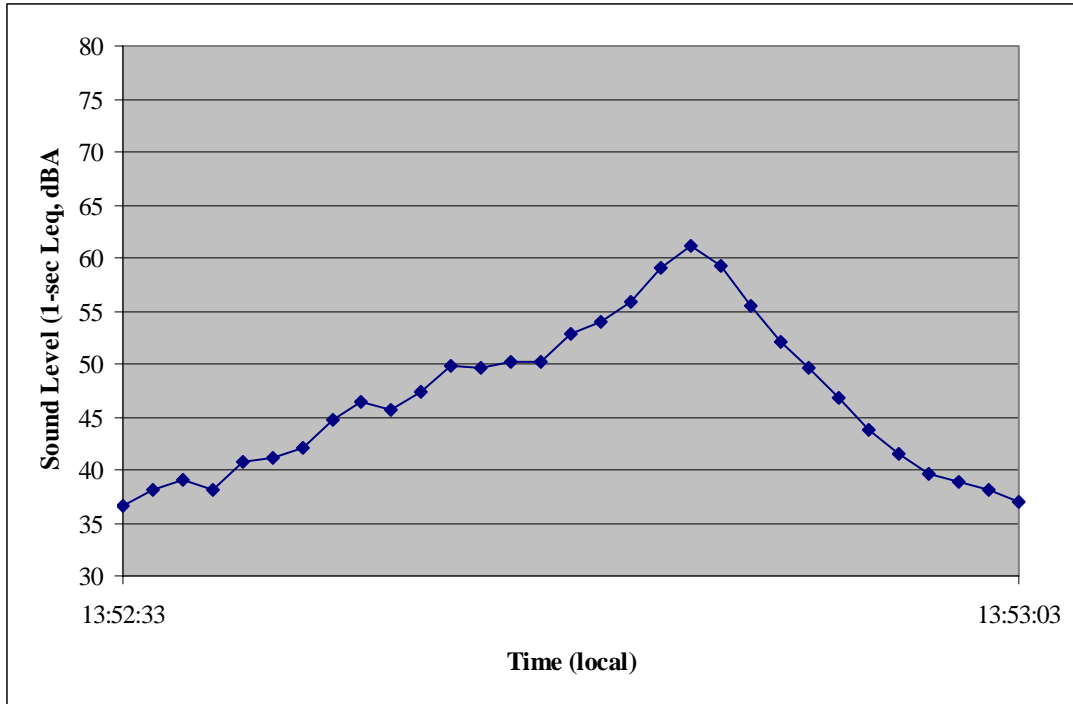


Figure 20. Goosewing Diesel Van, Right Side at Low (15 mph) Speed (Feb 26th)

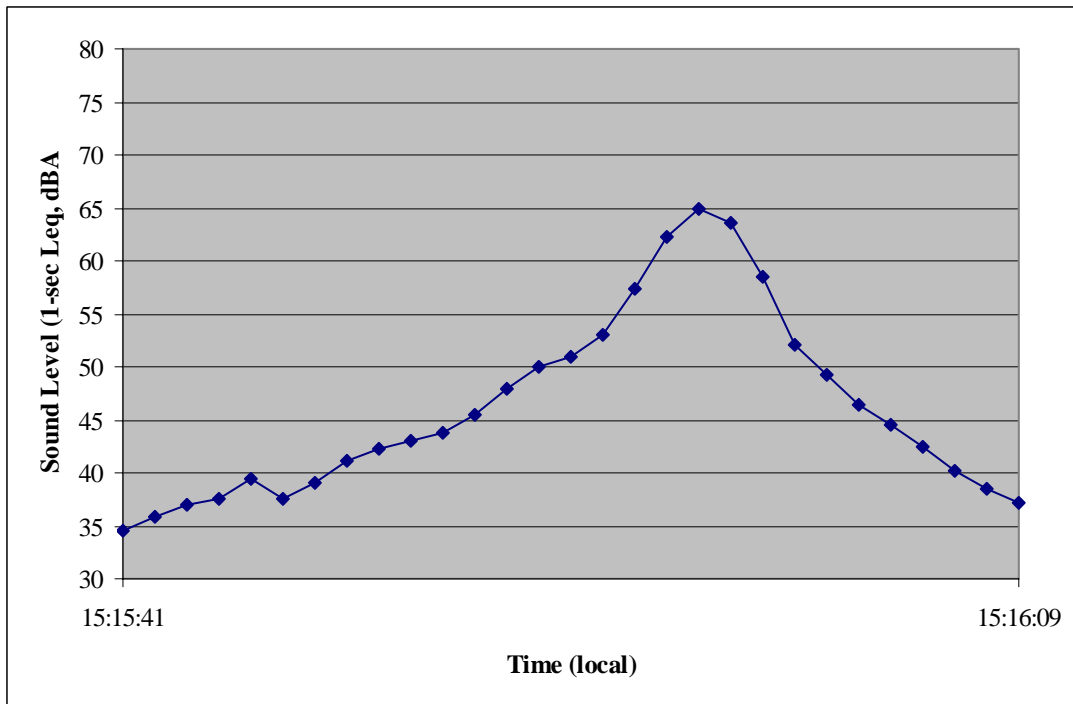


Figure 21. Goosewing Diesel Van, Left Side at High (30 mph) Speed (Feb 26th)

An example $L_{Aeq\Delta t}$ time history is shown in Figure 20 over 1 second intervals ($L_{Aeq1sec}$) for the Goosewing Diesel Van snowcoach measured during a low speed passby on February 26th. This figure shows the general pattern observed for all passby events: values increase as the vehicle approaches the microphone center line; there is a peak region; values decrease as the OSV travels away from the microphone center line. Another important feature to observe is that the peak level is at least 10 dB greater than the lowest approach and lowest departure levels. This indicates that a clean passby was acquired and that analysis using these data will not be unduly contaminated with sound sources other than the vehicle under study. An example time history profile is given in Figure 21 for a high-speed passby of the Goosewing Diesel Van snowcoach.

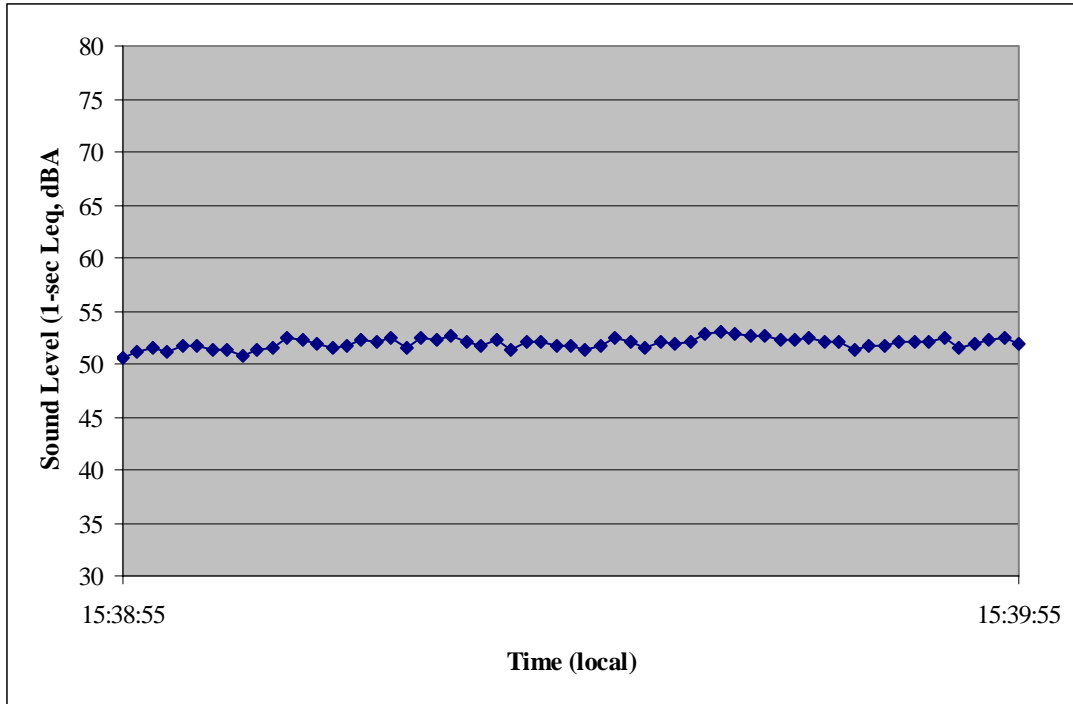


Figure 22. Goosewing Diesel Van, Left Side at Idle (Feb 26th)

An example idle measurement time history is shown in Figure 22 for the Goosewing Diesel Van snowcoach measured on February 26th. The profile is different here because the vehicle is stationary and neither approaches nor departs the microphone line during the measurement. Because the level does not change significantly over the measurement period it is not readily apparent that this is a clean measurement. In order to verify that these data are not contaminated by extraneous sounds, these data are compared with ambient levels. The ambient level was about 17 dB(A) lower than the idle level for this particular measurement and is therefore also considered a clean measurement. An example sound level time history is provided for each vehicle at each speed measured in Appendix E.

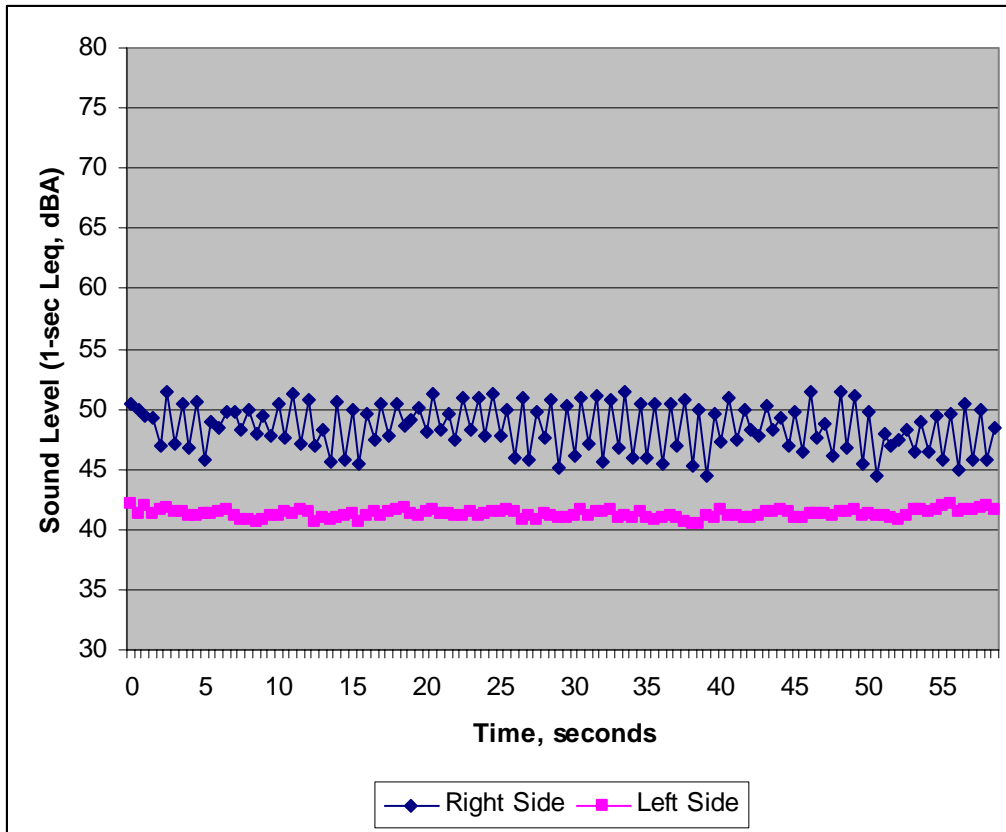


Figure 23. Xanterra 707 Idle (Feb 27th)

An example of the difference between the sound levels on the two sides of a vehicle is given in Figure 23 for the Xanterra 707. Here, the right side of the vehicle had the highest idle level. This side of the vehicle had a strong aspirated sound which showed up as a rhythmic level variation between 2 and 5 dB per sample. The right side of the vehicle had a lower, more steady idle level. Typically, time varying sounds are more noticeable than sounds that do not fluctuate. Therefore this rhythmic level variation may be more objectionable to park visitors. If the high side could be controlled so that its noise emission was the same as the lower side, this vehicle's idle level could be reduced by 8 to 9 dB. Note, that the Xanterra 707's engine is not fully enclosed (see Figure 11), therefore efforts to enclose the engine may help reduce the idle level.

4.2.2. Overall Level (L_{ASmx}) Associated with Each Vehicle

Table 8 rank orders the ten snowcoaches measured from highest to lowest maximum A-weighted sound pressure levels with slow time weighting (L_{ASmx}) for a constant speed of 15 mph (nominal). The values listed in Table 8 are the arithmetically averaged L_{ASmx} values for the passby direction which yielded the highest average value. Averages of the measured speeds are specified in the last column. Table 9 rank orders the ten snowcoaches measured from highest to lowest based on the arithmetically averaged L_{ASmx} values for the passby direction which yielded the highest average value for a constant speed of 30 mph (nominal). Averages of the measured speeds are specified in the last column.

The Yellowstone Expeditions and Alpen Guide snowcoaches consistently had lower sound levels at both speeds. The NPS snowcoach had high sound levels at low speeds but high speed measurements were not possible. Even so, the NPS snowcoaches' low speed sound levels are comparable to other snowcoach high speed measurements. A summary of all the L_{ASmx} values that were used to produce the reported maximum levels is provided in Appendix F.

Table 10 rank orders the ten snowcoaches measured from highest to lowest based on the arithmetically averaged L_{Aeq} values for the idle orientation with the highest level. In this case, instead of averaging passby measurements, a one-minute period of L_{eq1sec} values were averaged. The levels at idle of several snowcoaches were close to the ambient, indicating that at least some of the energy in the reported level is contaminated by the ambient. This would cause these levels to overestimate the true idle levels of these vehicles, so these levels should be considered a conservative estimate of the idle levels. Idle measurements with levels that are within 10 dB of the ambient are marked with an asterisk (*) in Table 10.

Whereas levels during passby measurements are due to a combination of engine / exhaust, drive train, and ski / track noise, idle levels are predominantly due to engine / exhaust noise alone. Both the Xanterra 165 and Xanterra 431 had low idle levels. These were late model Chevrolet van conversions, while for example, the Xanterra 707 was an older Bombardier B-12. Both the Xanterra 165 and Xanterra 707 were fitted with 5.7 liter V8 GMC engines, so modifications to the engine alone is not always sufficient to reduce noise emissions. Modifications may also need to be made, for example, to the



exhaust and shielding. Further investigation into OSV specifications is needed to determine all factors that contribute to BAT.

4.2.3. Noise vs. Speed Plots

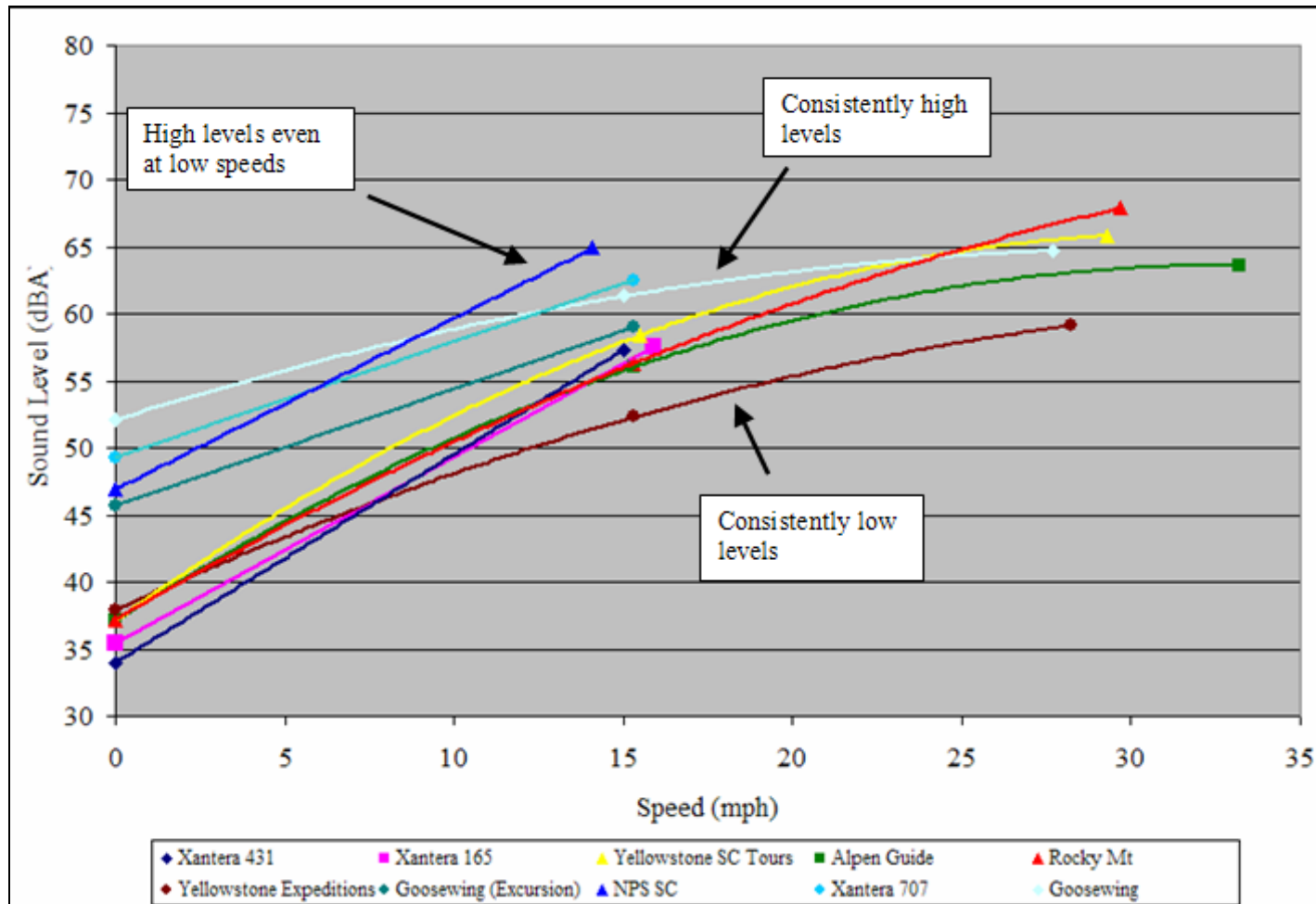


Figure 24. Sound Level vs. Speed*

The passby levels for high and low speeds were combined with idle levels to generate noise-speed curves as shown in Figure 24. This plot essentially presents the data from Table 8, Table 9, and Table 10 graphically for easier comparison. The Yellowstone Expeditions snowcoach consistently has the lowest overall noise profile over the speed range tested while the Goosewing Diesel Van has the highest. The Xanterra 707 and the NPS snowcoach also had high levels at idle and the highest level at low speed. They did not have data at high speed. Interestingly, the Xanterra 707 and the Alpen Guide are both Bombardier B-12 models. The Alpen Guide had a 2002 5.3 liter gasoline V8 while the Xanterra 707 had a 1990 5.7 liter gasoline V8. The Xanterra 707 was consistently noisier than the Alpen Guide, especially at low speeds. The difference is most pronounced at idle, where, as mentioned previously the Xanterra 707 had an unusual rhythmic variation in sound level.

4.2.4. Sound Exposure Level (SEL), dB(A)

The overall sound exposure level (SEL) due to a snowcoach passby gives another indication of the noise performance of the snowcoach. The SEL can be estimated from the stored LD824 data by using the following equation:

$$SEL = 10 \log_{10} \left(\Delta t \sum_{i=1}^N 10^{L_{Aeq\Delta t}(i)/10} \right),$$

where Δt is the time period for each record, $L_{Aeq\Delta t}(i)$ is the i^{th} $L_{Aeq\Delta t}$ measured, i is the record increment that includes the minimum number of measurements that provide a 10 dB drop from the peak $L_{Aeq\Delta t}$ for both the approach and departure during the passby. Because the SEL is an integration of the energy over the exposure period, a vehicle with a slow increase / decrease can have a greater SEL than a vehicle with the highest L_{ASmx} .

The SELs reported in Table 11 and Table 12 are energy averages of all passby measurements that were used in the calculation of L_{ASmx} for Table 8 and Table 9. Thus, the SEL equation was modified as follows:

$$SEL = 10 \log_{10} \left(\frac{\Delta t}{M} \sum_{i=1}^N 10^{L_{Aeq\Delta t}(i)/10} \right),$$

where M is the number of passby events and i iterates through three passby events. Allowing for order reversals between adjacent snowcoaches, the rank ordering based on SEL for these snowcoaches generally follows the rank ordering based on L_{ASmx} .

4.2.5. Sound Level Spectra

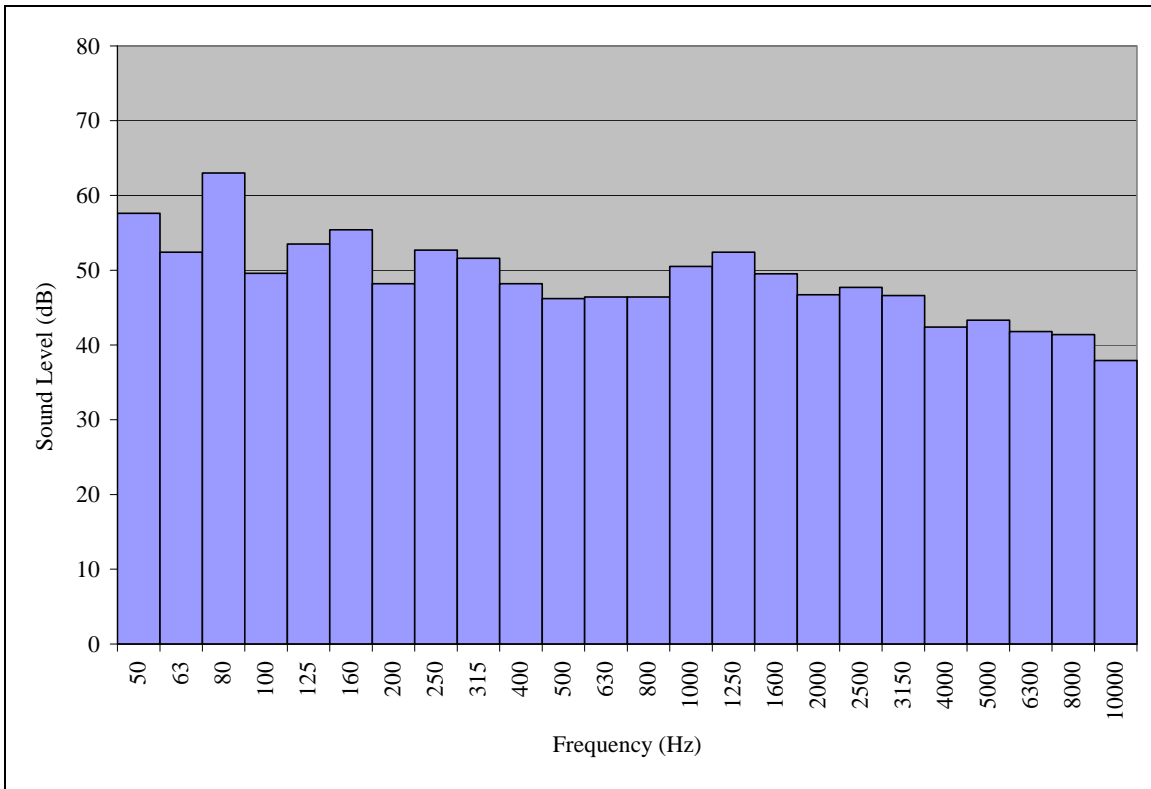


Figure 25. Goosewing Diesel Van, Right Side (Feb 26th, 13:52) Spectra for Low Speed

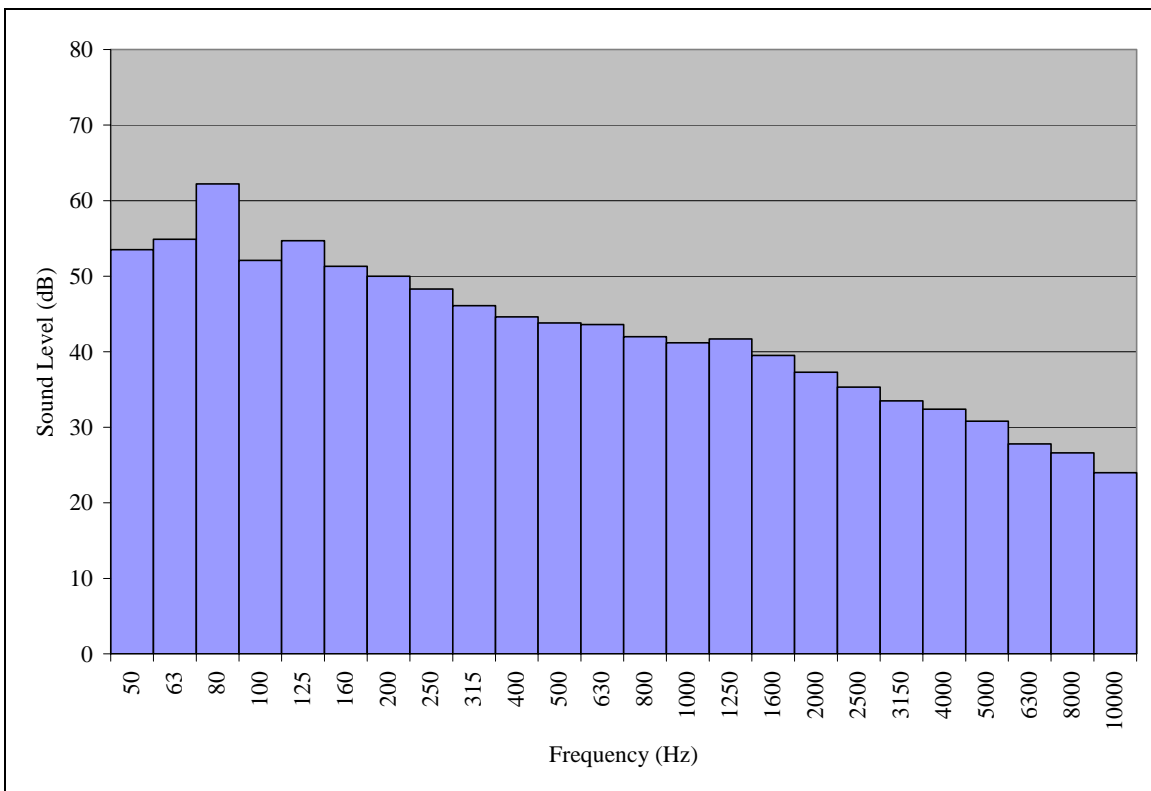


Figure 26. Yellowstone Expedition, Right Side (Feb 26, 12:53) Spectra for Low Speed

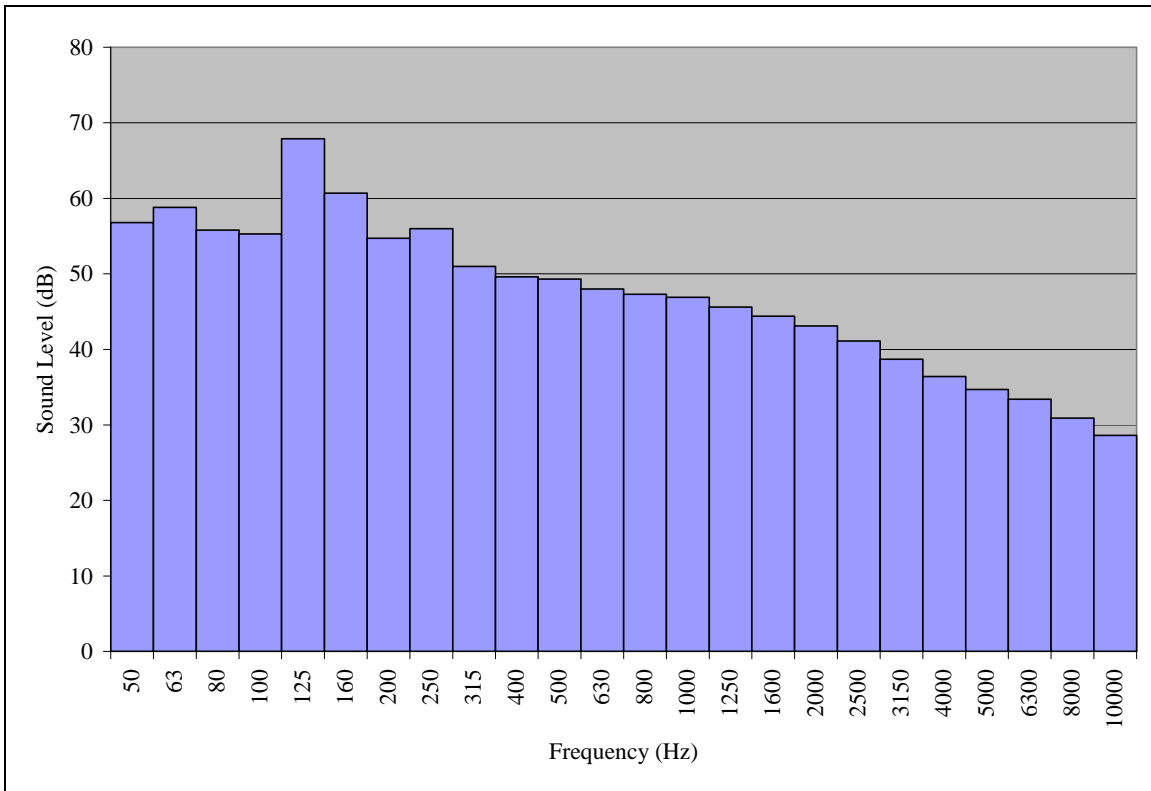


Figure 27. Yellowstone Expedition, Left Side (Feb 26, 14:18) Spectra for High Speed

For each record in the sound level time histories, there is an associated unweighted one-third octave band spectrum. The spectrum associated with the L_{ASmx}^* during one passby of the Goosewing Diesel Van measured at low speed on February 26th is shown as an example in Figure 25. Here, the general pattern of decreasing level with increasing one-third octave band center frequency can be seen. Additionally, occasional increases in a third-octave band can be seen. Generally these spectral peaks are associated with engine or drive train harmonics at discrete frequencies and can be expected to increase in frequency with increasing engine speed. The effect of increasing engine speed on spectral peaks or tones can be seen in Figure 26 and Figure 27. In Figure 26 a spectral peak can be seen in the 80 Hz one-third octave band for the Yellowstone Expedition snowcoach traveling at slow speed. When this snowcoach travels at high speed (with increased engine rpm), the spectral peak shifts to the 125 Hz one-third octave band.

Unweighted one-third octave band spectra associated with the passby time histories in Appendix E are provided in Appendix G.

* The $L_{Aeq\Delta t}$ is most appropriate for examining time histories, but the L_{ASmx} gives a better indication of the maximum level during a passby.

4.3. Comparison of SAE J192 (1985) and SAE J192 (2003)

The NPS wished to determine if there is a significant difference in the maximum exterior noise level obtained when testing snowmobiles to the 1985 versus the 2003 revision of SAE J192. The key differences between the two revisions are given in Table 13.

The analysis of the difference between the two revisions was conducted in two stages. In the first stage, the effect of starting from either 0 or 15 mph was analyzed. In this stage, slow response was used for both starting speeds. In general, changing the starting speed from 0 to 15 mph produces essentially identical results. On average, the results from a starting speed of 15 mph were about 0.2 dB higher than the results from a starting speed of 0 mph. Run-to-run results have a standard deviation of about 0.4 dB, so these variations are on the same order of magnitude as the run-to-run variations.

In the next stage of this analysis, the levels for 0 mph starting speeds were determined using a fast time response, L_{AFmax} . Since the different starting speeds were shown to produce essentially the same results, the differences between the two methods can be mostly attributed to the difference in the time response used. Thus, the effect of the different time response can be seen by comparing the 1985 and 2003 revisions as given in Table 14. The difference between the two revisions is shown in the last column, where the results for the 2003 revision are subtracted from the results from the 1985 revision. Here it can be seen that using the fast time response results in values that are a little less than 2 dB higher than those for the slow time response*. This is expected since the fast time response allows the level to rise faster as the snowmobile passes by the microphone. Therefore, vehicles which are just under the acceptable sound limit based on the 2003 revision may turn out to be over the limit when using the 1985 revision.

* While this difference is greater than the run-to-run variation, it is less than the standard's stated measurement uncertainty of +/- 2 dB. (Ref. 12 comment 6.7)

4.4. Snowmobiles at Constant Speed

During the study, there was an opportunity to measure three of the snowmobiles, TZ1, T660(2), and T660(4), at constant speeds, much in the same way as was done for the snowcoaches. The results of these opportunistic measurements are given in the following tables. The rank order was preserved for both high and low speeds for both the L_{ASmx} and for the SEL. The TZ1 consistently had the highest levels.

4.5. Ground Attenuation

In order to estimate the attenuation of snow-covered ground for the OSVs, the maximum L_{ASmx} values for passby events at the 50 foot location 4 feet above the snow cover were compared with the L_{ASmx} values at the 200 foot location 4 feet above the snow cover. Attenuation due to spherical divergence for a point source is $20 \times \log_{10}(2)$ per doubling of distance, or about 6 dB per doubling. So, the attenuation due to divergence between the 50 and 200 foot microphones should be 12 dB. Atmospheric attenuation is small over this distance for these sounds, and can effectively be neglected. Once spherical divergence is accounted for, the differences between the levels at the 50 foot and 200 foot microphones can effectively be attributed to excess ground attenuation. The estimated ground attenuation for three snowcoaches are shown in Table 19. These snowcoaches were selected from the measurements on the 27th, the day which had the lowest overall winds. On average, the ground attenuation was about 4.7 dB. Ground attenuation is typically limited to about 20 dB as the distance between the source and receiver increases, due to the effects of turbulence and scattering (Ref. 14).

To see how this ground attenuation compared with ground attenuation for other surfaces, the Federal Highway Administration’s (FHWA’s) Traffic Noise Model (TNM) (Ref. 15, 16, 17) was used to evaluate the ground attenuation of a typical lawn and of field grass. The ground attenuation was determined over the range from 50 to 200 feet from the source at a height of 4 feet above the ground using medium trucks. On average over this distance, lawn had a ground attenuation of 2.5 dB per distance doubling, field grass had a ground attenuation of 3.0 dB per distance doubling, granular snow had a ground attenuation of 3.2 dB per distance doubling and powder snow had a ground attenuation of 3.6 dB per distance doubling. It is reasonable to obtain a ground attenuation of 4.7 dB per distance doubling for the deep snow present at the measurement site.

4.6. Snow Bank (Barrier) Effects

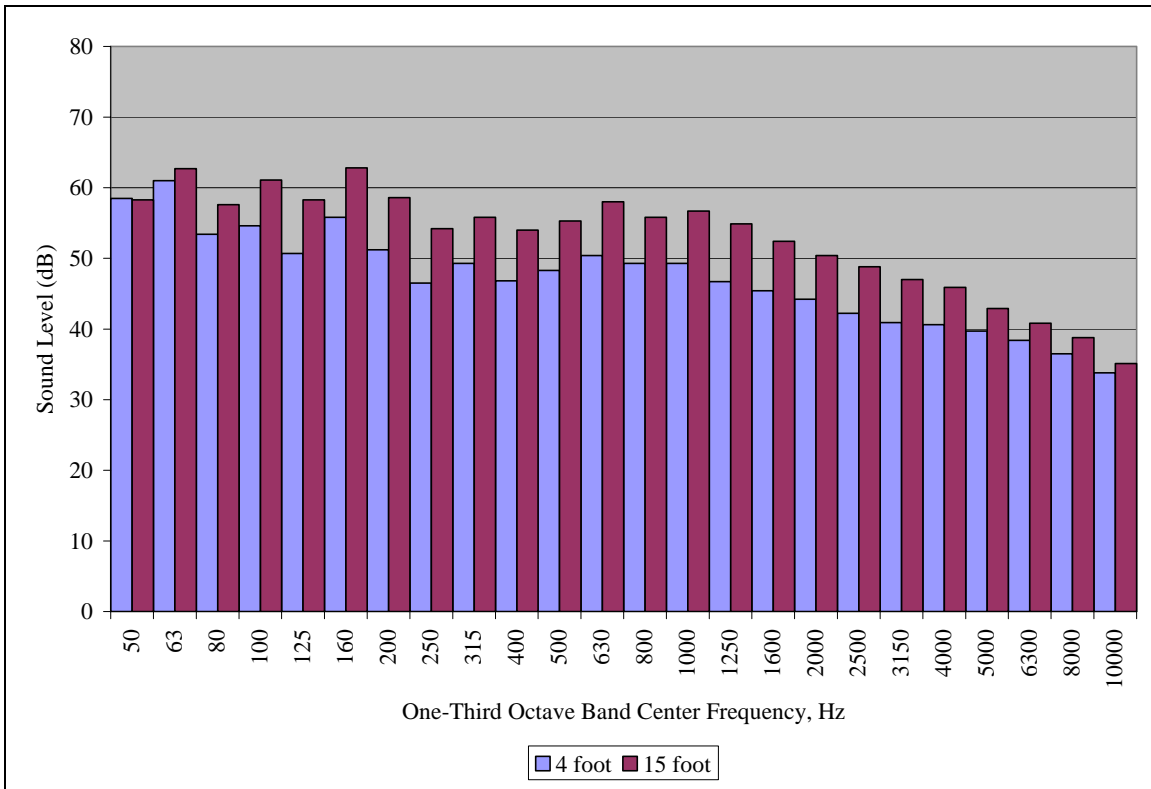


Figure 28. Xanterra 165, Left Side (Feb 27, 11:50) One-Third Octave Band Spectra for the Microphones 4 and 15 foot above the Snow Cover at 50 feet from the Travel Lane

As mentioned in Section 2.1, the measurement site was less than ideal with regard to variations in the vertical profile. To investigate the influence of the wayside snow bank on the measured sound levels, one-third octave band spectra from both 50 foot microphones were compared. This approach seemed appropriate since the 15 foot microphone had clear line-of-sight to all OSV sound sources under study. This was not the case for the 4 foot microphones due to the snow bank. Sample spectra are shown in Figure 28 for a Xanterra 165 passby event at low speed. In this figure, the 15 foot one-third octave bands are shown next to the corresponding 4 foot one-third octave bands. It can be seen that for all but the highest frequencies the two spectral profiles are about the same, that is, the difference does not seem to be frequency dependent. If the snow bank were significantly shielding the 4 foot microphone, its spectrum would roll off at about 6 dB per octave relative to the 15 foot microphone at higher frequencies. Since this roll-off is not observed, it seems that the barrier effect of the wayside snow bank is likely relatively small for the 4 foot microphone. This is especially true for the overall level.

5. Summary and Conclusions

The maximum A-weighted sound pressure levels with slow time response were measured for ten snowcoaches during constant speed passby events. Measurements were made for each vehicle side and the side with the highest average (based on three measurements within 2 dB) was assigned as the vehicle's passby noise level. Additionally, idle noise levels were also determined. Based on the low speed results, the NPS snowcoach had the highest noise levels while the Yellowstone Expeditions snowcoach had the lowest noise levels. High speed results were incomplete due to deteriorating road conditions on the second and third measurement days, however, of the five snowcoaches that were measured at high speed, the Rocky Mountain snowcoach had the highest level and the Yellowstone Expeditions had the lowest level. The Xanterra 165 and the Xanterra 431 had the lowest measured idle levels. More complete rankings can be found in Table 8, Table 9, and Table 10. All snow coaches met NPS' 73 dB BAT sound level limit for the speeds tested. Two Bombardier B-12 snowcoaches, one operated by Alpen Guide and one operated by Xanterra had very different sound levels. The Xanterra B-12 was about 11 dB higher than the Alpen Guide at idle and about 7 dB higher at 15 mph. Design differences between these two snowcoaches may provide insight into methods to decrease the Xanterra B-12 sound levels. The Yellowstone Expeditions' snowcoach provides one example of a snowcoach which may meet new limits should the NPS decide to lower the limit in the future.

The maximum A-weighted sound pressure levels with fast and slow time response were measured for six snowmobiles during full throttle passby events for two starting speeds 1) 0 mph and 2) 15 mph. Multiple measurements were made for each vehicle side and the side with the highest average (based on three measurements within 2 dB) was assigned as the vehicle's passby noise level. The two starting speeds produced similar results with an average difference of 0.2 dB(A). The use of the fast time response resulted in an increase of about 2 dB on average over the slow time response. The 1985 revision of SAE J192 specifies a fast time response and a starting speed of 0 mph. The 2003 revision specifies a slow time response and a starting speed of 15 mph. Therefore, snowmobiles tested according to the 1985 revision are expected to produce levels about 2 dB higher than the 2003 revision, due solely to the difference in specified time response.

Although the height difference between the road and the ground on either side of the road was initially a concern, analysis of the spectra between the 4 foot high and 15 foot high microphones suggests that the snow-barrier effect did not substantially effect the overall results. Therefore the data measured on these three days may be cautiously compared with other measurements made in accordance with SAE J1161 and SAE J192.

It was also observed that snow conditions on the road deteriorated substantially over the course of testing which made it impossible to test at high speeds on the second day. The 15 foot microphone was useful as a quality check, however, provided that the site is properly maintained, future testing should not require this microphone. Based on experiences during this study, the following recommendations are suggested for future measurement of snowcoach sound levels for the purpose of testing BAT conformance.



The measurements should adhere to SAE J1161 with the following modifications and considerations:

- Because of the altitude, barometric pressure specifications should be expanded to include typical pressures in the parks during the winter season. The sound level variation due to the lower barometric pressure could be corrected in a manner similar to the methods described in References 5 and 6.
- If a snow berm is present, all practical efforts to remove it should be implemented.
- If a snow berm greater than 3 feet tall cannot be removed, another site should be sought.
- Testing should be conducted for three conditions
 - Idle
 - 15 mph
 - A high speed to be determined by the park based on local speed limits, e.g., 30 mph, road speed limit, or a typical cruising speed.
- A road groomer should be kept on hand in order to ensure that the road conditions do not deteriorate over the course of the testing.
- If vehicles fail to meet BAT requirements at the high speed, consideration should be given to restrictions which would still allow the snowcoach to operate in the parks, but at a reduced speed.



Appendix A: Larson Davis Model 824 Sound Level Meter

This appendix provides some useful information on the settings, setup, and use of Larson Davis Model 824 sound level meters.

A.1 LD824 Settings

One-half second samples were used for the 50 foot microphone at a height of 4 feet above the snow cover while 1 second samples were used for the remaining microphones*. The following broadband metrics were stored with the same time periods as the captured data:

- Average A-weighted sound level (L_{Aeq}),
- Maximum A-weighted slow and fast values (L_{ASmax} , L_{AFmax}),
- Minimum A-weighted slow and fast values (L_{ASmin} , L_{AFmin}).

A.2 Check/apply Setup Parameters

1. Press **SETUP** button to access 824 virtual instruments menu.
2. Highlight **Edit Settings: *SLM&RTA SSA>** using $\uparrow\downarrow$ keys, then select by pressing $\sqrt{\quad}$ key.
3. On the Settings Page, use $\uparrow\downarrow$ keys to highlight desired feature, then $\sqrt{\quad}$, to access parameters (refer to summary of settings on the following page). Features include: **SLM, RTA, Intervals, Time History, Ln, Triggering, Advanced**. *Note: Gain settings can be found in SLM feature.*
4. Within each feature, use $\uparrow\downarrow$ to toggle through parameters. Select parameter using $\sqrt{\quad}$.
5. Parameter settings will appear in drop down menus. Use $\uparrow\downarrow$ to highlight, then $\sqrt{\quad}$ to apply desired settings. Back out of menu directories using \leftarrow key.
6. Repeat steps 3 through 5 for each feature until all desired settings have been applied.

* A 1 second sample was used for the 50 foot microphone at a height of 4 feet above the snow cover on the first day. For the second and third day the sample period was changed to ½ second.



A.3 Setting the Clock

1. Press **TOOLS** button. Use $\uparrow\downarrow$ to highlight **Clock/Timer**. Press \checkmark to select.
2. Press \checkmark again to enter **Clock/Timer** menu. Use $\uparrow\downarrow$ to highlight **Current Time** and \checkmark to select.
3. Use $\leftarrow \rightarrow$ to select hours, minutes, seconds, and $\uparrow\downarrow$ to alter values.
4. Press \checkmark to set time. Time will set and increment from the moment \checkmark is pressed.
5. Use same process to set **Current Date** and **Day Of Week**.
6. To view clock in real-time, from any feature, press **TOOLS**. Use $\uparrow\downarrow$ to highlight **Clock/Timer**. Press \checkmark to select.

A.4 Calibration

1. Press **TOOLS** button. Use $\uparrow\downarrow$ to highlight **Calibration**. Press \checkmark to select.
2. Press \checkmark again to enter **Calibration** menu. Ensure that **Cal Level** is set to desired level. If not, select (\checkmark) **Cal Level**; use arrow keys to change value, and \checkmark to enter appropriate setting.
3. Use $\uparrow\downarrow$ to highlight **Change**, then \checkmark . You will be prompted to make sure calibrator is active. If so, select (\checkmark) **YES**. Wait while calibration offset is being performed. Screen will go to Calibration readout with date, time and offset.
4. Calibration is complete. You may now select your desired **VIEW**.

A.5 Collect and Monitor Data

1. Press **VIEW**. Use $\uparrow\downarrow$ to highlight preferred instrument (SLM or RTA), then select (\checkmark).
2. Press **RUN/STOP** to collect data. Press again to stop data collection.



Appendix B: Sony Model TCD-100 DAT Recorder

This appendix provides useful information on the setup and use of Sony Model TCD-100 DAT recorders.

B.1 Sony DAT Settings

B.2 Check / Apply Setup Parameters

Sampling rate: 48 kHz or 44.1 kHz (CD compatible), 32 kHz in “LP” (half speed) mode

Input mode: Always set to “LINE”

Gain control: Always set to “MANUAL”

Tape duration: A 60-m (197-ft) tape will run for 2 hours at normal speed; 4 hours at LP half speed. Although the “LP” mode does not use linear PCM encoding, testing has established that amplitude linearity is good to within +/- 1.5 dB down to 85 dB below full-scale (0 VU).

B.3 Setting the Clock

1. Hold **CLOCK/SET** button until the date display flashes.
2. Adjust the value of flashing digits with the + & - buttons. Press **CLOCK/SET** button to advance to next digit. When setting seconds, the value can only be set to zero.
3. Start DAT clock by pressing **CLOCK/SET** button when time-base seconds reach zero. Internal clock ticks at own rate. Toggle between 12-hour time and 24-hour time by pressing and holding the + button for 3 seconds while the time is displayed.
4. To view clock in real-time, from any feature, press **TOOLS**. Use $\uparrow\downarrow$ to highlight **Clock/Timer**. Press \surd to select.



B.4 Operation Notes

1. The Input level control has a friction-lock, but care should be taken to prevent movement of the control after calibration. A small section of stiff card (or a piece special 3M tape) can be used to secure the control knob. This single control knob affects both channels equally. No independent adjustment of input levels is possible.
2. "AVLS" and Volume +/- controls affect the headphone output, but not the LINE output.
3. Allow ~30 seconds when recording, for ID marker to be written. Note that "START-ID" flashes in the display while the marker is being written. If recording is stopped before writing of marker is complete, the ID table may be scrambled.
4. Before recording, set display to "Absolute Time" by pressing the **COUNTER** button until "A-TIME" appears in the display. This indicates the absolute time from the start of the tape. Note that in "LP" mode, the value displayed is half of the actual elapsed time.
5. 6. To open the deck, slide the **OPEN** switch. Wait for "OPEN" to appear in the display before attempting to physically open the unit. Note that the deck will not open if the **LOCK** switch is engaged.
6. The **LOCK** switch will prevent most controls from operating - an important exception is the recording level control.
7. To view input signal levels, press the **RECORD** button. To prepare for recording, press **RECORD** and **PAUSE**. To record immediately, press **RECORD** and **PLAY**.
8. If the pause-record mode is enabled for more than 5 minute, the unit will time-out and drop out of this mode.
9. During recording, the current sample rate can be displayed by pressing the **PLAY** button.



Appendix C: Qualimetrics Transportable Automated Meteorological Station

This appendix provides useful information on the setup and use of TAMS units.

C.1 TAMS Unit Setup

1. Extend the tripod. Screw the tripod adapter on. Insert the met station onto the tripod adapter. Insert the anemometer and wind vane onto the appropriate sensors located at the top of the met station.
2. Use a compass to position the met station towards North as indicated on the figure shown on the side of the met station. Tighten the met station mounting clamp around the tripod adapter.
3. Connect the met station control cable to the bottom connector of the control/display unit.
4. Connect the RS232 output cable from the bottom connector of the control/display unit to the null modem adapter, to the HP 200 LX cable, then to the HP 200 LX.
5. Turn on the control/display unit.
6. Set the time on the control/display unit by pressing **SETUP** and the left arrow key until **Change Date/Time** is displayed and press **ENTER**. Type in the new time and press **ENTER**. Press the left arrow key again to set the date. Check the time and exit setup by pressing **SETUP**.
7. Check the data output settings by pressing **SETUP** and the left arrow key until **Change Data Output** is displayed and press **ENTER** four times. The display should now show **Computer Output is Enabled**. If it does not, press the left arrow key to toggle the setting to **Enabled**. Press **ENTER**.
8. The display should now show Output every 1 seconds. If it does not, press 1 to change the setting. Press **ENTER**. Press **SETUP** to exit setup.



Appendix D: Measurement Protocol and Logging Procedure

In order to facilitate orderly measurement of OSVs, the following protocol was instituted and found to be effective* :

- NPS and Volpe personnel determine what type of measurement will be conducted (constant speed or full throttle).
- NPS personnel specify vehicle to be measured.
- Volpe personnel note description of vehicle, check wind speed, and indicate readiness for measurement.
- NPS personnel indicate vehicle is beginning run.
- NPS personnel indicate vehicle speed to the OSV driver to allow the driver to maintain constant speed during passby[†].
- Volpe personnel[‡]:
 - note the rise and fall of the sound level on the LD824 as the vehicle travels through the measurement area,
 - note the maximum level displayed on the LD824,
 - confirm that the level at the start point and stop point were less than the maximum level by at least 10 dB, and
 - indicate any potentially contaminating sounds or wind levels greater than 12 mph, identifying the measurement as bad if appropriate.
- NPS personnel indicate if the vehicle strayed from a straight path along the travel path or if speed varied more than 2 mph from target speed, identifying the run as bad if appropriate.
- For the case of constant speed runs, NPS personnel indicate speed and Volpe personnel record the speed.
- Volpe personnel monitor the number of runs by each vehicle in each direction and announce when sufficient measurements are made for the specified vehicle under the specified operating condition.

* Communication between NPS and Volpe personnel was largely conducted by using radio transceivers. Radio silence was observed during measurement intervals.

[†] Vehicle speed was relayed to the OSV drivers by means of a lighted sign for vehicles traveling towards Grand Teton and by radio communication and hand signals for vehicles traveling towards Yellowstone.

[‡] For screening purposes $\frac{1}{2}$ second L_{Aeq} were monitored rather than L_{ASmx} . During the post-processing and analysis, L_{ASmx} were used in accordance with the SAE standards.

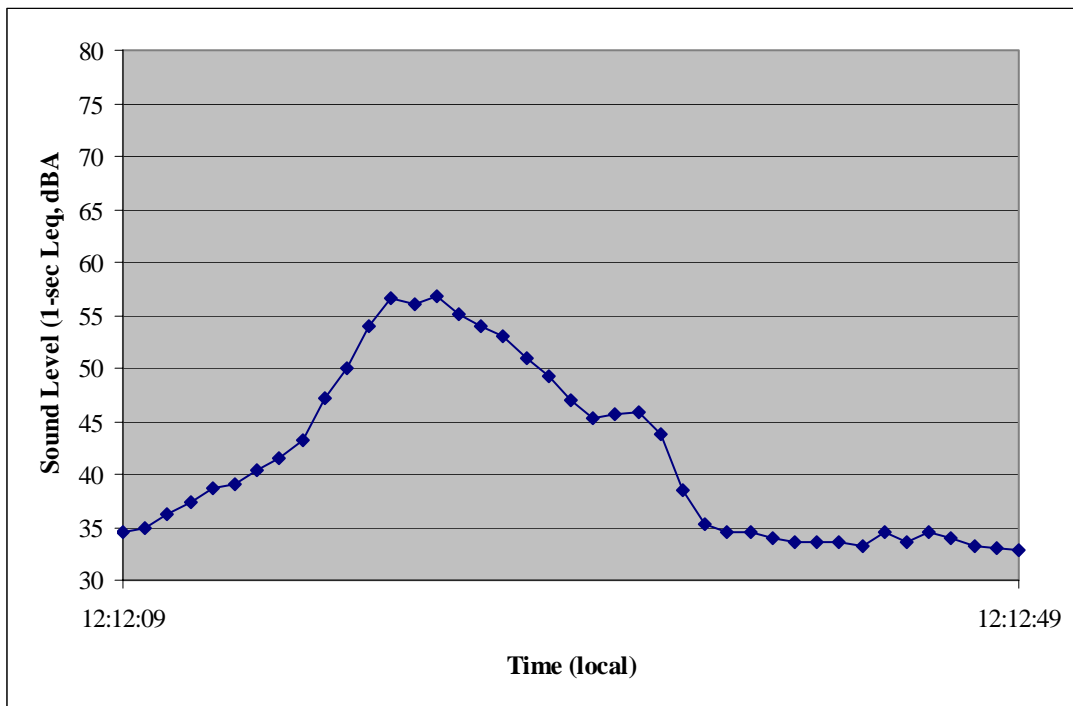


Figure 29. Alpen Guide, Right Side 15 mph (Feb 26th)

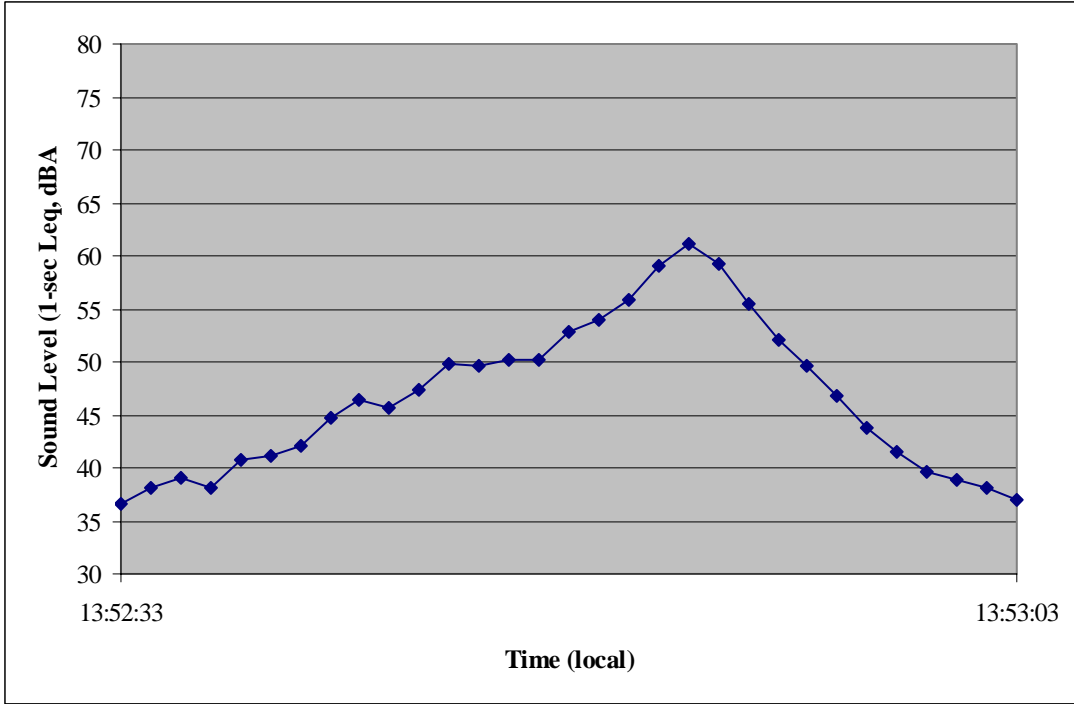


Figure 30. Goosewing Diesel Van, Right Side 15 mph (Feb 26th)

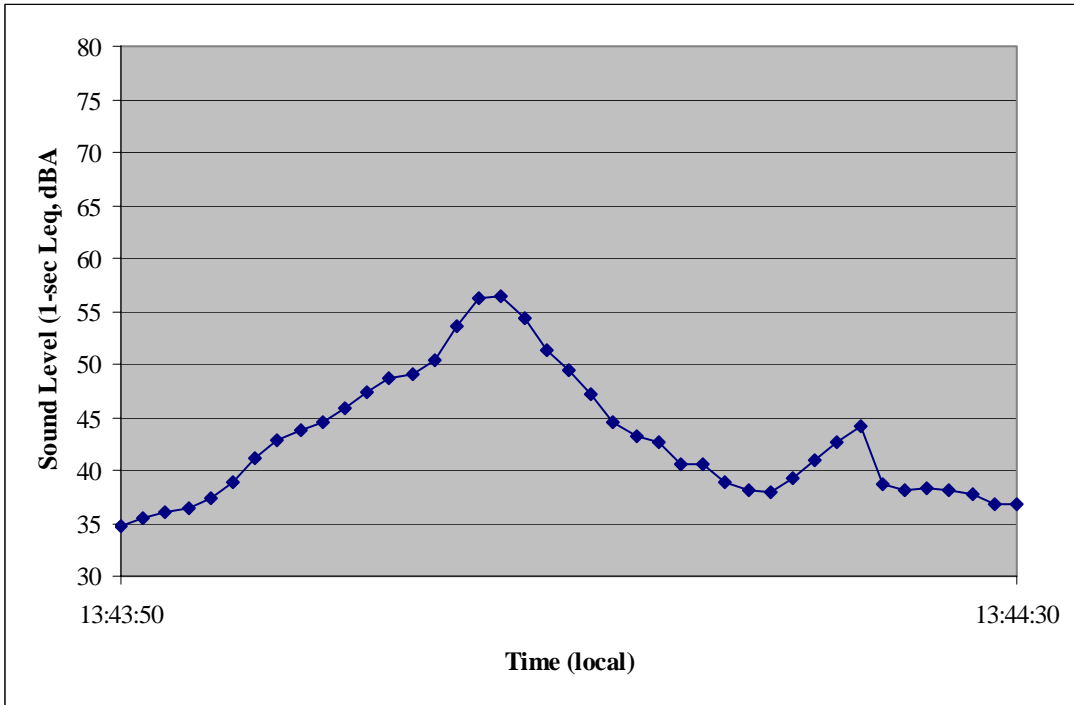


Figure 31. Rocky Mt. SC Tours, Right Side 15 mph (Feb 26th)

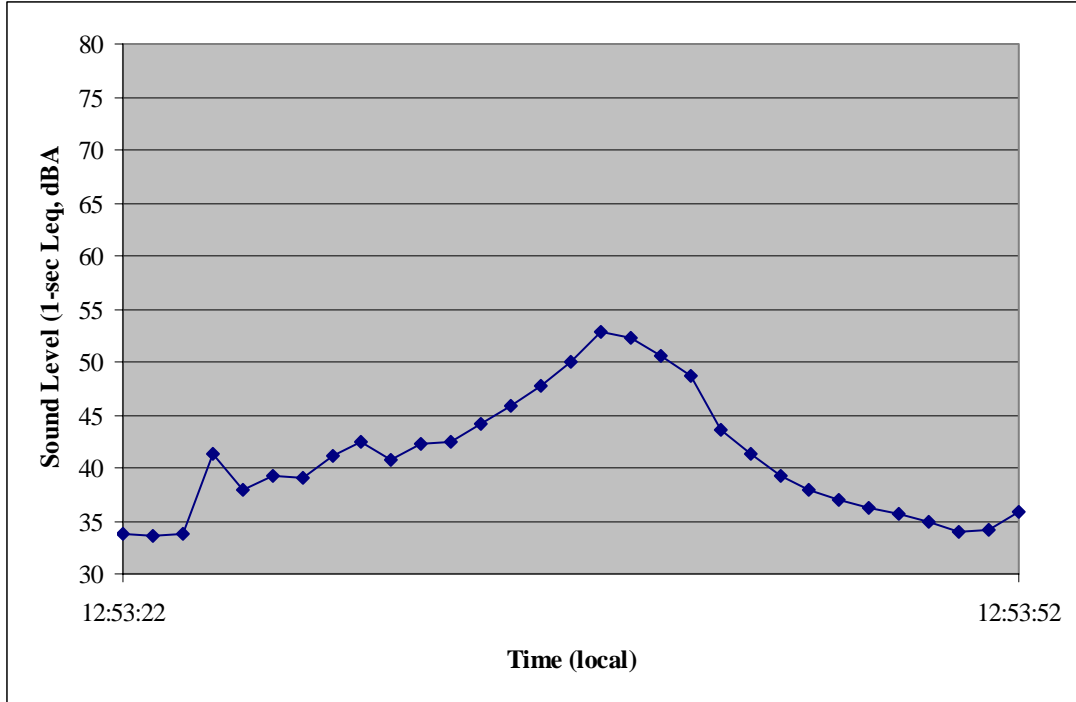


Figure 32. Yellowstone Expedition, Right Side 16 mph (Feb 26th)

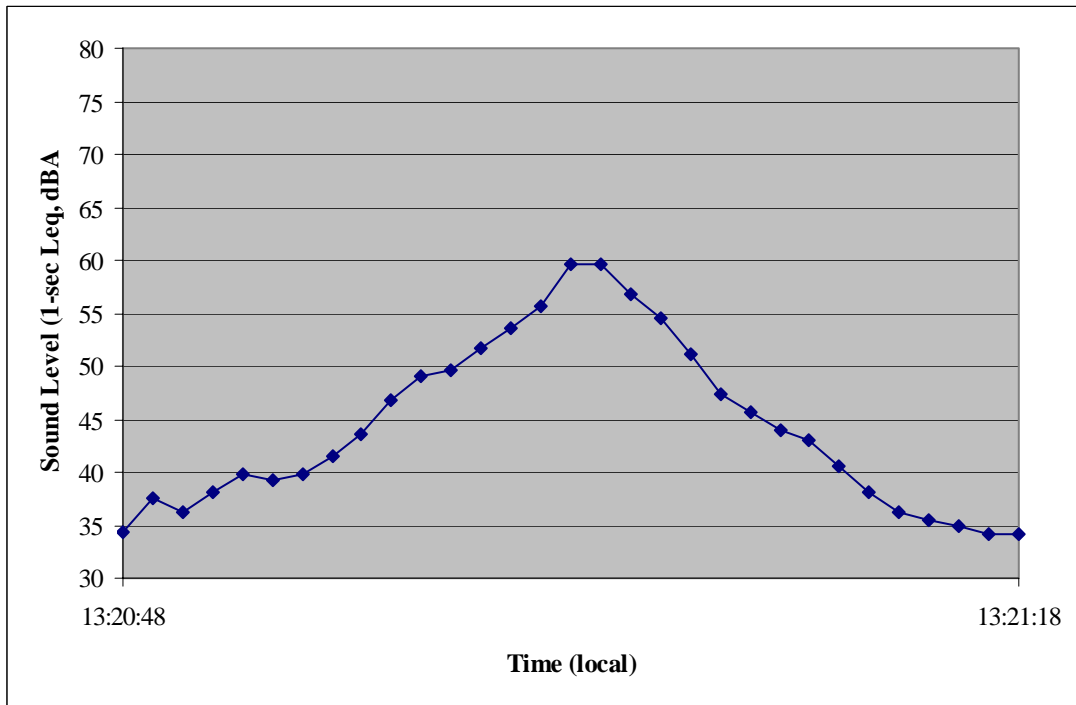


Figure 33. Yellowstone Snow Coach, Right Side 16 mph (Feb 26th)

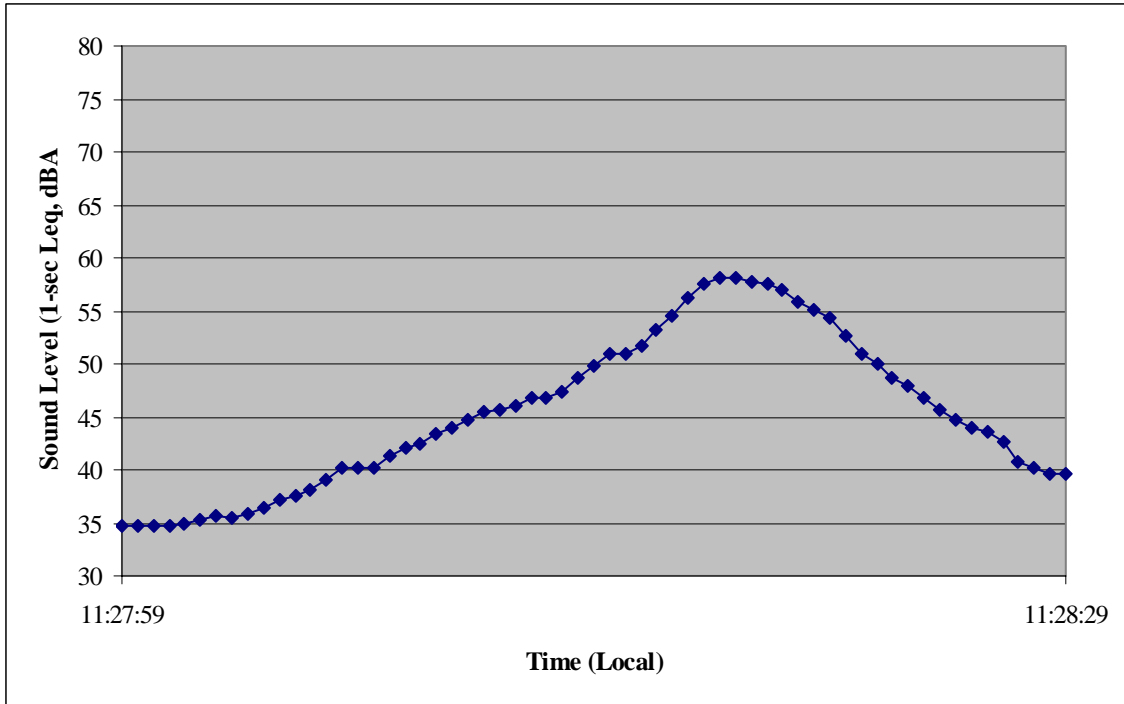


Figure 34. Xanterra 431, Right Side 15 mph (Feb 27th)

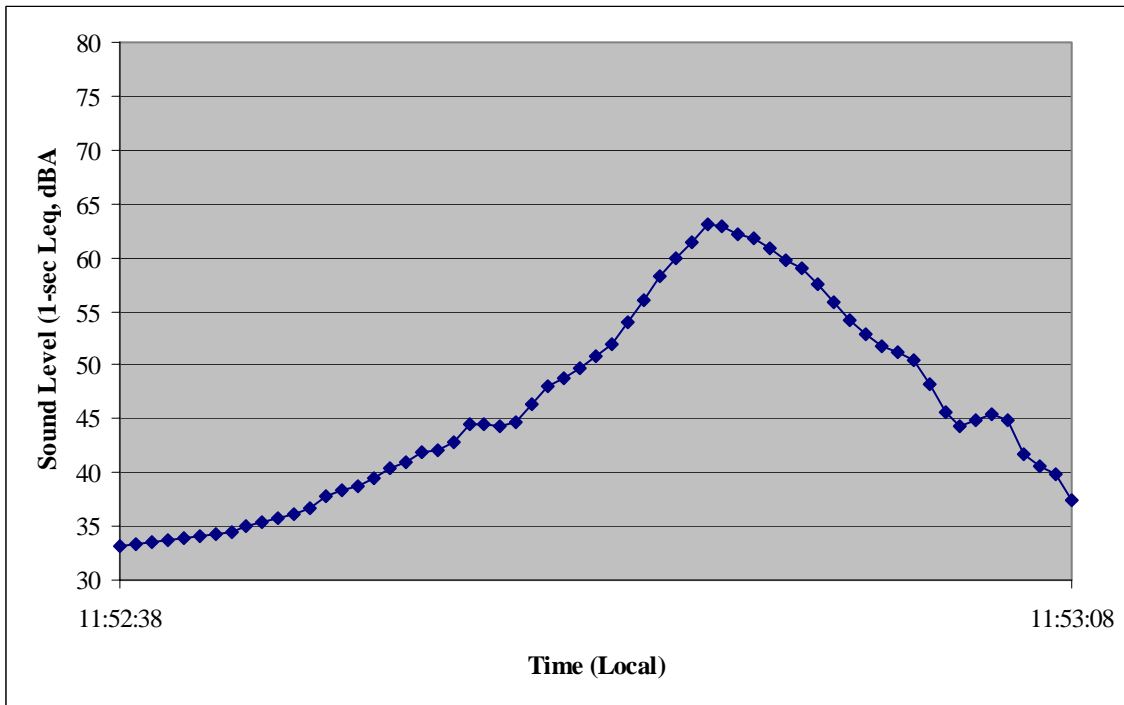


Figure 35. Xanterra 707, Right Side 15 mph (Feb 27th)

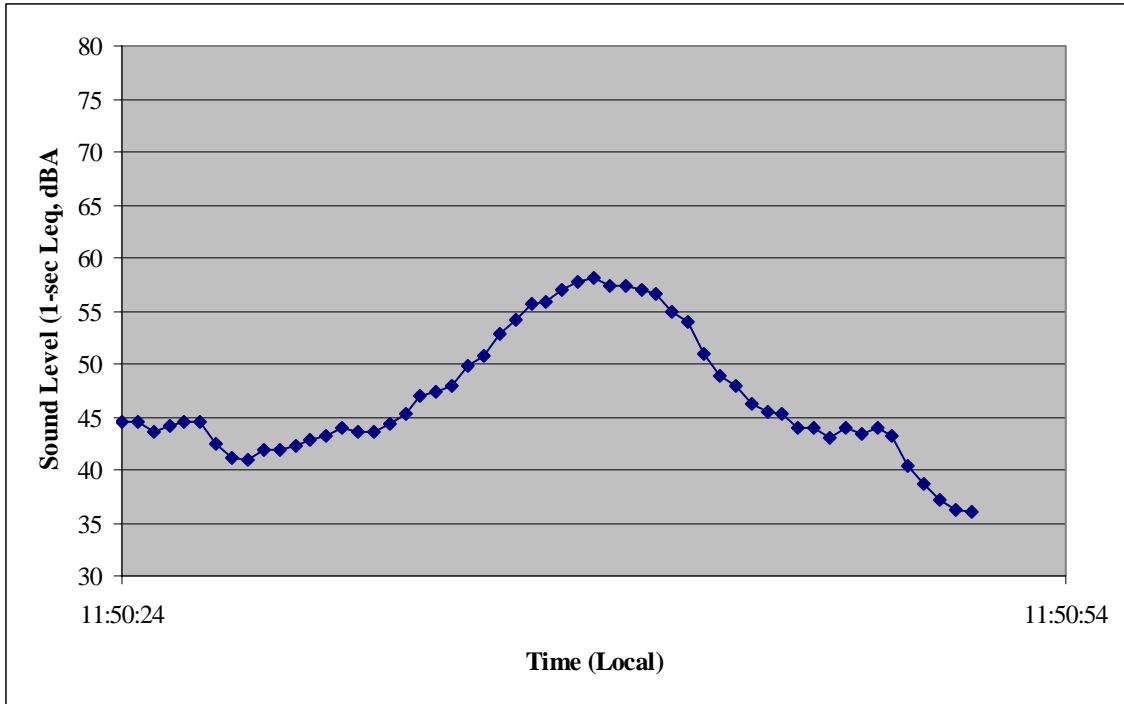


Figure 36. Xanterra 165, Left Side 15.5 mph (Feb 27th)

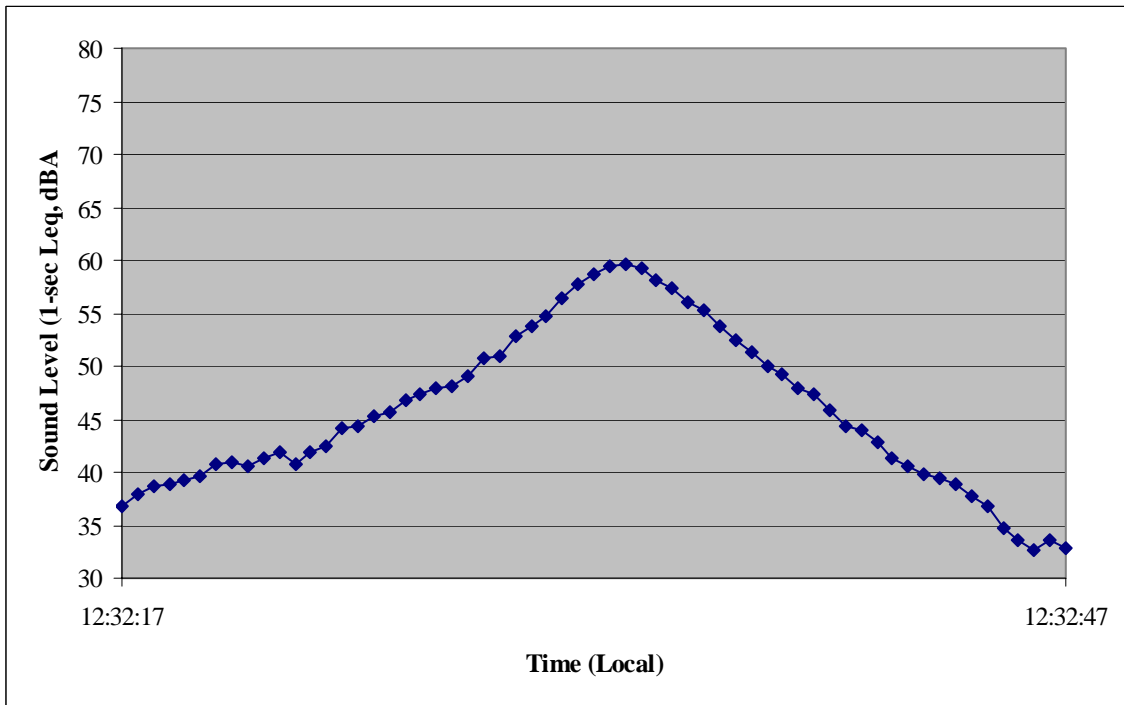


Figure 37. Goosewing Excursion, Right Side 16 mph (Feb 27th)

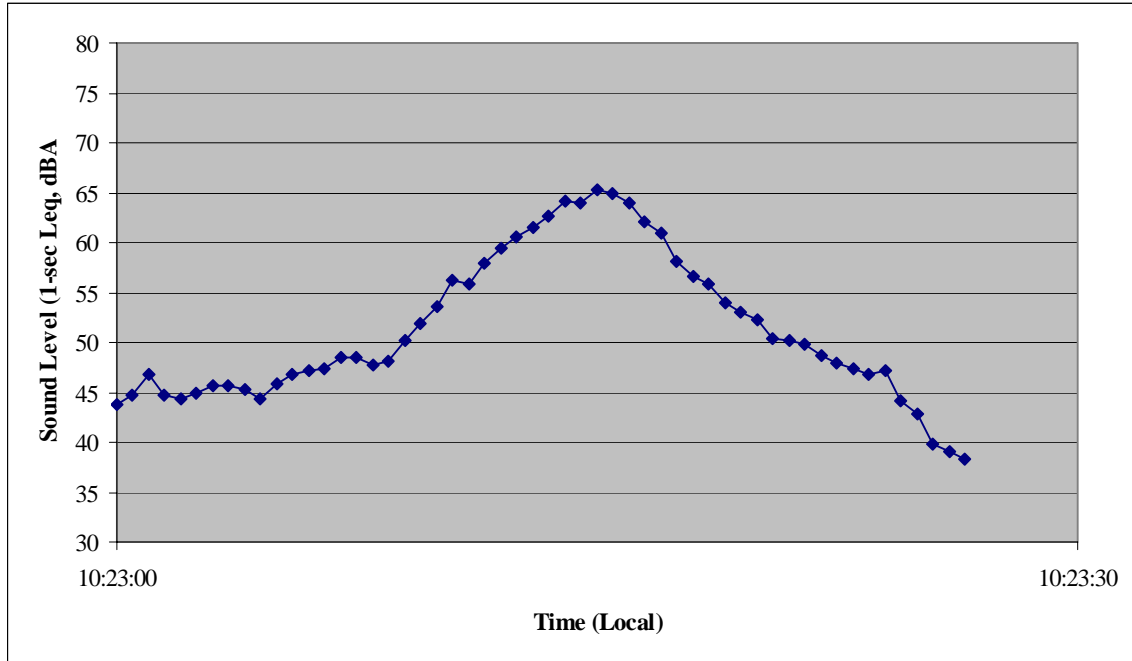


Figure 38. NPS Snow Coach, Left Side 15 mph (Feb 28th)

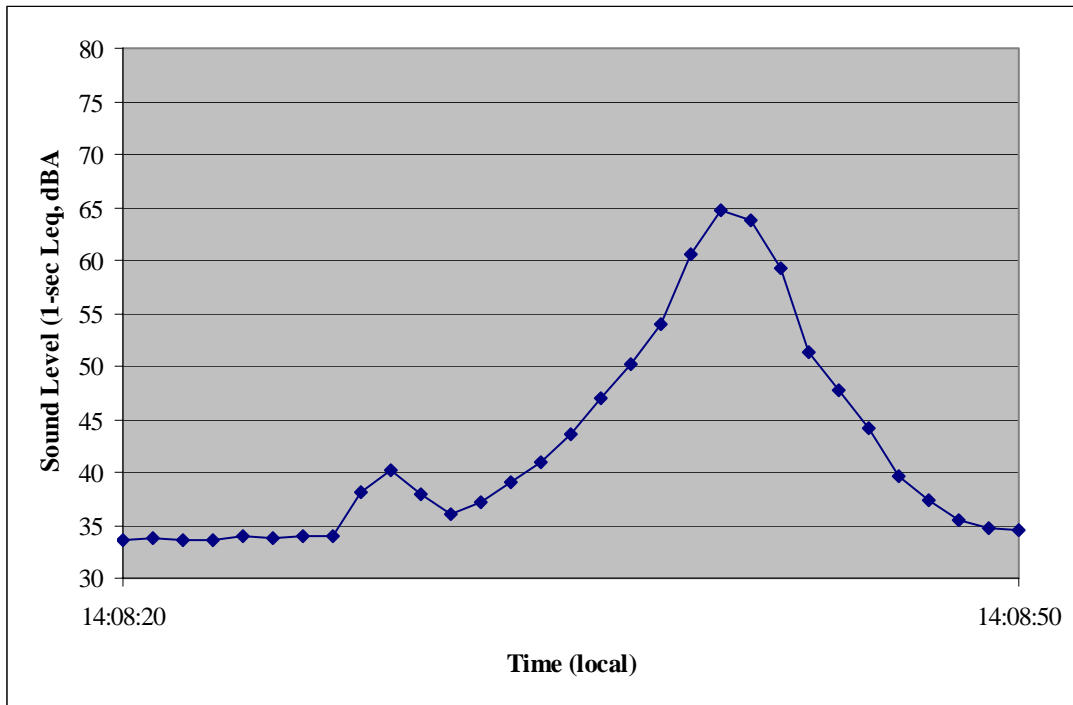


Figure 39. Alpen Guide, Right Side 34 mph (Feb 26th)

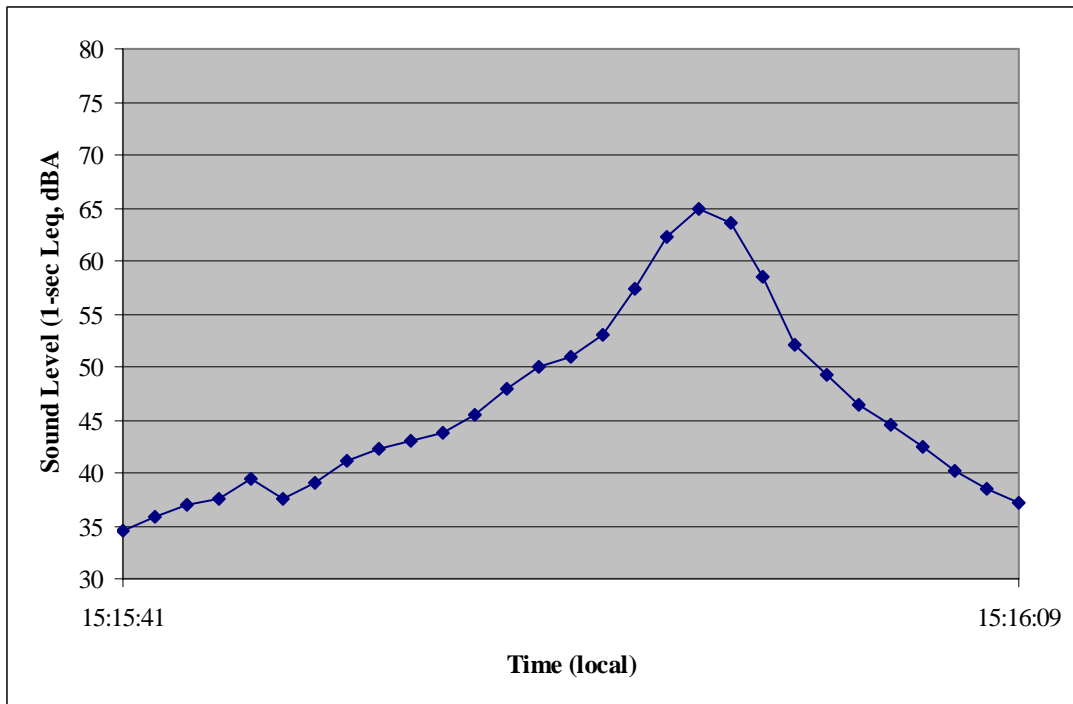


Figure 40. Goosewing Diesel Van, Left Side 28 mph (Feb 26th)

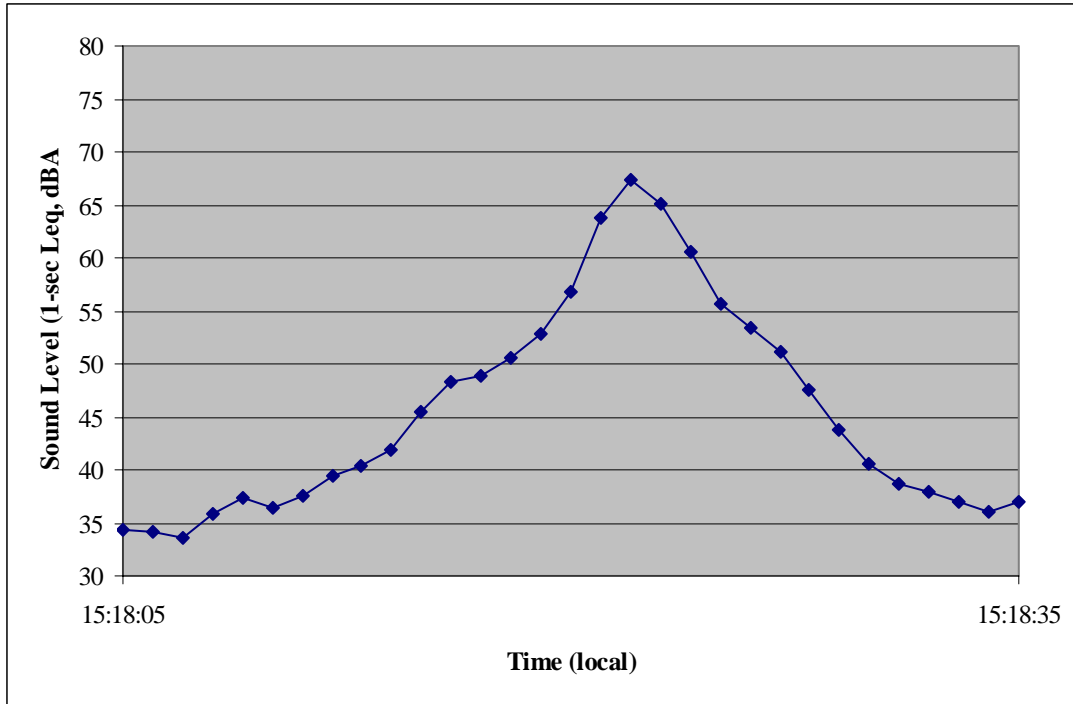


Figure 41. Rocky Mt. SC Tours, Left Side 29 mph (Feb 26th)

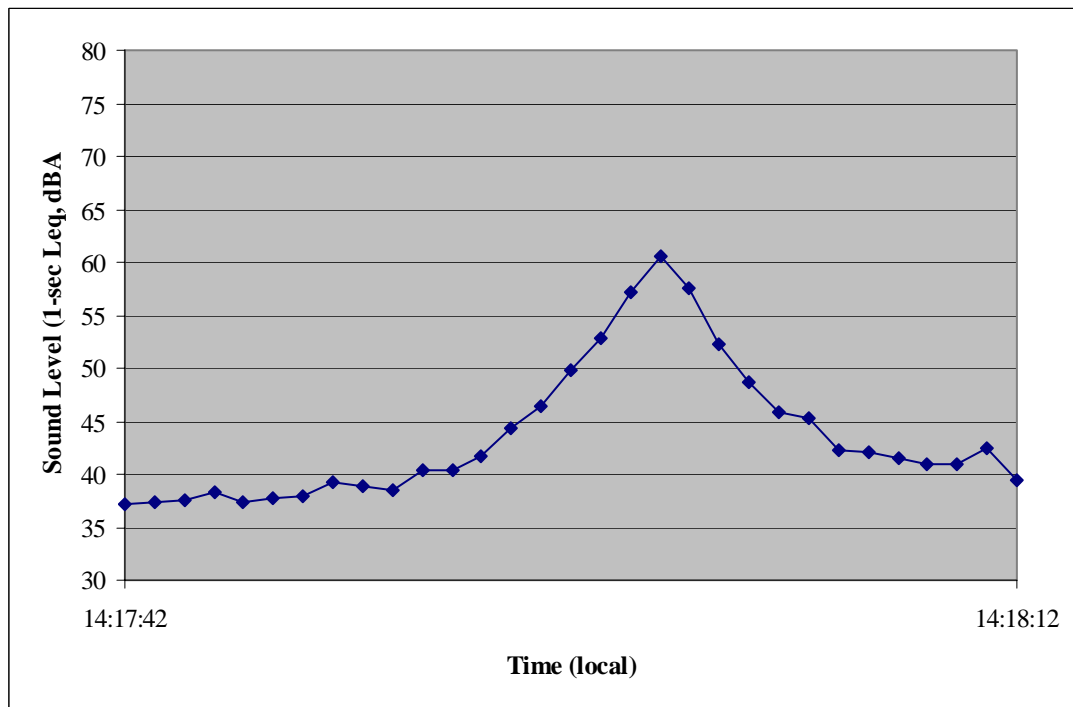


Figure 42. Yellowstone Expedition, Left Side 28.5 mph (Feb 26th)

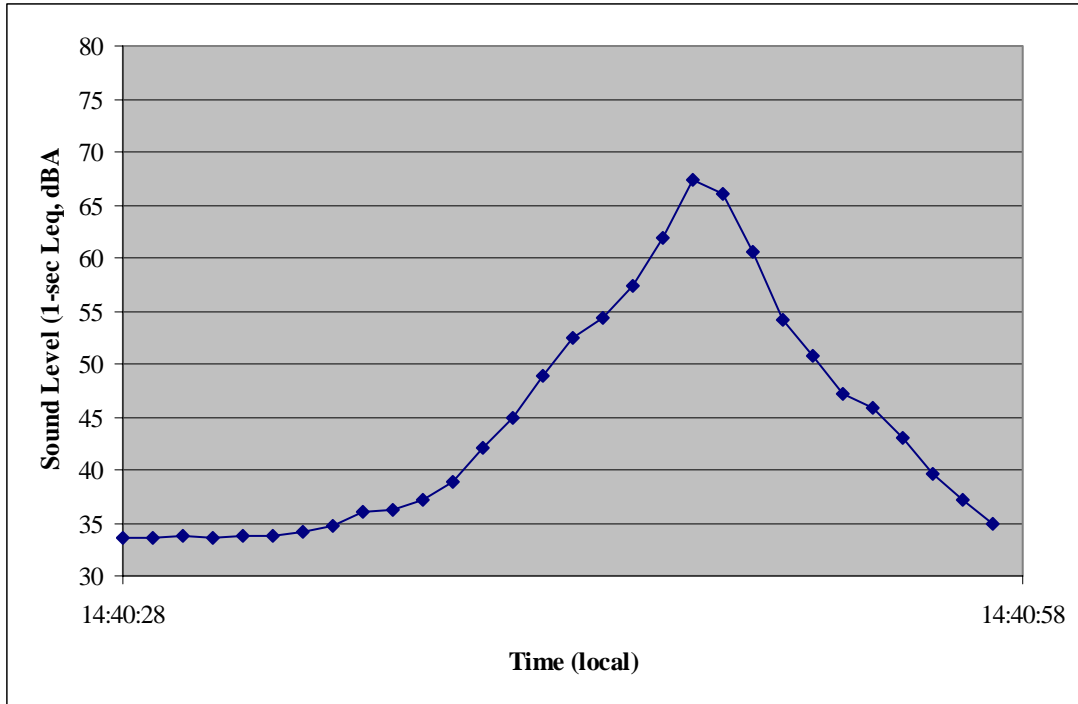


Figure 43. Yellowstone Snow Coach, Right Side 30 mph (Feb 26th)

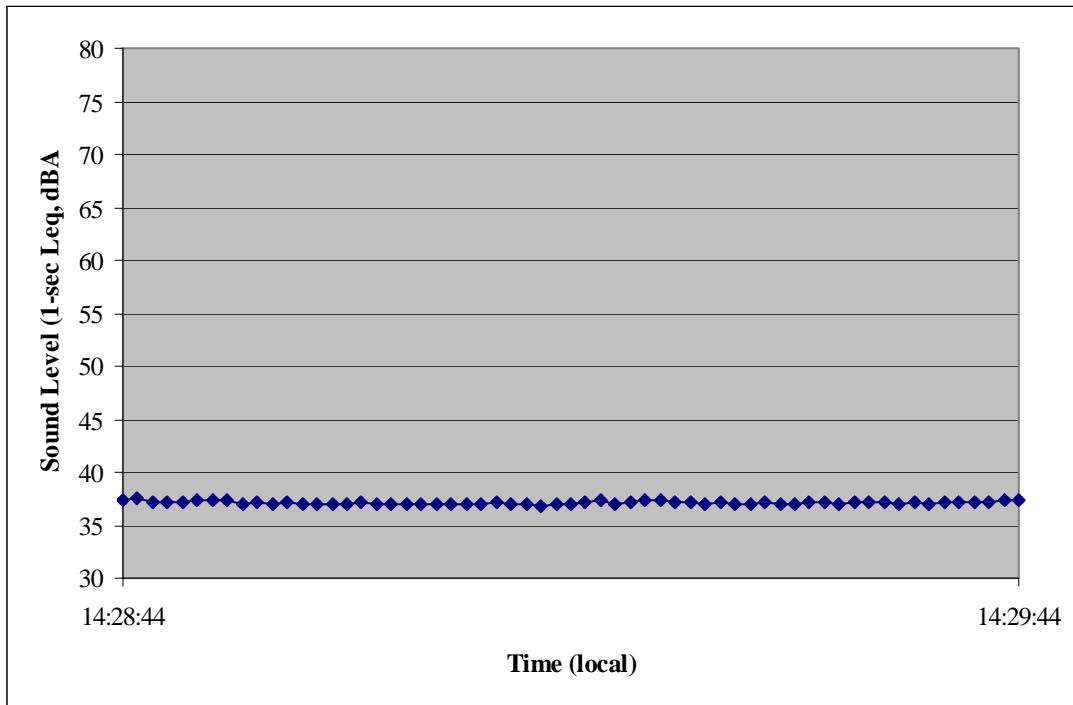


Figure 44. Alpen Guide, Right Side Idle (Feb 26th)

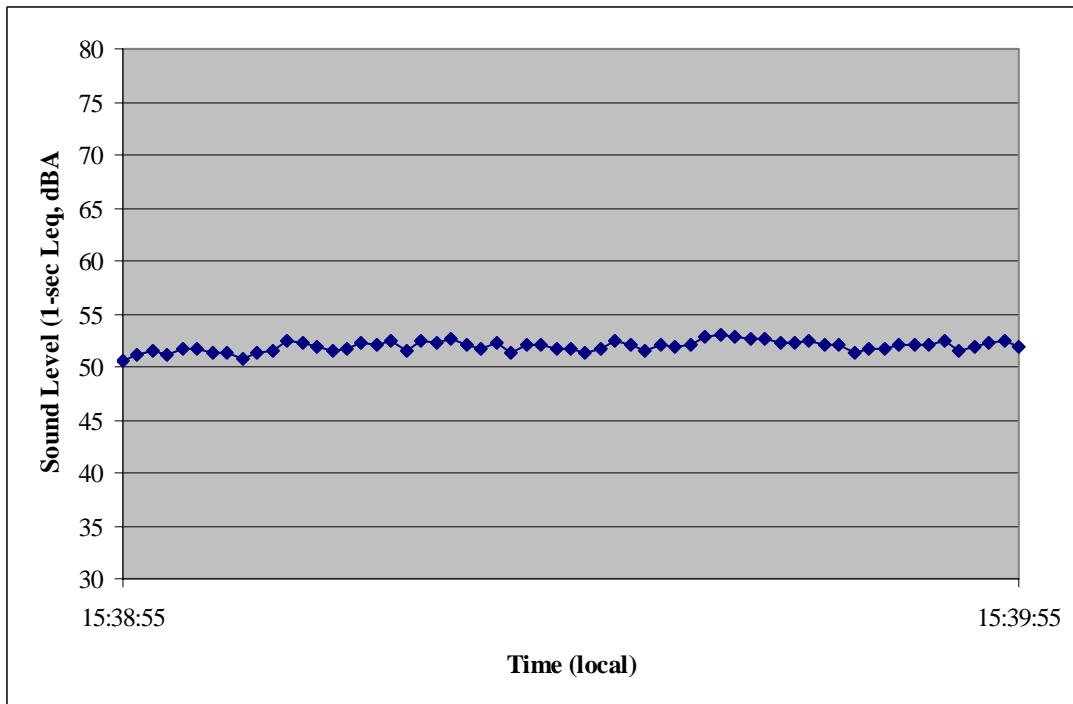


Figure 45. Goosewing Diesel Van, Left Side Idle (Feb 26th)

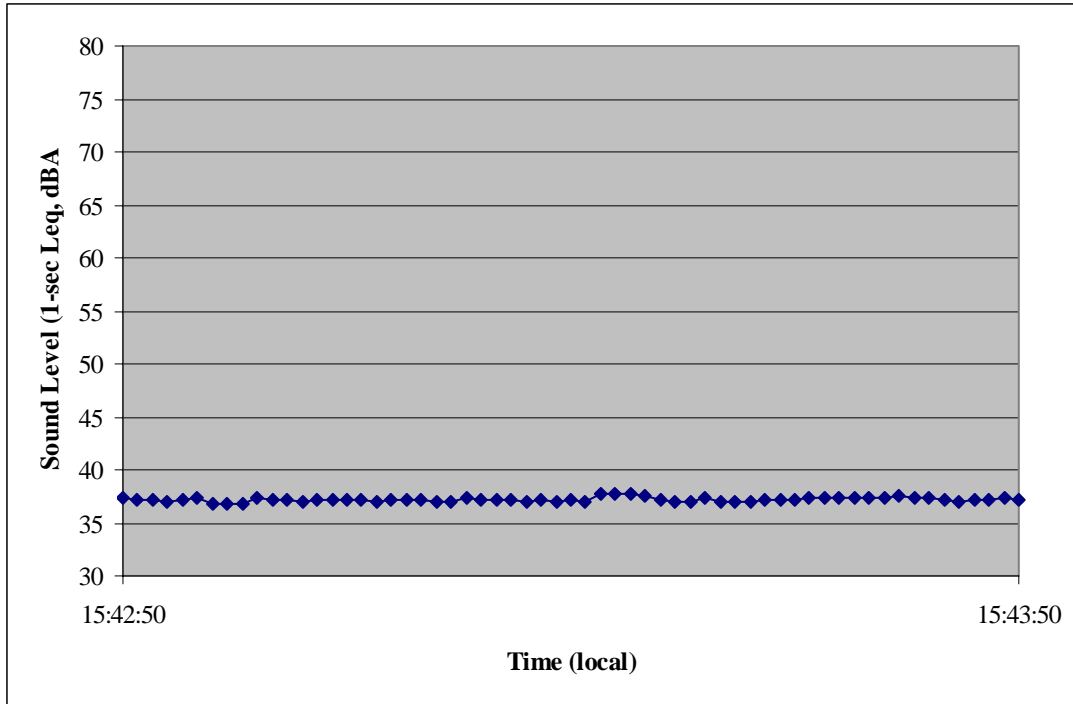


Figure 46. Rocky Mt. SC Tours, Left Side Idle (Feb 26th)

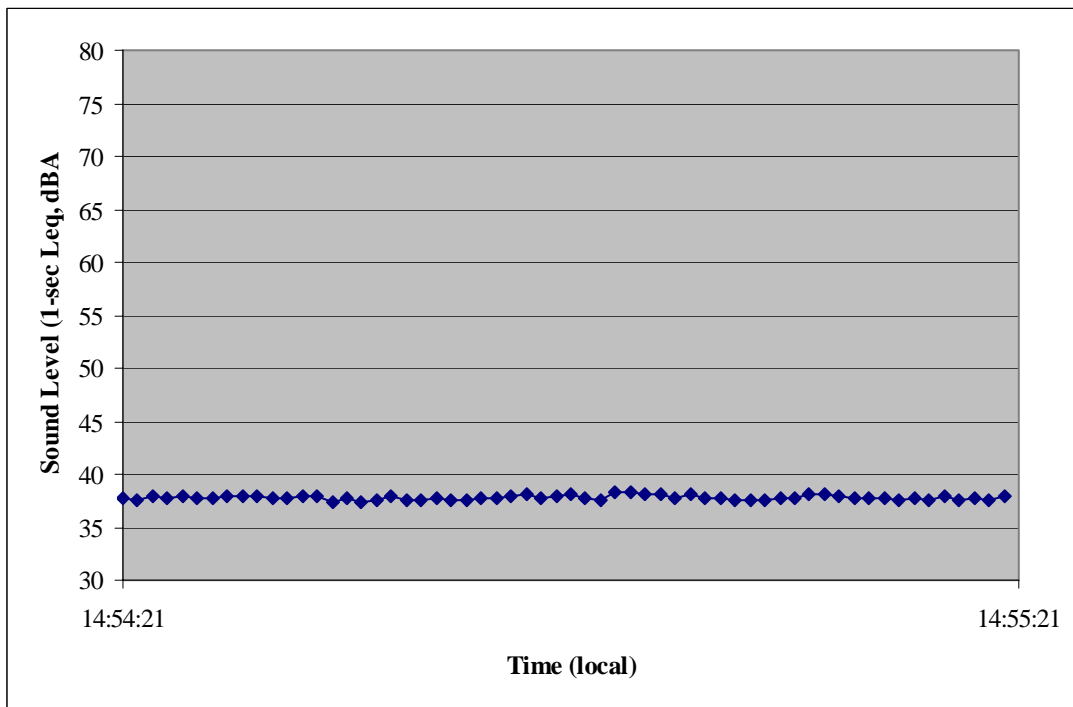


Figure 47. Yellowstone Expedition, Left Side Idle (Feb 26th)

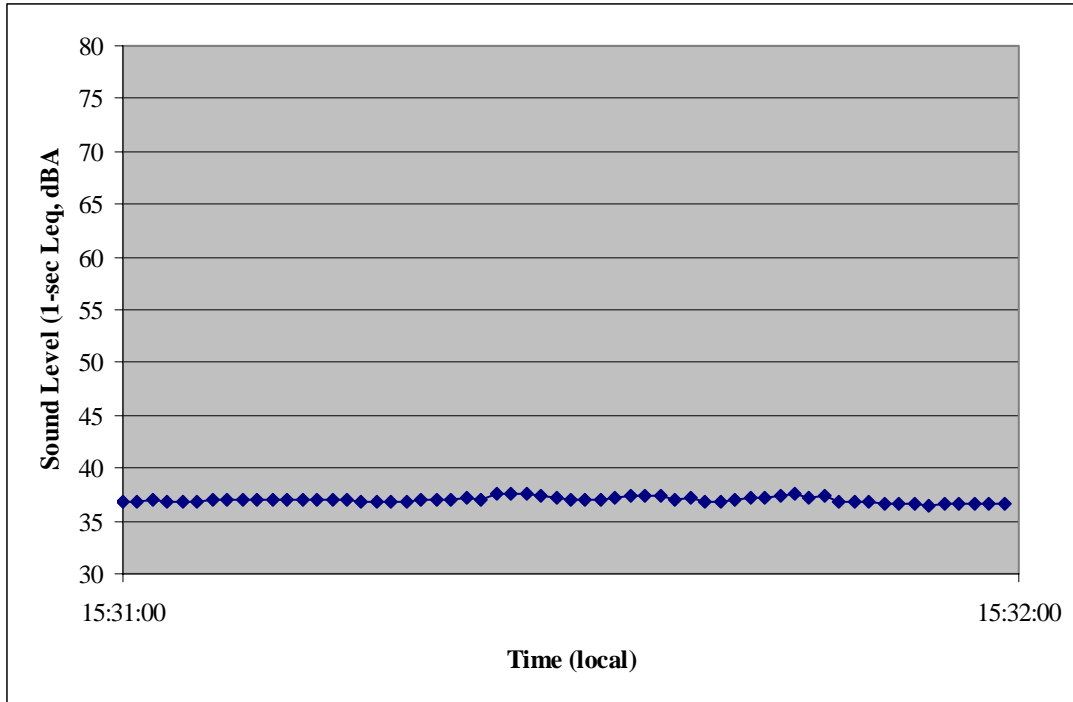


Figure 48. Yellowstone Snow Coach, Left Side Idle (Feb 26th)

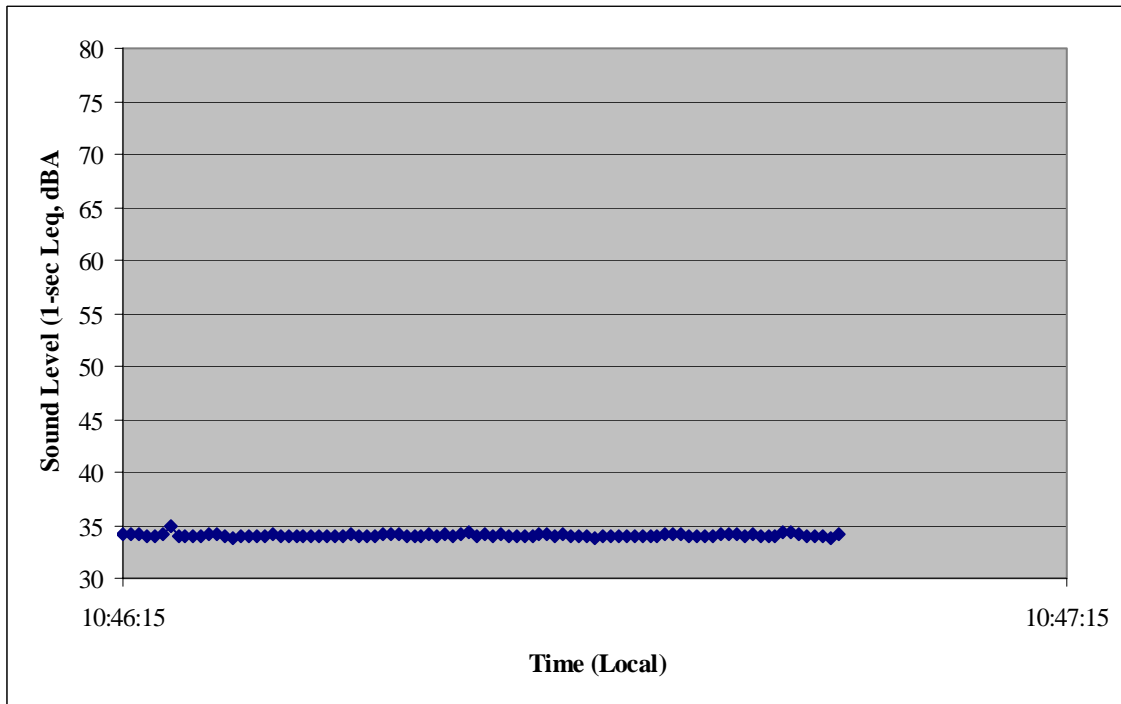


Figure 49. Xanterra 431, Right Side Idle (Feb 27th)*

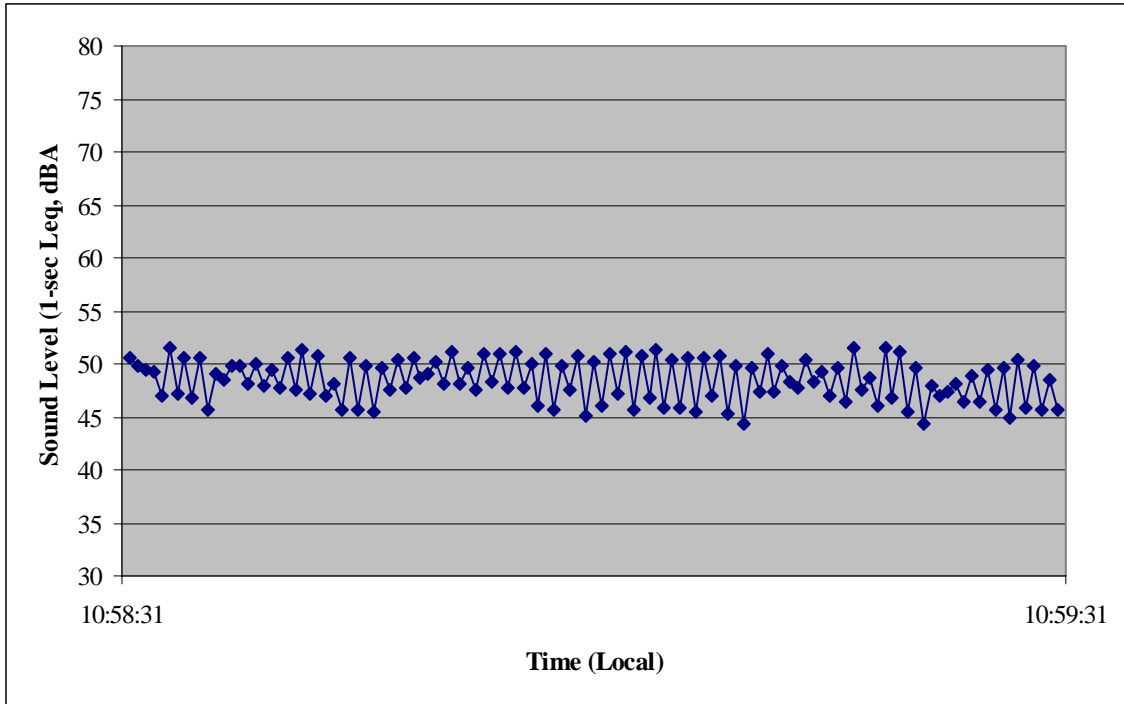


Figure 50. Xanterra 707, Right Side Idle (Feb 27th)

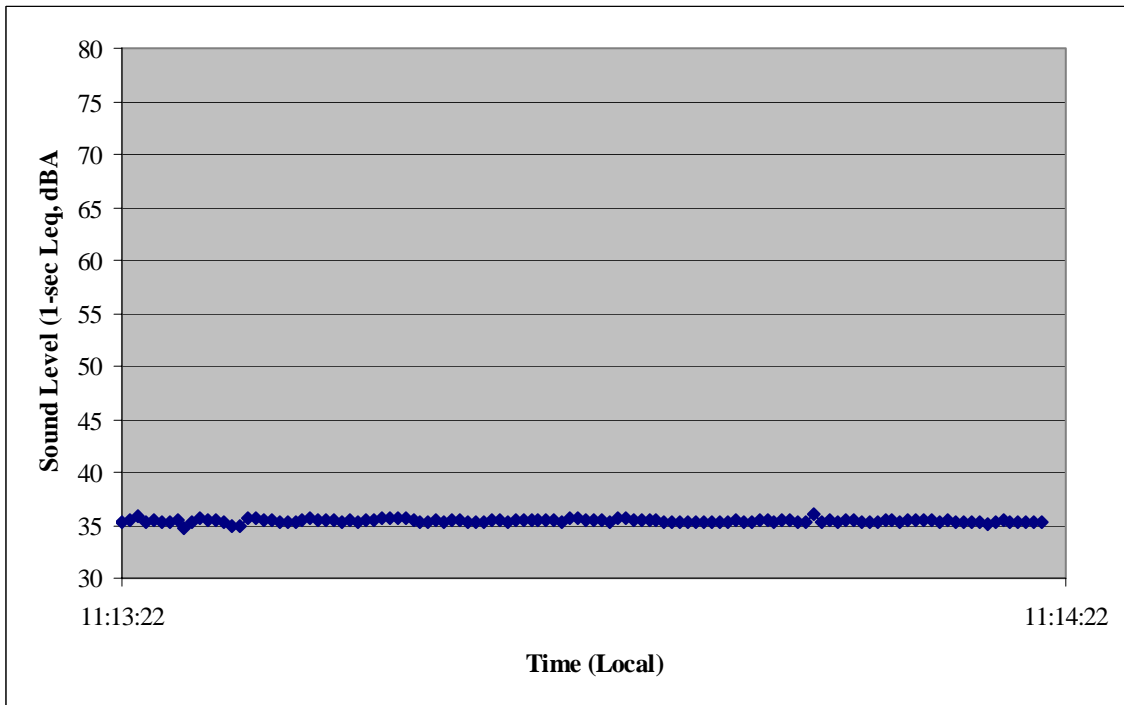


Figure 51. Xanterra 165, Left Side Idle (Feb 27th)

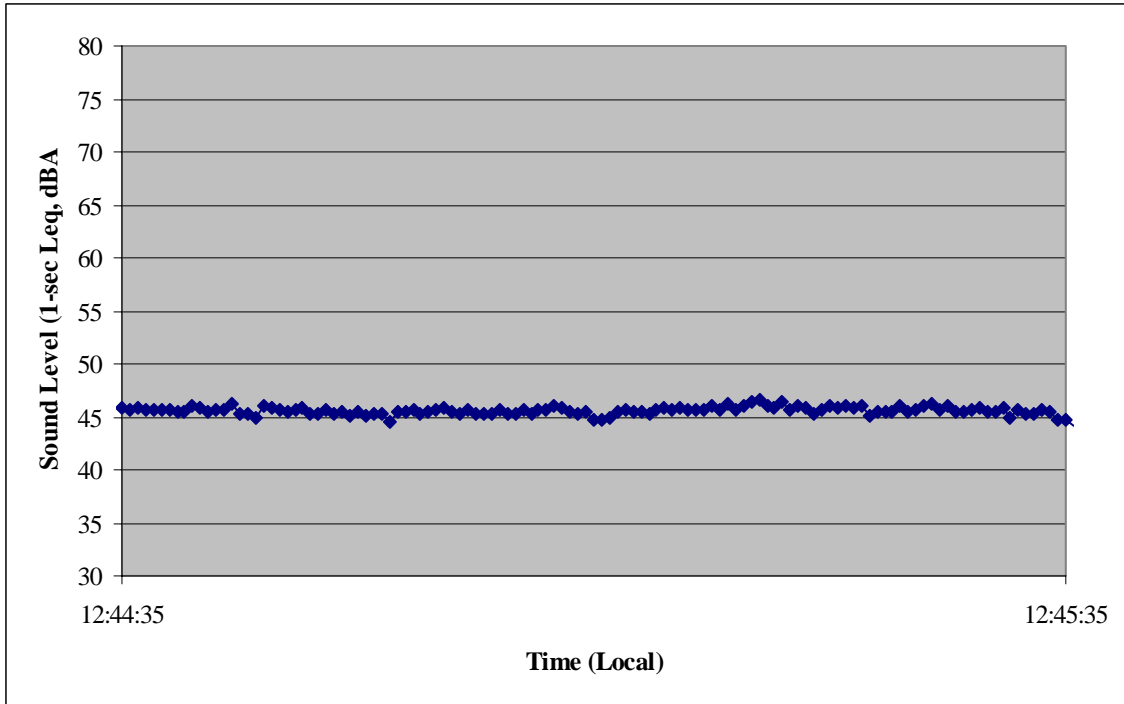


Figure 52. Goosewing Excursion, Left Side Idle (Feb 27th)

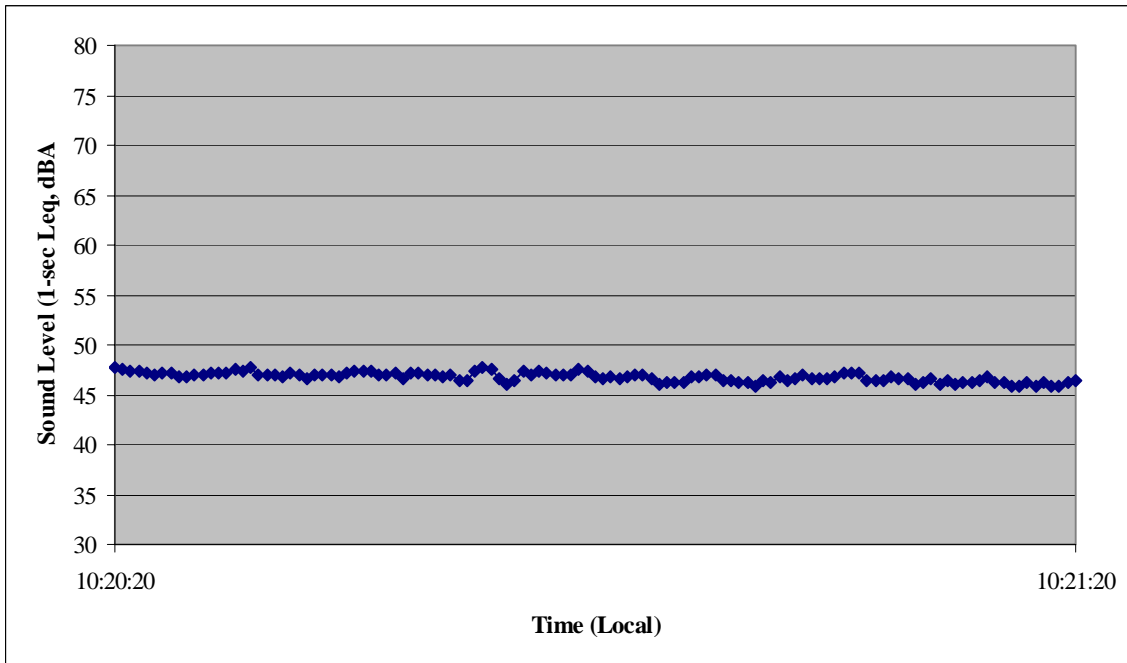


Figure 53. NPS Snow Coach, Left Side Idle (Feb 28th)

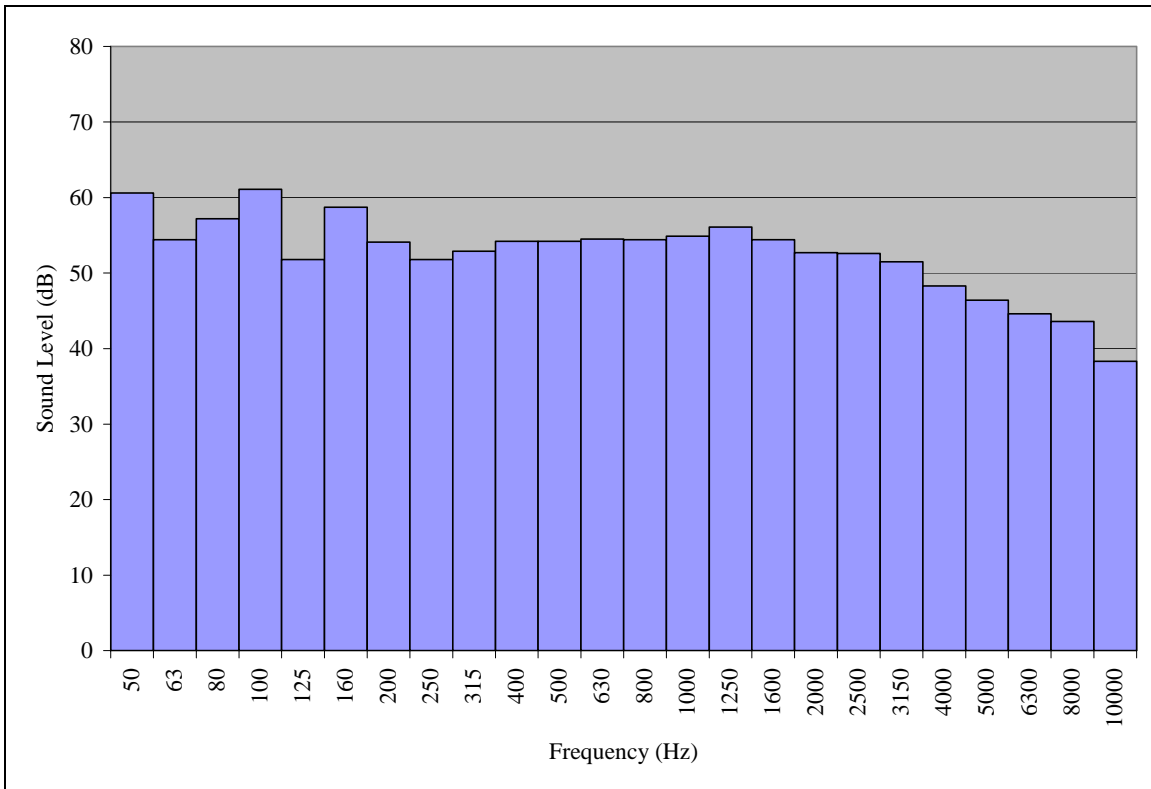


Figure 54. NPS SC, Left Side (Feb 28, 10:18) Spectra for Low Speed

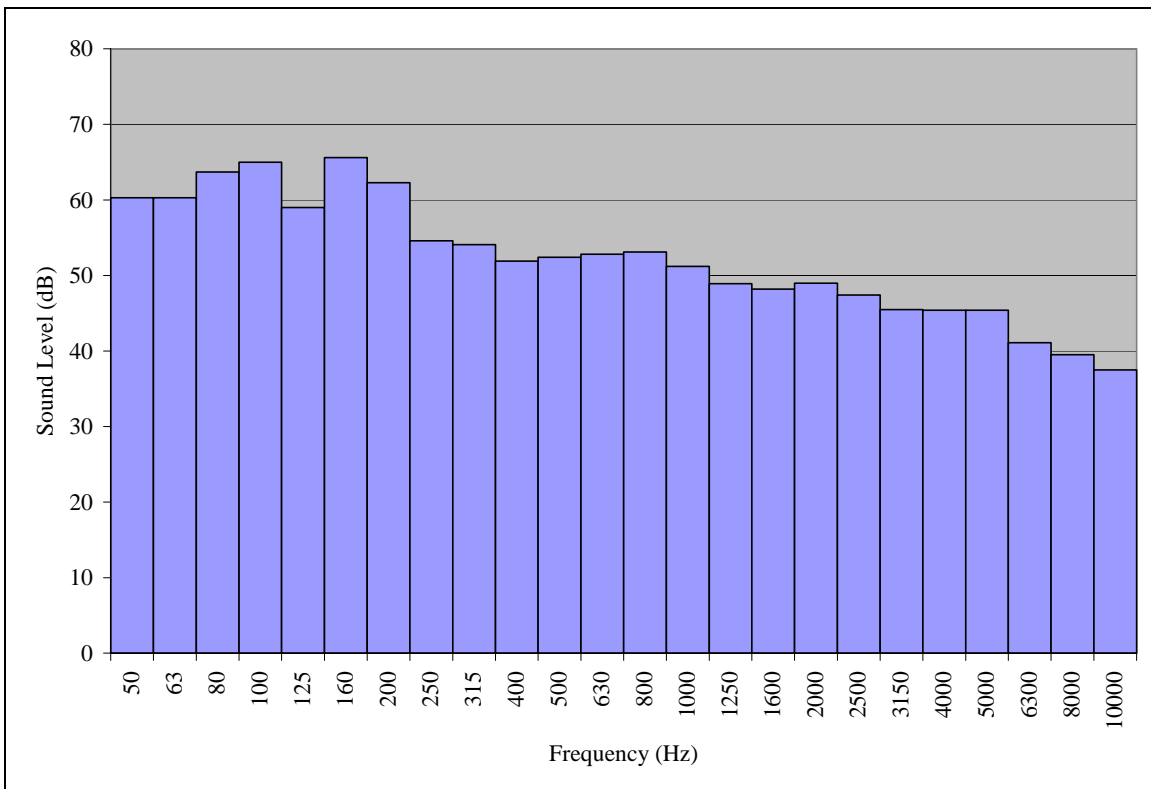


Figure 55. Xanterra 707, Right Side (Feb 27, 11:52) Spectra for Low Speed

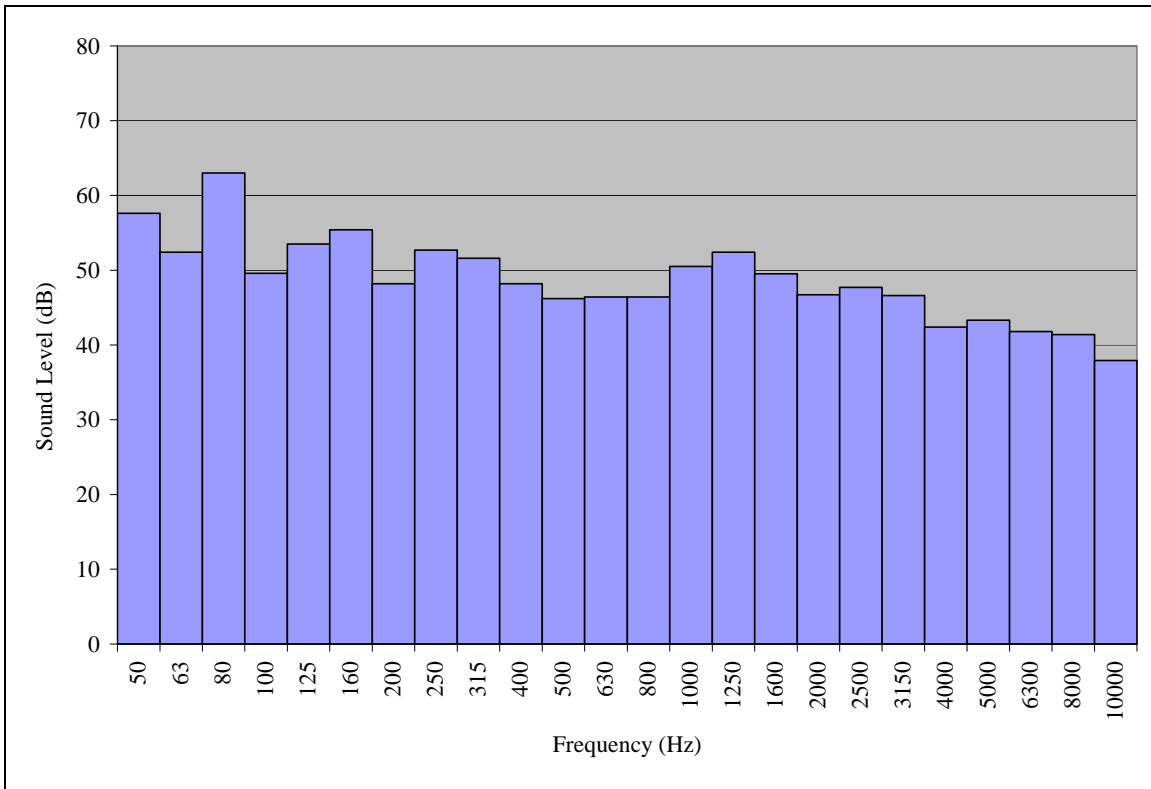


Figure 56. Goosewing Diesel Van, Right Side (Feb 26, 13:52) Spectra for Low Speed

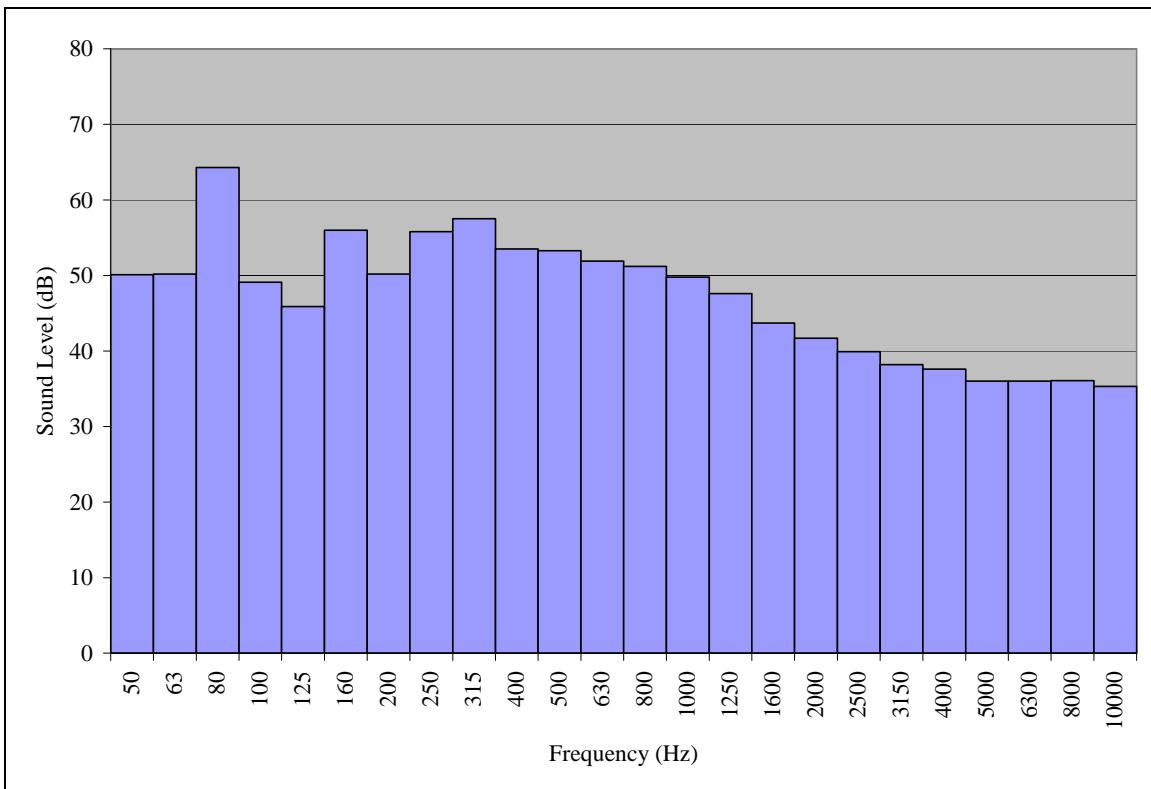


Figure 57. Yellowstone SC Tour, Right Side (Feb 26, 13:21) Spectra for Low Speed

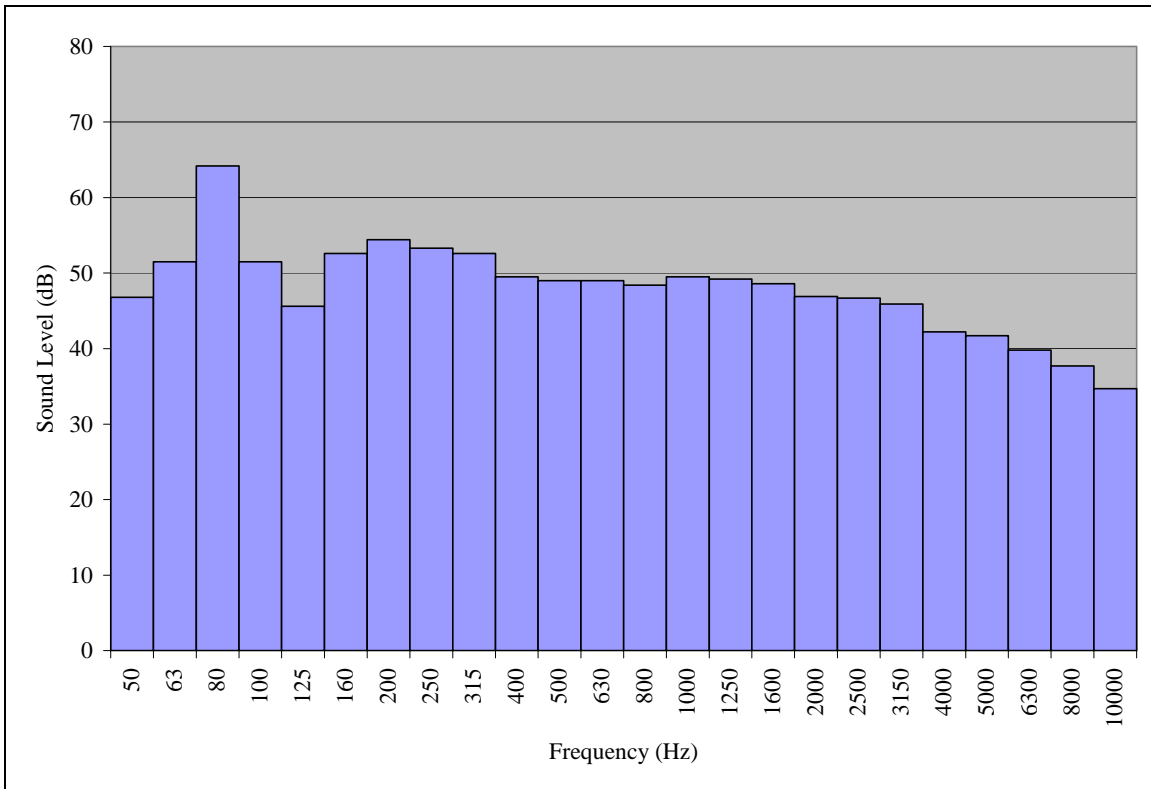


Figure 58. Goosewing Excursion, Right Side (Feb 27, 12:32) Spectra for Low Speed

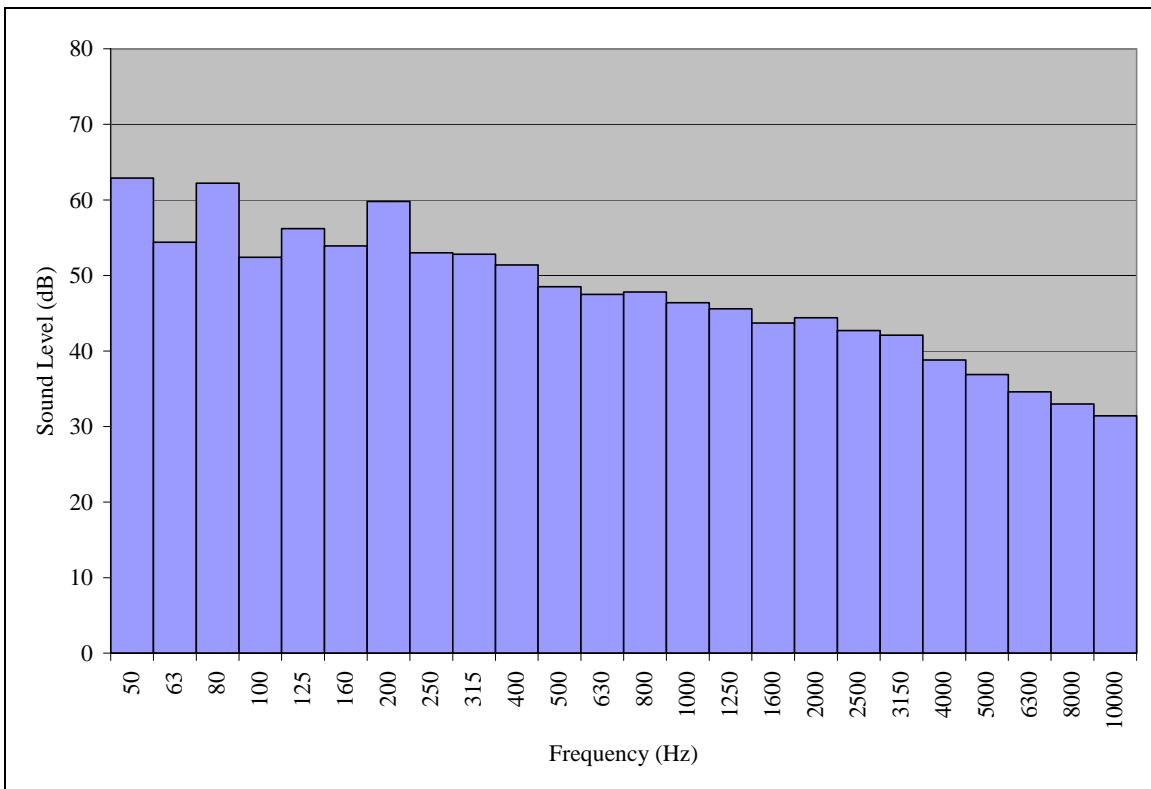


Figure 59. Xanterra 431, Right Side (Feb 27, 11:27) Spectra for Low Speed

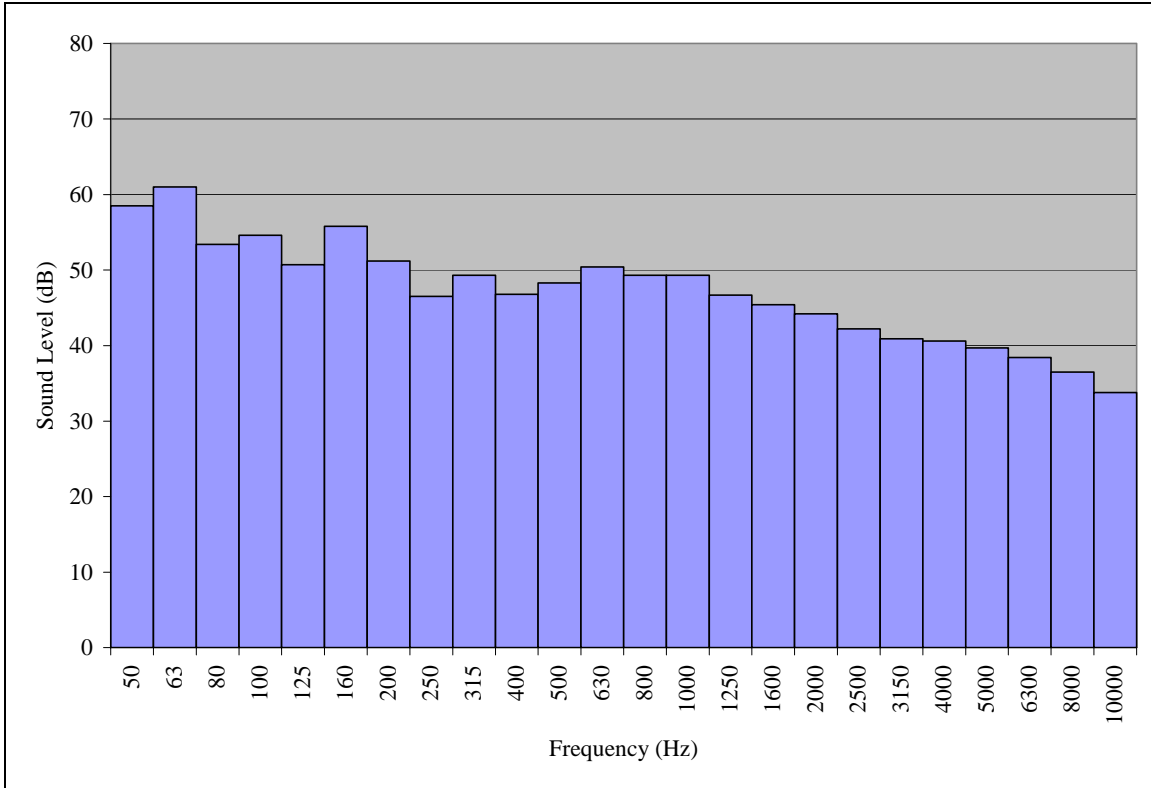


Figure 60. Xanterra 165, Left Side (Feb 27, 11:50) Spectra for Low Speed

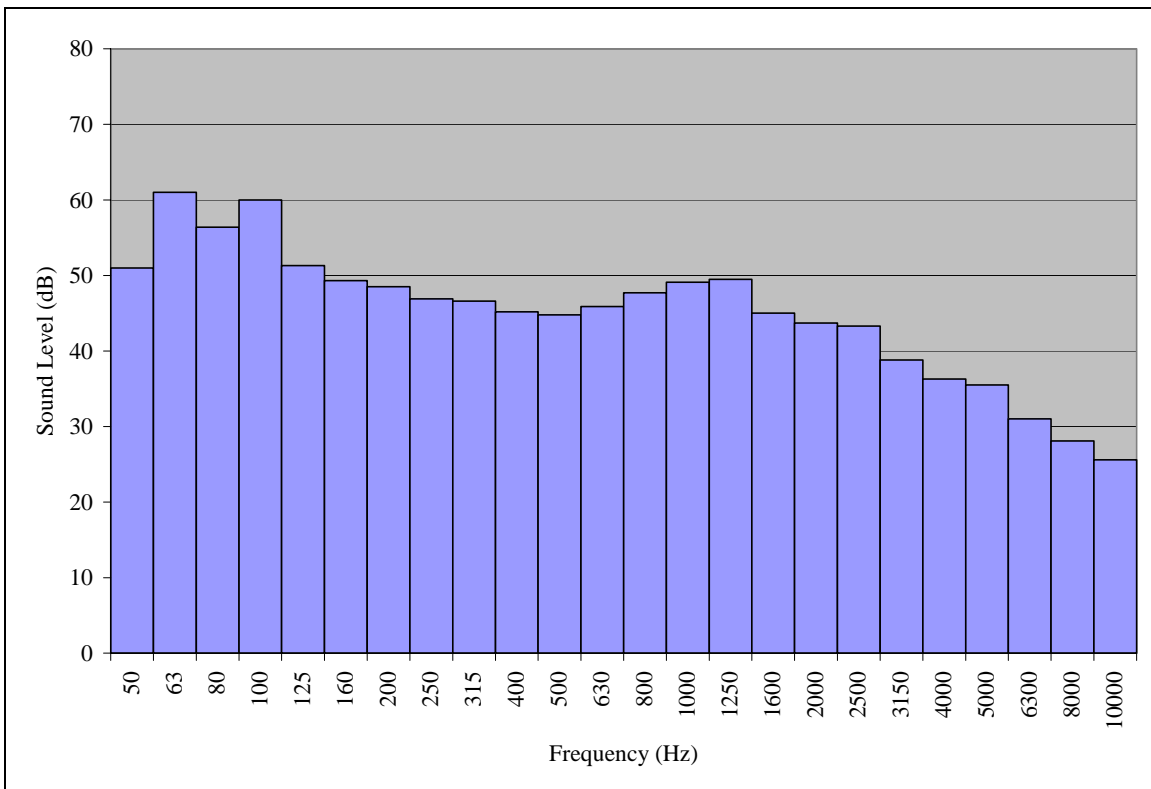


Figure 61. Alpen Guide, Right Side (Feb 26, 12:12) Spectra for Low Speed

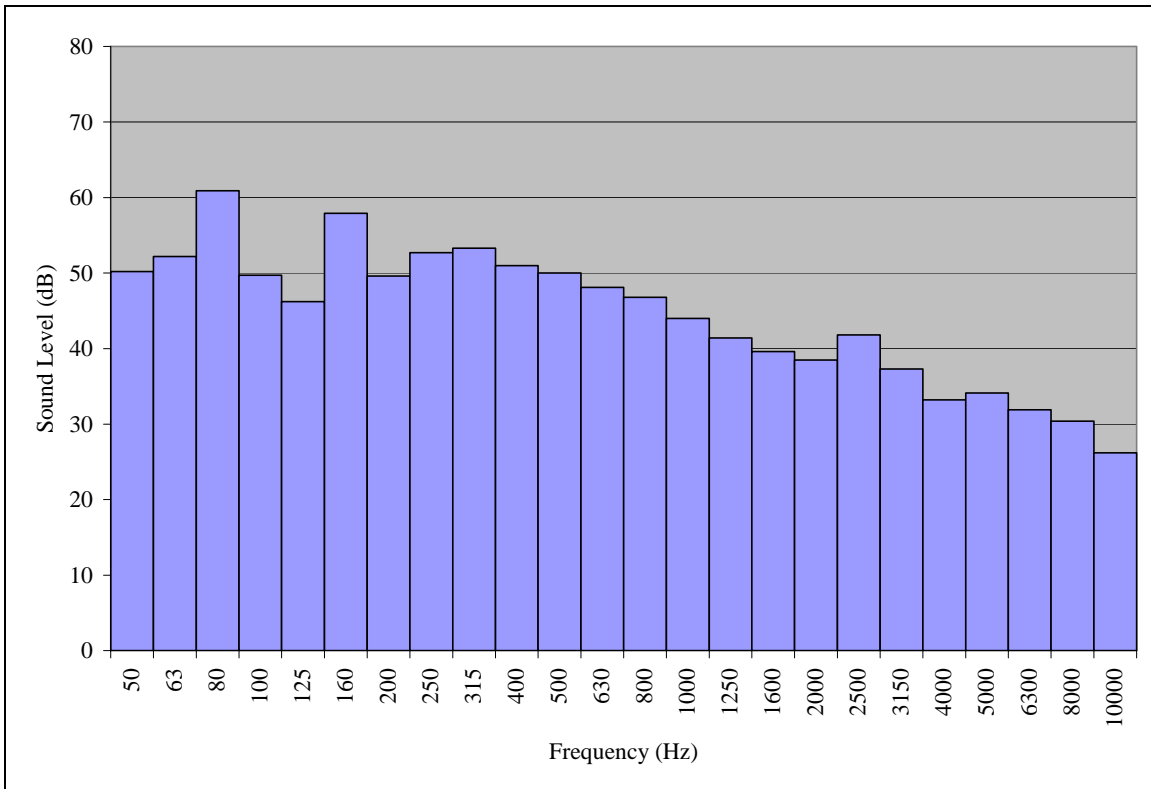


Figure 62. Rocky Mt, Right Side (Feb 26, 13:43) Spectra for Low Speed

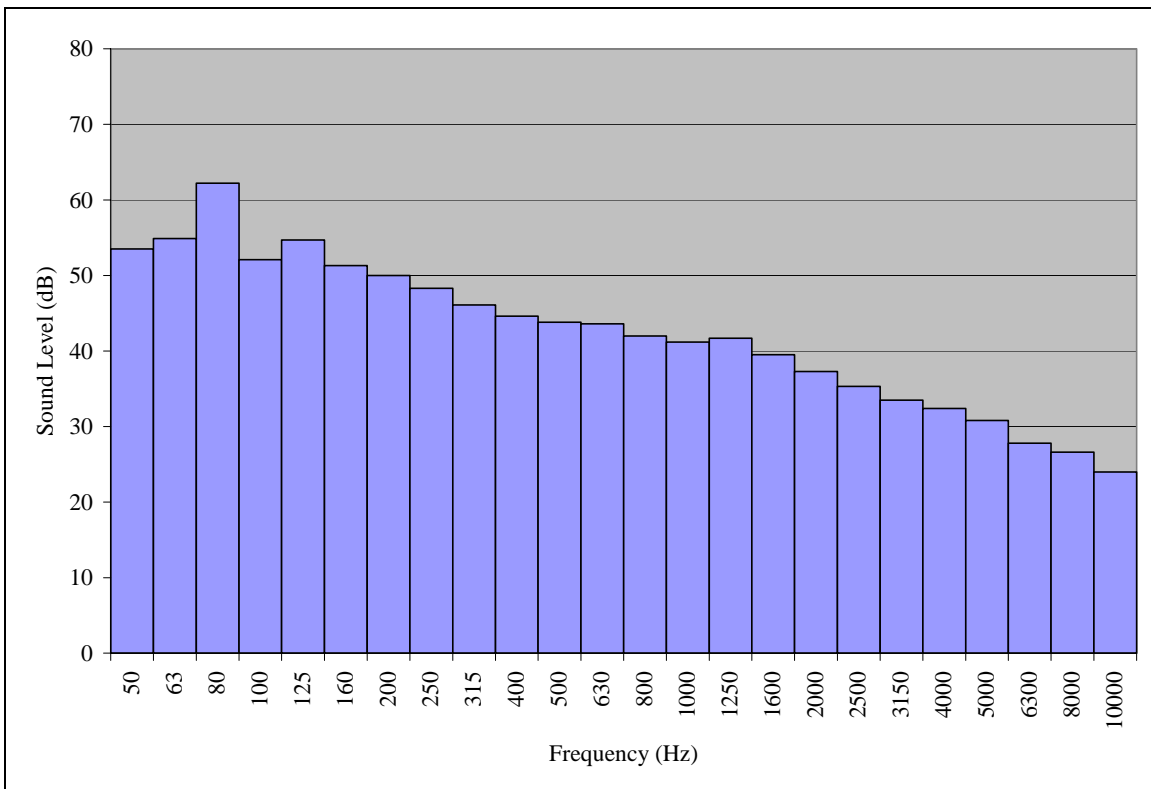


Figure 63. Yellowstone Expedition, Right Side (Feb 26, 12:53) Spectra for Low Speed

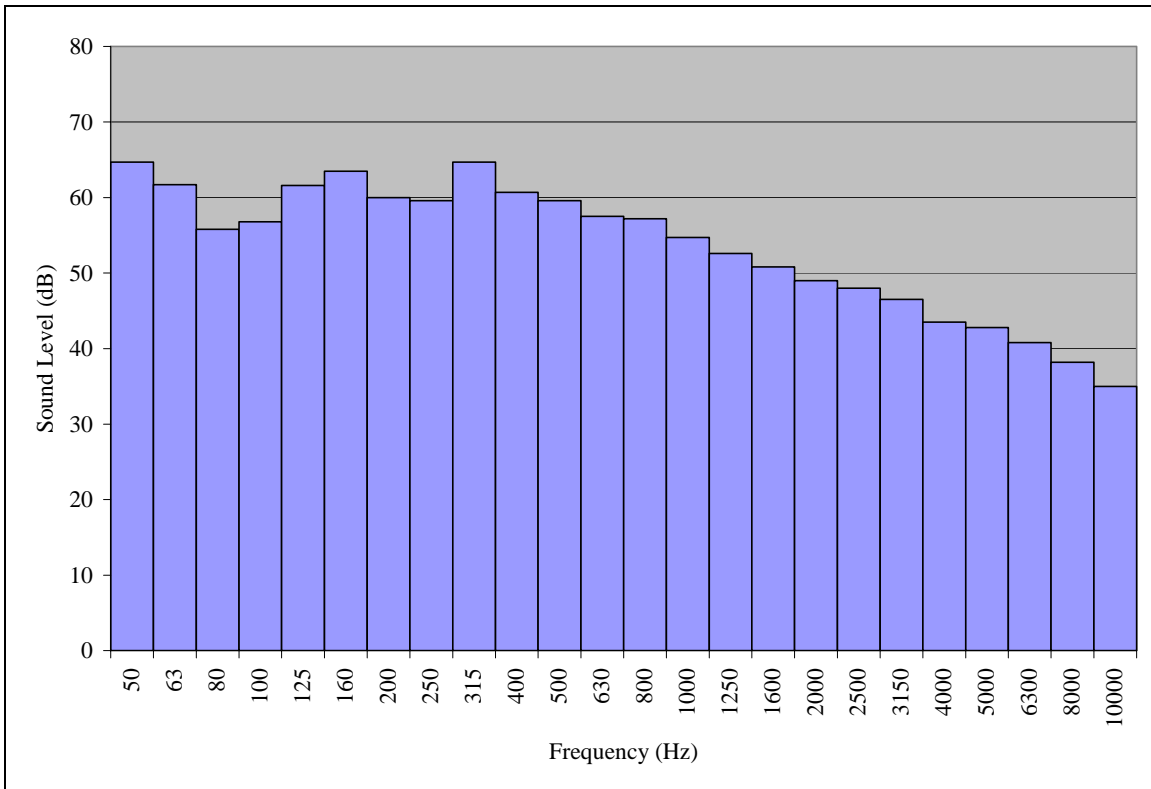


Figure 64. Rocky Mt, Left Side (Feb 26, 15:18) Spectra for High Speed

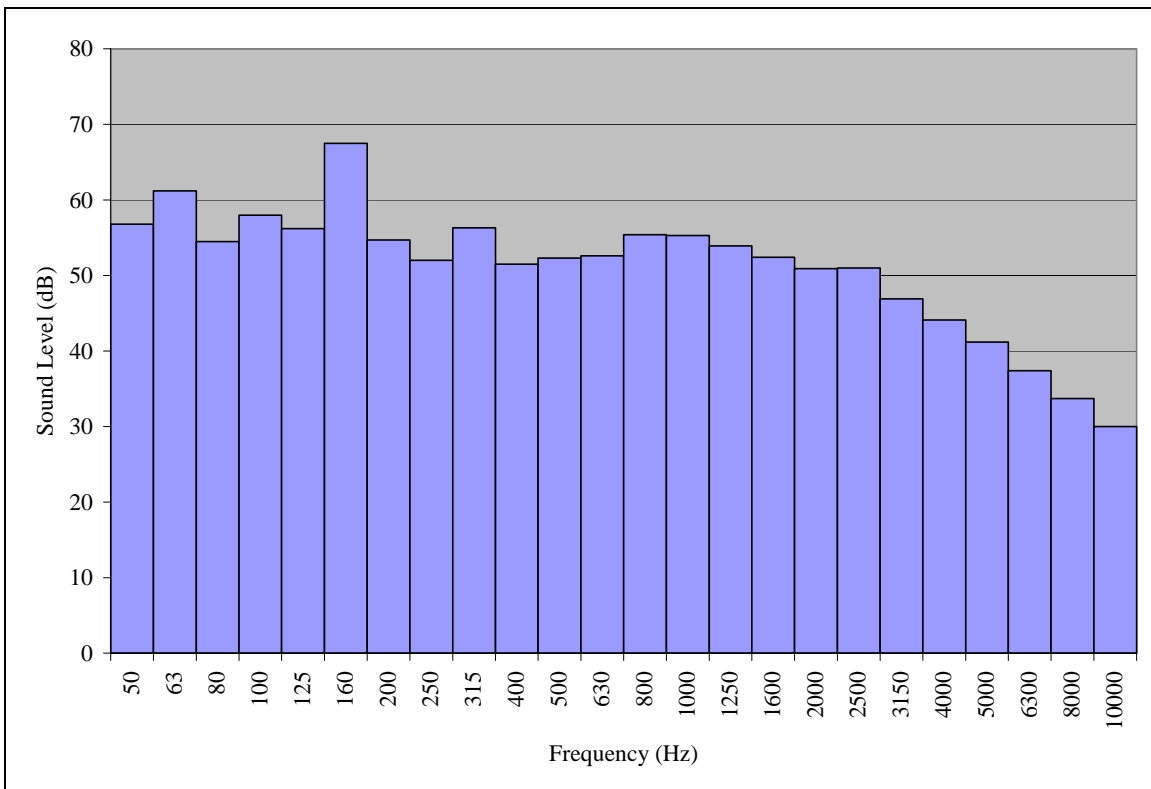


Figure 65. Alpen Guide, Right Side (Feb 26, 14:07) Spectra for High Speed

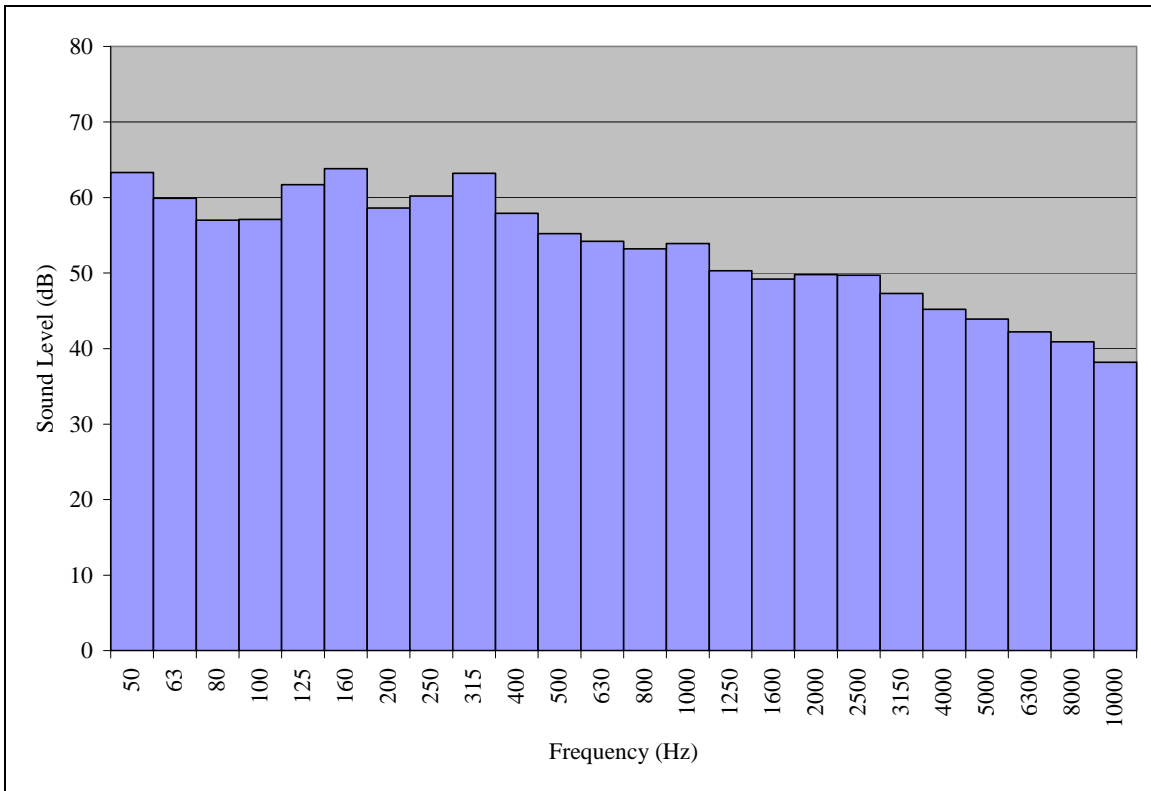


Figure 66. Goosewing Diesel Van, Left Side (Feb 26, 15:16) Spectra for High Speed

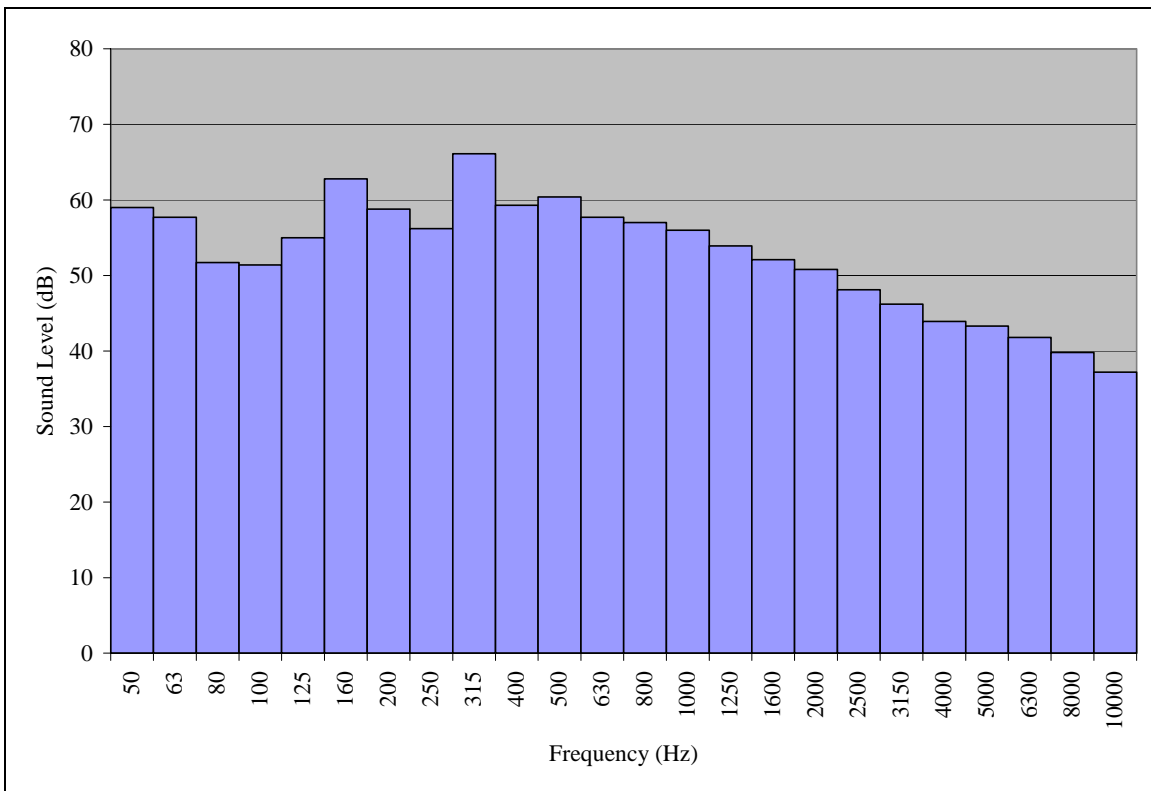


Figure 67. Yellowstone Snow Coach, Right Side (Feb 26, 14:40) Spectra for High Speed

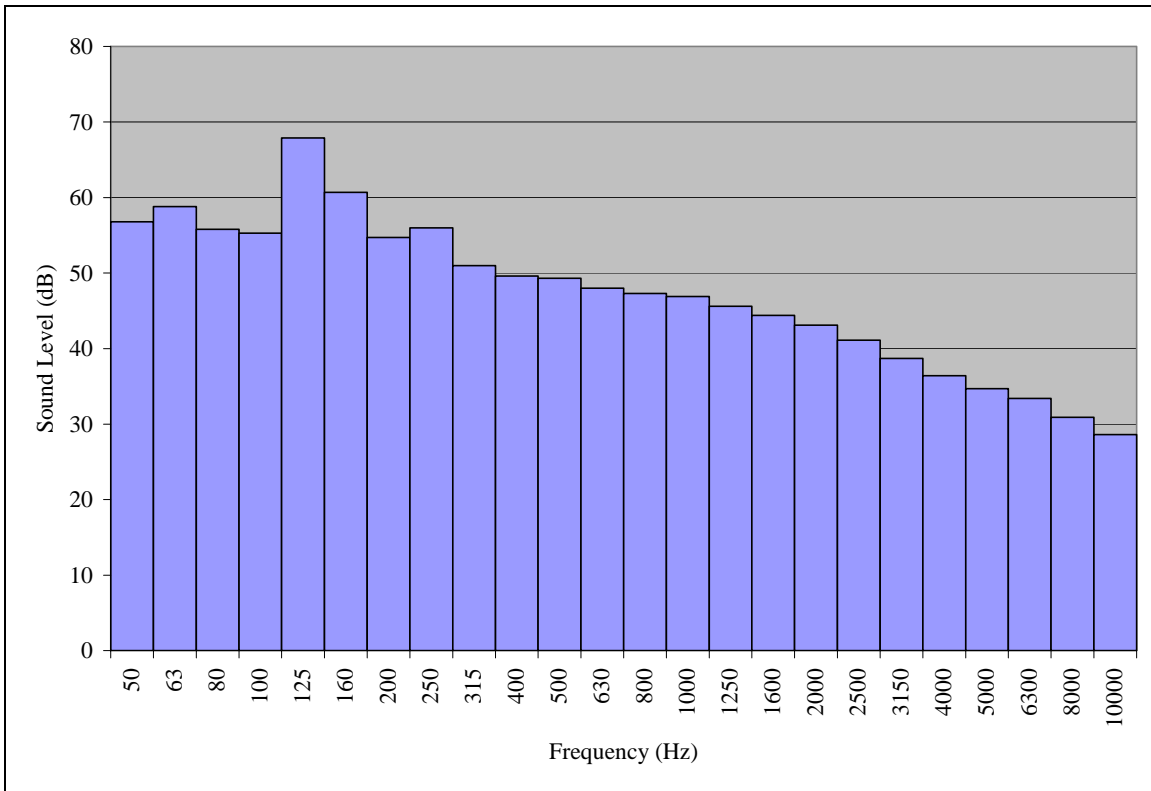


Figure 68. Yellowstone Expedition, Left Side (Feb 26, 14:18) Spectra for High Speed
