
1 ORDERED, that the National Marine Fisheries Service shall issue the Final

3 before September 1, 2004.

4 ORDERED, that the requirement that the National Marine Fisheries Service file status
5 reports every sixty days on the development of the Programmatic Supplemental Environmental
6 Impact Statement pursuant to the Court's August 6, 1999, Remand Order (Docket Sheet #272) is
7 terminated

8 ORDERED, that any remaining unadjudicated claims that are still pending in this case
9 are dismissed without prejudice.

10 ORDERED, that Judgment shall be entered in part for Plaintiffs, in part for Defendants,
11 and in part for Defendant-Intervenors, in accordance with the Court's Orders of July 13, 1999
12 (Docket Sheet #254), January 25, 2000 (Docket Sheet #373), and December 18, 2002 (Docket
13 Sheet #577), for the reasons discussed in the aforementioned Orders.
