<sup>a</sup>New England County Metropolitan Area (NECMA) = a county or counties in New England, comprised of cities and towns as population centers.

<sup>b</sup>No leisure-time physical activity = no reported leisure-time physical activities (i.e., any physical activities or exercises such as running, calisthenics, golf, gardening, or walking) in the past month.

<sup>c</sup>% = estimated proportion of the population.

<sup>d</sup>95% CI = confidence interval.
