# **Black-Owned Businesses: Strongest in Services**

## Black-owned firms grew 46 percent between 1987 and 1992.

The number of Black-owned businesses increased from 424,165 to 620,912—growing more than U.S. businesses as a whole. The number of all businesses increased by 26 percent, from 13.7 million to 17.3 million.

Receipts for Black-owned firms grew at about the same rate as for all businesses. Black-owned business receipts increased from \$19.8 billion to \$32.2 billion (63 percent). Receipts for all businesses increased from \$1,995 billion to \$3,324 billion (67 percent). Receipts reported by Black-owned businesses were about 1 percent of the total receipts for all firms in 1992, unchanged from 1987.

#### Average receipts for Black-owned businesses were less than for all U.S. firms.

Receipts for Black-owned firms averaged \$52,000 per firm, compared with \$193,000 for all U.S. firms. Fifty-six percent of Black-owned firms had receipts under \$10,000. Less than 1 percent had receipts of \$1 million or more. These firms sell

U.S. Department of Commerce Economics and Statistics Administration BUREAU OF THE CENSUS less partly because they are in the service industries where average receipts are generally less. In contrast, 45 percent of all U.S. firms had receipts under \$10,000 and 2 percent had receipts of a million or more.

#### Service industries dominate.

In 1992, 54 percent of Black-owned firms were in industries that provide services to individuals, businesses, and others. These firms accounted for 34 percent of all Black-owned business receipts.

Business services (such as advertising firms and employment agencies) and personal services (such as dry cleaners and beauty shops) accounted for 47 percent of the total number of Black-owned service industry firms and 35 percent of their receipts.


