Current Issues

ATS/Pnote Search by Date Range Issues [04/01/09 (Updated 04/07/09)]

Federal Student Aid has identified two issues when schools search for Direct Loan Master Promissory Notes (MPNs) via the <u>COD Web site</u> for a specified school and date range. *Note:* The date range search will also return all Agreements to Serve (ATS) associated with that school.

Issue 1: The search results do not return all MPNs associated with that school.

The search results should include MPNs for any school associated with the MPN. Federal Student Aid has determined that unlinked MPNs are returned with the search results. However, for cases when an MPN is linked to an award from another school, the MPN is not returned with the search results. For cases when the MPN is linked to awards from more than one school, the MPN is only returned in search results for the school associated with the first linked award.

Issue 2: The search results do not return more than 200 records and records are not the most current 200 records.

The search results should include all MPNs within the date range. Federal Student Aid has determined that a date range search for a long timeframe will not return more than 200 records



and those records are not the most current MPNs. Federal Student Aid recommends that a school perform a date range search using a short timeframe.

Weekly Reminders

Sending Addresses for U.S. Territories on the Common Record or the COD Web site (04/24/09)

When submitting student or borrower addresses to the Common Origination and Disbursement (COD) System, it is important that the correct tags are used, particularly when the student or borrower address is located in a U.S. Territory. These addresses are considered domestic addresses and should not be submitted as a foreign address with a Country Code. If these addresses are not submitted correctly, important correspondence from the COD System and the Direct Loan Servicing Center is delayed or not received.

When a student or borrower address is located in a U.S. Territory, the address should be treated as a domestic address and submitted to the COD System as follows:

2008-2009 ACG Deobligation Due to No Corresponding Pell Grant Warning Message (04/23/09)

On April 21, 2009, Federal Student Aid began processing a message to schools that have reported 2008-2009 Academic Competitiveness Grant (ACG) actual disbursements for a student who does not have a 2008-2009 Federal Pell Grant (Pell Grant) actual disbursement recorded in the COD System. The message is a warning that these disbursements will be considered overawards and reduced to a zero dollar amount (\$0.00), even if the disbursements were previously accepted in the COD System. The reduction of the affected disbursements is scheduled to occur on May 5, 2009.

Federal Student Aid sent the April 21, 2009 warning message to schools' Student Aid Internet Gateway (SAIG) mailboxes in the message class AGTX09OP. Additionally, Federal Student Aid sent a file of student records reported to the COD System that do not have a corresponding 2008-2009 Pell Grant actual disbursement in the Reconciliation Report message class AGRC09OP. Schools that receive the warning message should review the accompanying Reconciliation Report and, if applicable, report 2008-2009 Pell Grant disbursements for affected students before May 5, 2009.

Note Regarding Exception Process for No Corresponding 2008-2009 Pell Grant Due to R2T4 Calculation:

Some of the student records included in the Reconciliation Report may be for students who do not have a corresponding Pell Grant for the 2008-2009 Award Year due to the documented full repayment of the Pell Grant as a result of a Return of Title IV Funds (R2T4) calculation. A school can inform Federal Student Aid of the student records to which this exception applies by calling the COD School Relations Center by May 1, 2009. A customer service representative will collect the following information from the school via the phone:

- School's Name
- School's Pell ID and G5 Award Number
- Student's First and Last Names
- Student's Social Security Number (SSN)
- Student's Grade Level
- ACG Award ID



- ACG Award Amount
- ACG Award Year-to-Date Disbursement Amount

Upon notification that an R2T4 exception applies, Federal Student Aid will exclude the applicable student records from the reduction scheduled for May 5, 2009.

TEACH Grant Operational Implementation Guidance – COD System Implementation and Guidance Summary (04/24/09)

The College Cost Reduction and Access Act (the CCRAA), Pub. L. 110-84, authorized the Teacher Education Assistance for College and Higher Education (TEACH) Grant Program beginning with the 2008-2009 Award Year.





For TEACH Grant policy and operational guidance refer to the following postings on the <u>Information for Financial Aid Professionals (IFAP) Web site</u>:

- <u>Final Rule published on June 23, 2008 (73 FR 35472)</u> in the <u>Federal Register</u> provides the final regulations effective July 1, 2008 for the 2008-2009 Award Year.

TEACH Grant – Institutional Participation Request Process Information (04/24/09)
On June 3, 2008, the Department of Education posted <u>Dear Colleague Letter GEN-08-07 on the Information for Financial Aid Professionals (IFAP) Web site</u>. This Dear Colleague Letter clarifies how an institution will establish eligibility to participate in the TEACH Grant Program.

For complete information about the Institutional Participation Request Process, refer to <u>Dear</u> Colleague Letter GEN-08-07.

Participation Request Process Steps – As outlined in the 10-step participation request process included in <u>Dear Colleague Letter GEN-08-07</u>, a school must complete Question 1, enter specified language in Section K/Question 69, and complete Section L via the <u>E-App Web site</u>. After completing these steps, the school must mail its signed and dated signature page to the Department of Education (the Department) per the instructions provided on the "Submit





Application" page. To aid in expediting receipt of the school's signature page by the Department, the school may want to use an overnight delivery method.

Participation Request Process Follow Up – If a school does not receive a response regarding its request to participate in the TEACH Grant Program within two weeks of submitting the request, the school should contact the School Participation Team for the school's state. Contact information is available on the E-App Web site.

School Addition to ATS Web Site – Once a school is determined to be eligible to participate in the TEACH Grant Program, the school's name will be added to the TEACH Grant Agreement to Serve (ATS) Web site. As a general rule, Federal Student Aid will update the TEACH Grant ATS Web site on the Tuesday or Thursday most closely following notification of the school's eligibility. If a school has questions about the TEACH Grant ATS Web site, it should contact the COD School Relations Center.
